

The CAP Update included the following request to ANR:

Develop a framework for the reporting of greenhouse gas emissions data from fuel suppliers and other significant emitters of climate pollution. ANR will work expeditiously to put a reporting framework in place and recommend to the Legislature by December 15, 2025, statutory changes and funding needed to support streamlined reporting requirements and a stepped implementation plan.

Approach in H740

Amending §582 and adding a new Section (2) to provide clear authorization for a reporting program offers needed clarity

Secretary's Discretion

The Secretary shall adopt rules that create a comprehensive greenhouse gas emission reporting program that covers all sources of emissions, including fuel suppliers. Suppliers of transportation and heating fuels covered by the rules shall comply with requests from the Secretary for information. The information collected shall at a minimum include the types and volume of fuels sold, by sector for the transportation, residential, commercial, and industrial sectors, by county.

The Secretary shall **have authority to** adopt rules that create a comprehensive greenhouse gas emission reporting program that covers all sources of emissions, including fuel suppliers. Suppliers of transportation and heating fuels covered by the rules shall comply with requests from the Secretary for information. The information collected shall at a minimum include the types and volume of fuels sold, by sector for the transportation, residential, commercial, and industrial sectors, by county.

Draft Timeline

Current Draft: File with LCAR by March 1, 2027

Replace with a deadline to ICAR or an “adopt by” date as both are more within our control than LCAR timing.

- Propose adopting by **July 1, 2027**, leaving time to coordinate with reporting entities.

Rule adoption date of 2027 would mean that 2028 is the first reporting year, with 2028 reports due in early 2029.

Necessary Budget
