## Kate -

I work for the Town of Stowe Electric Department and heard your introduction to H. 88. As a municipal utility, we're directly responsible to the residents and visitors in our community. We take the cost of service and best interests of our community seriously. Many communities in Vermont have warming and cooling shelters available for their residents and community.

I had staff look at the number of days where the max temperature reached or exceeded 92 degrees, see attached. As you can see, in most years there are 6 or fewer days where the temperature and/or heat index reached or exceeded 92 degrees.

I can appreciate that even 1 day at or over 92 degrees can create a life safety issue for at risk Vermonters. However, I wonder if a new statute or PUC rule update requiring no utility disconnections during days that exceed 92 degrees creates the result that the proposed statute intends. I also wonder if there's another opportunity to reach the goals of the proposed statute without burdening municipal utilities with more administrative costs and oversight. For example, working with municipal and State agencies to expand cooling shelters, or increasing the pace of weatherization and installation of more efficient air conditioning could provide an improved quality of life for our most vulnerable Vermonters without burdening them and the municipalities that serve them with more statutory oversight.

As a municipal utility, we are concerned about the life safety of our customers. We are also aware that placing more restrictions on utility disconnections only seems to increase costs and reduce opportunities for utilities to communicate with their customers. For example, Stowe Electric rarely disconnects a utility consumer as a matter of policy. However, disconnection notices create an opportunity for the customer to speak with utility staff about payment plans, rebates for electrification and efficiency measures, cost saving measures such as smart thermostats, and how to access State and Federal financial assistance. By reducing the opportunity for these conversations, we reduce the chance to make a positive impact in our customer's lives.

Have you reached out to Lesley-Ann L. Dupigny-Giroux? She's Vermont's State Climatologist and a talented person when it comes to communicating climate and climate risk facing our state. She could add important climate information to this conversation.
