TO THE HOUSE OF REPRESENTATIVES:

2	The Committee on Environment to which was referred Senate Bill No. 124
3	entitled "An act relating to miscellaneous agricultural subjects" respectfully
4	reports that it has considered the same and recommends that the report of the
5	Committee on Agriculture, Food Resiliency, and Forestry be amended as
6	follows:
7	First: In Sec. 3, 6 V.S.A. § 4851, in subsection (a), in the second to last
8	sentence, after "federal regulations for concentrated animal feeding operations
9	and before the period, by inserting "or by the VPDES CAFO Rules"
10	Second: In Sec. 4, 6 V.S.A. § 4858, in subdivision (c)(1), in the second to
11	last sentence, after "federal regulations for concentrated animal feeding
12	operations" and before the period, by inserting "or by the VPDES CAFO
13	Rules"
14	and in subsection (d), in the third to last sentence, after "if required by
15	federal regulations for concentrated animal feeding operations" and before the
16	period, by inserting "or by the VPDES CAFO Rules"
17	Third: In Sec. 8, 10 V.S.A. chapter 47, subchapter 3A, in section 1351, by
18	striking out the lead in to subdivision (8) in its entirety and inserting in lieu
19	thereof a new lead in to subdivision (8) to read as follows:

1	(8) "Medium concentrated animal feeding operation" or "medium
2	CAFO" means an AFO that is defined as an AFO by the VPDES CAFO Rules
3	adopted by the Secretary, including an AFO that:
4	and in section 1352, by striking out subdivisions (1)–(4) in their entireties
5	and inserting in lieu thereof new subdivisions (1)–(4) to read as follows:
6	(1) Implement the federal Clean Water Act to administer a Vermont
7	pollutant discharge elimination system (VPDES) CAFO program that is at
8	least as stringent as the federal Clean Water Act and enabling rules.
9	(2) Make, adopt, revise, and amend rules as necessary to administer a
10	VPDES CAFO program that is at least as stringent as the federal Clean Water
11	Act and enabling rules.
12	(3) Make, adopt, revise, and amend procedures, guidelines, inspection
13	checklists, and other documents as necessary for the administration of the
14	VPDES CAFO program.
15	(4) Designate any AFO that meets the definition of a CAFO under the
16	federal Clean Water Act regulations or under the VPDES CAFO Rule, in the
17	Secretary's sole discretion.
18	Fourth: In Sec. 9, community stakeholder group on agricultural water
19	quality, by adding a subsection (c) to read as follows:
20	(c) The Secretary of Natural Resources shall, as part of the report required
21	under this section, propose a plan for inspection of animal feeding operations

1	(AFOs) potentially subject to the requirements for a CAFO permit under 10
2	V.S.A. chapter 47, subchapter 3A. The plan shall include:
3	(1) a proposal of which AFOs should be subject to inspection, including
4	whether all large farm operations and medium farm operations must be
5	inspected to determine if a CAFO permit is required;
6	(2) a proposed schedule of inspection of those AFOs subject to
7	inspection, including the frequency of inspection or events or thresholds that
8	would require inspection; and
9	(3) an estimate of the staffing or other resources that would be required
10	to implement the proposed inspection plan.
11	Fifth: In Sec. 10, 10 V.S.A. § 1259, in subsection (i), in the first sentence,
12	after "shall delegate to and" and before "the Secretary of Agriculture, Food and
13	Markets", by inserting "the VPDES CAFO Rules, and"
14	Sixth: In Sec. 11, 10 V.S.A. § 1263, in subsection (g), in the first sentence,
15	after "National Pollutant Discharge Elimination System permit regulations"
16	and before "shall submit an application", by inserting "or the VPDES CAFO
17	Rules"
18	Seventh: In Sec. 12, 10 V.S.A. § 1264(d), in subdivision (1)(A), by striking
19	out the first sentence in its entirety and inserting in lieu thereof a new first
20	sentence to read as follows:

1	Stormwater runoff from farms in compliance with agricultural practices
2	adopted by the Secretary of Agriculture, Food and Markets, provided that this
3	and not subject to the federal Clean Water Act, its enabling regulations, or the
4	VPDES CAFO Rules as determined by the Secretary of Natural Resources.
5	Eighth: By striking out Sec. 13, effective date, and its reader assistance
6	heading in their entireties and inserting in lieu thereof two new sections to be
7	Secs. 13 and 14 and their and their related reader assistance headings to read:
8	* * * Reference to Federal Clean Water Act * * *
9	Sec. 13. REFERENCE TO FEDERAL CLEAN WATER ACT
10	(a) Notwithstanding statements to the contrary in 6 V.S.A. chapter 215 or
11	10 V.S.A. chapter 47, when the following are referenced in 6 V.S.A. chapter
12	215 or in 10 V.S.A. chapter 47, the text of each shall be applied and interpreted
13	as each public law, statute, or regulation existed on January 1, 2025, regardless
14	of any subsequent amendment, repeal, or other substantive change:
15	(1) Pub. L. No. 92-500;
16	(2) the federal Clean Water Act;
17	(3) federal laws or regulations related to the federal Clean Water Act;
18	(4) the enabling regulations of the federal Clean Water Act, including
19	citations to the Code of Federal Regulations for regulations adopted under the
20	federal Clean Water Act;

1	(5) the federal regulations for concentrated animal feeding operations
2	(CAFO) or the federal CAFO regulations; and
3	(6) the federal national pollutant discharge elimination system (NPDES)
4	regulations or federal NPDES regulations.
5	(b) Subsection (a) of this section shall be repealed on April 1, 2029.
