Climate action work is happening across state government.

- The Climate Action Office leads, coordinates, and tracks climate action across government.
- This supports the goals and requirements of the Global Warming Solutions Act.
- Supported by an Inter-Agency Advisory Board



Objectives of the Inter-Agency Advisory Board to the CAO

- 1. To provide a space for proactive coordination on climate action across state government.
- 2. Articulating where policy and financial implications overlap around climate action to ensure resources are maximized.
- 3. To support the monitoring of progress over time in meeting the state's climate goals.
- 4. Identification and framing up of gaps where the climate action office might prioritize support.
- 5. Development of state positions on issues related to climate change.

Provide expertise and capacity on state-led climate initiatives.


Track and assess climate actions and communicate those findings.


Annual State Climate Spending Document

- Spending on climate action has steadily increased in recent years but there are challenges ahead that will change that picture.
- Climate spending totals \$524,508,384 for FY 2025 this is in large part due to federal investments, which are set to end as soon as this year.
- In addition to funding from the American Recovery Act coming to a close, federal funds from laws like the Inflation Reduction Act and the Bipartisan Infrastructure Bill are vulnerable to rollback from the federal government.
- Sustained federal funding for critical programs like the Climate and Health Program in the Department of Health are also at risk.
- While state funding has also advanced initiatives—from flood preparedness and recovery to new energy navigator positions that support low-income Vermonters accessing grant funds new funding sources will be necessary if we want to continue to advance at the pace and scale needed to meet our climate goals.



Allocation of climate spending falls into three main categories:




State vs. Federal Investments






Resilience and Adaptation: Resilience Implementation Strategy
