### ANR's FY24 Budget

- ANR's FY24 Budget: \$230.1 million
  - Roughly 40% (\$92.7 million) is federal funds
- Budget supported 650 full-time employees and ~400 seasonal workers
- Almost 3/4s of ANR's FY24 budget was passed thru to municipalities, contractors, and partner organizations

## Federal (FY24) Funding Sources and Types

- 51 federal funding sources; expenditures totaling \$61.2M
  - Reminder: SEFA captures how much has been <u>spent</u> as opposed to <u>awarded</u>
- 10 of these federal funds account for almost 90% of all expenditures
- Two of these federal funds account for 50% (\$30.4M) of all expenditures
  - Drinking Water State Revolving Fund
  - Clean Water State Revolving Fund

# Federal (FY24) Funding Sources and Types

ANR receives grants from 7 different federal departments/agencies

<ul> <li>U.S. Environmental Protection Agency</li> </ul>	\$44M
<ul> <li>Department of the Interior</li> </ul>	\$11M
<ul> <li>Department of Agriculture</li> </ul>	\$3.7M
<ul> <li>Department of Transportation</li> </ul>	\$1.2M
<ul> <li>Department of Homeland Security</li> </ul>	\$500k
<ul> <li>Department of Defense</li> </ul>	< \$20k
<ul> <li>Northern Borders Regional Commission</li> </ul>	< \$20k

#### Uses of Federal Grants within ANR

- Positions
  - 275 of ANR's 650 full-time staff are partially or fully-funded with federal monies
    - Equates to roughly 180 FTEs
- Pass-thru loans, grants and contracts examples include:
  - State Revolving Fund loans to more than 70 municipalities (EPA)
  - Recreational Trails Program grants to 13 municipalities and non-profits (DOT)
  - State Wildlife Grants to 7 conservation districts and non-profits (DOI, USFWS)

#### Risk Assessment

- No good way to predict what federal programs may be reduced or eliminated
  - How changes "cascade" to subrecipients even more challenging to anticipate
- Other factors impacting uncertainty:
  - Legal challenges
  - Multi-year apportionments
    - PR-Wildlife Restoration Grants (DOI)
  - Multi-year, overlapping awards
    - Lake Champlain Basin Program (EPA)
    - Cooperative Forestry Assistance (USDA)
