




Organizational Structure

By Department (in millions)




By Cost Category:

- 50% for contracts, grants and loans to municipalities, partner organizations and businesses
- 34% for salaries and benefits that supports a 682 full-time employee count and ~400 temporary staff
- 16% for all other operating: internal service funds, leases, PILOT, vehicles, etc.

Deploying Dollars in Vermont:

- \$40M in contracts, including \$22M to Vermont businesses
- \$59M in grants, including \$51M to Vermont entities
- \$65M in loans

FY27 Key Budget Information

Governor's SFY27 Recommend: \$299.6 million

- Overall decrease of \$42.1 million (~12%) compared to FY26
 - Largely driven by the winding down of BIL/IIJA fund.
- Other significant budget changes (gross amounts).
 - Increase in salaries, wages, and benefits of \$6.5M.
 - Increase in Internal Service funds for human resources, facilities operation fund, VISION, and worker's compensation of \$350k.
 - Decrease in Internal Service Funds for insurance of \$548k.
 - Increase resulting from new ADS billing model of \$1.45M.
 - Decrease in Federal Forest Legacy projects of \$3.8M.
 - Decrease in the petroleum clean-up fund to maintain solvency including a reduction in underground storage tank loans.
 - Smaller decreases for air quality division: mercury monitoring and Camnet grant.






Secretary's Office

The Secretary's Office is responsible for the overall leadership and vision of the Agency including coordination among departments and legislation.



Civil Rights & Environmental Justice

Supports and advances compliance with State and Federal laws such as Vermont's environmental justice law.



Office of Policy and Planning

Works with staff from all three departments to represent ANR in proceedings before Act 250 District Commissions, LURB and the PUC; develops cross cutting Agency policy.



Climate Action Office

Provides expertise and capacity for state-led climate initiatives and leads efforts to achieving the requirements of the Global Warming Solutions Act and broader climate action.



Office of General Counsel (Legal Services)

Provides a range of legal services to all departments includes drafting and reviewing policies and permits, rulemaking and general legal advice.



Financial and Administrative Services

Provides financial and administrative management services for the Agency and its departments, as well support to the Land Use Review Board.



Regional Offices

Supports administrative and financial needs of the Agency's five regional offices.



Federal Funds Update

Climate Pollution Reduction Grant (CPRG) Program

- Part of the Inflation Reduction Act
- Vermont received \$3M non-competitive planning grant award
 - Grant period is July 1, 2023 to June 30, 2027
 - Department of Environmental Conservation is recipient, and the Climate Action Office administers the award.
- Grant activities include the development, updating, and evaluation of plans to reduce climate pollution.
 - Work builds on framework of the Vermont's Greenhouse Gas Inventory, the Global Warming Solutions Act, and the Vermont Climate Action Plan.
- To date, \$1.4M expended and another \$1.1M encumbered = \$2.5M



- Purchased new gas standards required to conduct T015 air testing at Vael.



Sec. B.700 - Civil Rights & Environmental Justice

As a recipient of federal funds, the Agency and its departments must comply with civil rights and nondiscrimination statutes, such as Title VI of the Civil Rights Act of 1964, and the implementing regulations associated with the federal agency providing the financial assistance. In addition, Act 154 (S.148) established an environmental justice (EJ) policy for the State of Vermont which creates new EJ-related responsibilities for State agencies, requires development and maintenance of an EJ mapping tool and forms two new bodies to support policy implementation. The Civil Rights and Environmental Justice unit supports and advances compliance with these State and Federal laws.



Sec. B.700 - Civil Rights & Environmental Justice

Civil Rights and Environmental Justice Unit (CREJU) responsibilities under the Vermont Environmental Justice Law (Act 154 of 2022):

- Provide quality and timely technical assistance to the Advisory Council (AC), the Interagency Committee, and the covered agencies.
- Support ANR and sister agencies in adhering to actions required of covered agencies under Act 154.
- Ensure timely, coordinated implementation across all covered agencies and the two advisory bodies.

2025 Highlights and Accomplishments:


- **Environmental Benefits:** Completed the Environmental Benefits Spending Guidance on September 15, 2025.
- **Community Engagement:** Coordinated the development of a Community Engagement Subgroup made up of members of the AC and covered agency staff.
- **Environmental Justice Mapping Tool:** Hired contractors for the Environmental Justice Mapping Tool.
- **Technical assistance:** Provided over 130 hours of tailored technical assistance to VT EJ Law partners.
- **Cumulative Environmental Burden Rulemaking:** Developed a workplan and legal framework to begin rule development; rulemaking will take place in 2027.
- **Annual Reporting:** Developed a workplan to improve complaint intake processes across covered agency in accordance with AC 2024 recommendations.

Sec. B.700 – Office of Policy and Planning

The Office of Policy and Planning works with staff from all three departments to represent ANR in proceedings before Act 250 District Commissions, LURB and the PUC, and leads development of cross cutting Agency policy. Providing a unified position across ANR's many departments and divisions is critical for project developers and interested citizens to navigate the regulatory process and necessary to inform decision-making bodies such as Act 250 commissions and PUC. Members of this Office also provide case management for large, complex projects that intersect concerns in multiple Agency-administered programs.



Sec. B.700 – Office of Policy and Planning


- ANR is a statutory party in Act 250 and Public Utility Commission proceedings, required to provide evidence and recommendations on project's compliance with Act 250 and Sec. 248's environmental criteria.
 - The Office distributes materials for **newly filed applications to over 100 technical staff in ANR's three departments each week**, coordinating staff review, compiling staff comments, reconciling internal disagreements, drafting proposed permit conditions, and representing the agency at hearings.
- The Office also plays a significant external role providing guidance and technical assistance to potential applicants on how to configure projects to meet applicable criteria and in developing new policy.
- With the creation of the LURB and passage of Act 181, the Office is leading ANR's review of updated regional Future Land Use maps and LURB rulemaking for Tier 3, Criteria 8C, and Tier 1A guidance.
- In FY25 ANR **reviewed 260 Act 250 applications and 35 PUC applications**.

Sec. B.700 – Climate Action Office

The Climate Action Office (CAO) provides inter-governmental coordination, expertise and capacity for state-led climate initiatives, as well as monitoring, assessing and tracking implementation of climate adaptation, mitigation, and resilience activities to evaluate progress over time. The CAO is focused on three core areas: climate program coordination, on-going support for the Vermont Climate Council including periodic updates to Vermont's Climate Action Plan, and community and stakeholder engagement. To carry out this work, the CAO works closely with staff across ANR, other state Agencies, the state climatologist, and key stakeholders.



Sec. B.700 – Climate Action Office

- 2021 initial Climate Action Plan (CAP) recommended establishing a Climate Action Office; CAO was proposed by Governor Scott as part of his FY23 Budget Recommend.
- Since its creation, key CAO accomplishments include:
 - Supporting the Climate Council's development of the updated 2025 CAP.
 - In partnership with the Treasurer's Office, developing Vermont's first Climate Resilience Implementation Strategy (RIS), conducting an evaluation of cap-and-invest program feasibility for Vermont, and supporting implementation the Climate Superfund Act.
 - Establishing an Inter-Agency Advisory Committee on climate policy, provided capacity and support for climate action at PSD, VTrans, Labor, AAFM and other state agencies
 - Managing multiple technical analyses on climate issues.
 - Developing a climate change vulnerability index and climate tool-kit for municipalities.
 - Managing multiple rulemakings that result in reduced GHG emissions and improved the accuracy of the state's climate data.
 - Securing significant grant funding from EPA and the NGO sector.
- CAO tracks progress towards the GWSA emissions reduction requirements and supports modelling and other contract capacity to assess progress and inform cost effective future emission reduction measures.

- Starting in FY27 the CAO will administer the annual Drive Electric Grant, which was transferred from the Department of Environmental of Conservation.



Sec. B.700 – The Office of General Counsel (OGC)

The OGC provides legal services to the ANRSO; Department of Environmental Conservation (DEC), Department of Forests, Parks and Recreation (FPR); and Department of Fish and Wildlife (DFW). Legal services include drafting and reviewing policies, permits, contracts and other legal documents, rulemaking, legal advice, initiating civil environmental enforcement, and representing the Agency in litigation before the Environmental Court and other administrative bodies such as the Public Utilities Commission (PUC) and Act 250 proceedings. The range of legal subject matter includes; administrative law, contracts, grants, law enforcement (fish and wildlife violations), civil rights, environmental justice, civil environmental enforcement, personnel, public records and meetings, land acquisition and management, and regulatory programs.



Sec.B.700 Office of General Counsel

- Key accomplishments by Department:
 - **DEC:** evaluating changes to federal guidelines allowing programs to successfully retain funding; implemented EPA final PFAS via changes to Public Water Supply rule and Groundwater Protection Rule and Strategy; updated Low Emission and Zero Emission Vehicle Rules; updated Aboveground Storage Tank Rules; technical corrections to Wastewater Systems & Potable Water Supply Rules; provided sites and permitting advice on complex projects such as, Pownal, Ely Mines, NEWSVT, discharge permits for Shoreham and Hinesburg Wastewater Treatment Facilities; Environmental Justice, Civil Rights and ADA compliance initiatives.
 - **DFW:** drafted conservation easements; assisted with successful Act 250 and threatened and endangered permit negotiations; provided legal support to Fish & Wildlife Board Work; amended nine DFW and Board rules; comprehensive review and collaboration with AAFM on regulations that protect rare plants; progress in establishing BMPs for utility corridors.
 - **FPR:** assisted in the acquisition of 6 properties and 19 perspective properties (closings FY2026 or 2027), provided legal review and drafting of two rules (to be initiated in FY2026), drafted four legislative proposals (heavy cut, legal trails, fire prevention and fire warden, and UVA amendments), development of two trespass cases referred to AGO, assisted with resolution or referral of six encroachment cases; drafted ski lease assignment and assisted in due diligence review of Burke Mtn buyer.

Sec. B.700 – Office of General Counsel

- Litigation currently **has 95 active cases (70 enforcement, 7 permit appeals, and 18 PUC)**.
 - FY25:
 - Enforcement - 23 cases assigned, 2 transferred to Attorney General (AGO), 20 cases closed. \$154,204.79 penalties to General fund.
 - Permit appeals - 7 assigned, 12 closed with generally favorable court decisions.
 - PUC - 38 new cases, 25 closed Certificates of Public Good.
 - Key successes:
 - NEWSVT Declaratory Ruling dismissed by the Environmental Court.
 - Winooski 8 Hydroelectric Appeal – appeal withdrawn.
- OGC also supports referrals and AGO initiatives relating to environmental matters, such as: Global Warming Solutions Act, Climate Superfund, PFAS, PCBs, federal executive orders, trespass and enforcement, and challenges to federal and state rules (California Vehicle Emission Standards, Furbearing Rule and Standing Trees litigation).


