OPERATIONAL SUPPORT

- FUNDING FOR STRENGTHENING OUR ABILITY TO DELIVER OUR MISSION OF SAFE, AFFORDABLE, RESPECTFUL HOUSING FOR THE MOST VULNERABLE IN OUR COMMUNITIES:
- **\$619,744**
- **IMPACT:** Strengthening housing organizations to deliver on mission

REAL ESTATE DEVELOPMENT SUPPORT:

- FUNDING TO NOT ONLY CREATE NEW HOUSING FOR THOSE MOST IN NEED BUT THE ABILITY TO LEVERAGE OTHER SOURCES NOT RELIANT ON VERMONTERS:
- **\$19,387,960 INVESTMENT**
- **\$34,294,150 IN LEVERAGED \$\$**
