8 Statement of purpose of bill as introduced: This bill proposes to approve

9 amendments to the charter of the Town of Barre to repeal the Town's Office of

11 An act relating to approval of amendments to the charter of the Town of

13 It is hereby enacted by the General Assembly of the State of Vermont:

14 Sec. 1. CHARTER AMENDMENT APPROVAL

15 The General Assembly approves the amendment of the charter of the Town  
16 of Barre as set forth in this act. Voters approved the proposals of amendment  
17 on May 14, 2024.

18 Sec. 2. 24 App. V.S.A. chapter 101 is amended to read:

19 CHAPTER 101. TOWN OF BARRE

1 § 10. ELECTED OFFICERS; GENERAL

2 (a) The following officers shall be elected by the legal voters of the Town  
3 of Barre and voting for the officers shall be by Australian ballot:

9 ~~(f) The Office of Auditor may be abolished and replaced by an annual~~  
10 ~~financial audit of all funds of the Town by a public accountant, licensed in~~  
11 ~~Vermont, provided the voters authorize the actions at any annual or special~~  
12 ~~Town meeting. The vote to eliminate the Office of Auditor shall remain in~~  
13 ~~effect until rescinded by majority vote of the legal voters present and voting at~~  
14 ~~an annual or special meeting duly warned for that purpose. Unless otherwise~~  
15 ~~provided by law, the Selectboard shall provide for all other auditor duties to be~~  
16 ~~performed. The term of office of any auditor in the office on the date the Town~~  
17 ~~votes to eliminate that office shall expire on the 45th day after the vote or on~~  
18 ~~the date that the Selectboard enters into a contract with a public accountant~~  
19 ~~under this section, whichever occurs first.~~ [Repealed.]
