

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Government Operations and Military Affairs to which
3 was referred House Bill No. 508 entitled “An act relating to approval of
4 amendments to the charter of the City of Burlington” respectfully reports that it
5 has considered the same and recommends that the bill be amended by striking
6 out all after the enacting clause and inserting in lieu thereof the following:

7 Sec. 1. CHARTER AMENDMENT APPROVAL

8 The General Assembly approves the amendments to the charter of the City
9 of Burlington as set forth in this act. Voters approved the proposals of
10 amendment on March 4, 2025.

11 Sec. 2. 24 App. V.S.A. chapter 3 is amended to read:

12 CHAPTER 3. CITY OF BURLINGTON

14 § 2. ELECTION BOUNDARIES

15 ~~(a) City districts described. For the annual meeting of 2024 and all City~~
16 ~~elections thereafter, the City of Burlington is divided into four electoral~~
17 ~~districts, constituted as follows:~~

18 ~~(1) East District. The East District shall include all that part of said City~~
19 ~~lying easterly and northerly of the following described boundaries: Beginning~~
20 ~~at the common boundary between the Cities of Burlington and Winooski in the~~
21 ~~Winooski River beneath the Central Vermont Railway bridge downstream of~~

1 ~~the Lower Winooski Falls and Salmon Hole; thence westerly in the centerline~~
2 ~~of said railroad tracks for 406.6 feet to a point where the centerline of Intervale~~
3 ~~Road extended northerly intersects said railroad track centerline~~
4 ~~(approximately 73.2028 longitude, 44.4911 latitude); thence southerly along~~
5 ~~the extension of the centerline of Intervale Road, crossing Riverside Avenue~~
6 ~~until the centerline intersects with that of the Archibald Street centerline~~

17 ~~thence southerly along the eastern property boundary of 315 Maple Street for~~

19 ~~feet westerly to a point where the southern property boundary of 315 Maple~~

7 ~~(2) Central District. The Central District shall include all that part of the~~
8 ~~City bounded as follows: On the east, beginning at the common boundary~~
9 ~~between the City of Burlington and Town of Colchester in the Winooski River~~
10 ~~at a point intersecting with the centerline of Institute Road extended~~
11 ~~northeasterly (approximately 73.2147 longitude, 44.5089 latitude); thence~~
12 ~~southerly along the common boundary between the City of Burlington and~~
13 ~~Town of Colchester in the Winooski River to a point beneath the Central~~
14 ~~Vermont Railway bridge downstream of the Lower Winooski Falls and~~
15 ~~Salmon Hole; thence westerly along the East District northern boundary for~~
16 ~~406.6 feet to its intersection with the westerly boundary of the East District;~~
17 ~~thence southerly along the westerly boundary of the East District to its~~
18 ~~intersection with the centerline of Archibald Street, then southerly along the~~
19 ~~East District western boundary to the intersection with the centerline of Pearl~~
20 ~~Street; thence westerly along the northern boundary of the East District to the~~
21 ~~intersection with the centerline of South Winooski Avenue; thence southerly~~

1 along the western boundary of the East District to the centerline of Maple
2 Street; thence westerly along the centerline of Maple Street until its
3 intersection with the centerline of South Champlain street; thence northerly
4 along the South Champlain Street centerline until its intersection with the
5 centerline of King Street; on the south along the centerline of King Street
6 extended westerly to Lake Champlain; on the west by Lake Champlain; on the
7 north, beginning at the intersection of the common property boundary between
8 87 North Avenue and 9 Lakeview Terrace extended westerly to Lake
9 Champlain (approximately 73.2252 longitude, 44.4832 latitude); thence
10 northeasterly along the extended property boundary between 87 North Avenue
11 and 9 Lakeview Terrace to its intersection with the centerline of the Central
12 Vermont Railway railroad track (approximately 73.2239 longitude, 44.4837
13 latitude); thence northerly and easterly along the centerline of the Central
14 Vermont Railway railroad track, crossing North Avenue and the Burlington
15 Beltline, to its intersection with the centerline of Spring Street extended
16 northwesterly (approximately 73.2183 longitude, 44.4912 latitude); thence
17 northwesterly along the extension of the centerline of Spring Street to its
18 intersection with the centerline of Institute Road extended northeasterly
19 (approximately 73.2281 longitude, 44.4995 latitude); thence northeasterly
20 along the extension of the centerline of Institute Road extended to its
21 intersection with the common boundary between the City of Burlington and

3 ~~(3) South District. The South District shall include all that part of the~~
4 ~~City south of the southern boundaries of the East and Central Districts.~~

5 ~~(4) North District. The North District shall include all that part of the~~
6 ~~City north of the northern boundary of the Central District.~~

7 ~~(b) Wards described. Each of the City of Burlington's four electoral~~
8 ~~districts set forth in subsection (a) of this section hereby comprises two wards,~~
9 ~~each of which is constituted as follows:~~

10 ~~(1) East District—Ward 1 and Ward 8.~~

11 ~~(A) The East District is divided into two wards by the following~~
12 ~~boundary: Beginning at the center of the intersection of Brooks Avenue and~~
13 ~~South Willard Street; thence easterly along the Brooks Avenue centerline until~~
14 ~~intersecting with the centerline of North Prospect Street; thence southerly~~
15 ~~along the centerline of North prospect Street to the intersection of the~~
16 ~~centerline of Colchester Avenue to the intersection of the centerline of Mary~~
17 ~~Fletcher Drive; thence southerly along the centerline of Mary Fletcher Drive~~
18 ~~for 331.58 feet (approximately 73.196 longitude, 44.4802 latitude); thence~~
19 ~~southerly along the western side and easterly along the southern side of the~~
20 ~~UVM Medical Center building for 1854.5 feet until a point at the center of the~~

18 ~~subdivision (A) of this subdivision (1), and Ward 8 lies to the south and west.~~

19 ~~(2) Central District—Ward 2 and Ward 3.~~

20 ~~(A) The Central District is divided into two wards by the following~~
21 ~~boundary: Beginning at the intersection of the common property boundary~~

1 ~~between 85 North Avenue and 9 Lakeview Terrace extended westerly to Lake~~
2 ~~Champlain (approximately 73.2252 longitude, 44.4832 latitude); thence~~
3 ~~northeasterly along the extended property boundary between 87 North Avenue~~
4 ~~and 9 Lakeview Terrace to its intersection with the centerline of the Central~~
5 ~~Vermont Railway railroad track (approximately 73.224 longitude, 44.4837~~
6 ~~latitude); thence southeasterly along the centerline of the Central Vermont~~
7 ~~Railway railroad track to a point intersecting with the northwestern property~~
8 ~~boundary of 300 Lake Street extended southwesterly (approximately 73.2234~~

1 ~~(B) Ward 2 lies to the north of the boundary described in subdivision~~
2 ~~(A) of this subdivision (2), and Ward 3 lies to the south.~~

3 ~~(3) South District—Ward 5 and Ward 6.~~

4 ~~(A) The South District is divided into two wards by the following~~
5 ~~boundary: Beginning at the intersection of the centerlines of Maple Street and~~
6 ~~Church Street; thence southerly along the centerline of Church Street to the~~
7 ~~intersection with the centerline of Adams Street; thence westerly along the~~
8 ~~centerline of Adams Street to the intersection with the centerline of Saint Paul~~
9 ~~Street; thence southerly along the Saint Paul Street centerline to its intersection~~
10 ~~with the centerline of Shelburne Street; thence southerly along the centerline of~~
11 ~~Shelburne Street to its intersection with the centerline of Flynn Avenue; thence~~
12 ~~easterly along the centerline of Flynn Avenue extended easterly to the common~~
13 ~~boundary between the Cities of Burlington and South Burlington.~~

14 ~~(B) Ward 5 lies to the west of the boundary described in subdivision~~
15 ~~(A) of this subdivision (3), and Ward 6 lies to the east.~~

16 ~~(4) North District—Ward 4 and Ward 7.~~

17 ~~(A) The North District is divided into two wards by the following~~
18 ~~boundary: Beginning at the centerline of Institute Road extended southwesterly~~
19 ~~to Lake Champlain; thence northeasterly to the intersection of Institute Road~~
20 ~~with the centerline of North Avenue; thence northerly along the centerline of~~
21 ~~North Avenue to its intersection with the centerline of Fairfield Drive; thence~~

1 ~~westerly along the centerline of Fairfield Drive to its intersection with the~~
2 ~~western property boundary of 39 Westward Drive extended southerly~~
3 ~~(approximately 73.2685 longitude, 44.5257 latitude); thence northerly along~~
4 ~~the western property boundary of 39 Westward Drive, until intersecting with~~
5 ~~the centerline of Westward Drive; thence southwesterly along the centerline of~~
6 ~~Westward Drive to the intersection with the Northshore Drive centerline;~~
7 ~~thence northerly along the Northshore Drive centerline until intersecting with~~
8 ~~the Clair Pointe Road centerline (point); thence westerly along the southern~~
9 ~~property boundary of the Claire Pointe condominium development~~
10 ~~(approximately 73.2686 longitude, 44.5286 latitude), and then extended to~~
11 ~~Lake Champlain.~~

12 ~~(B) Ward 4 lies to the west of the boundary described in subdivision~~
13 ~~(A) of this subdivision (4), and Ward 7 lies to the east.~~

14 ~~(5) Ward map reference. Reference is also made to a map entitled “Ward~~
15 ~~Redistricting, 8 Wards — 4 Districts, 12 Councilors, Approved Map~~
16 ~~(December 2 V1.3), Map Date: December 8, 2022 “ located in the Burlington~~
17 ~~Chief Administrative Officer’s office in further aid of the description of the~~
18 ~~wards set forth in this subsection.~~

19 The election area boundaries established pursuant to 2023 Acts and
20 Resolves No. M-7 shall remain in effect until changed by the City Council,
21 which is authorized to make changes from time to time to the boundaries of the

1 election areas in order to provide an equal division of population among them
2 in accordance with data produced by the U.S. Census Bureau. Election area
3 changes shall not be made more frequently than once in five years. Changes
4 shall be approved by the voters at an annual or special meeting of the City and
5 shall become effective immediately upon approval unless a later date is
6 established by the City meeting vote.
