Legally purchase cannabis: <u>EVERYWHERE</u>

Legally consume cannabis: NOWHERE

Instead of a vacuum of uncertainty and illegality, Vermont must define the <u>legal</u> consumption of cannabis and the required conditions.

Proposed Consumption Requirements:

- Defined Time
- Legal sale of a regulated product.
- Security for employee and customer.
- Confirmation of 21+ age.
- Trained and certified server.
- Transportation or Lodging?

The Solution: Temporary cannabis catering permit, similar to alcohol

A "beer garden for weed" is a logical and safe example to consider.

The time, location, and license-holders are all listed on the permit and must be approved by the local municipality, **providing a local control.**

The hosting municipality would also be entitled to receive a portion of the fee for the permit.

Licensed Vermont cannabis products are the only cannabis products allowed to be sold or consumed at the event and must be sold by a licensed retailer.

Al<u>c</u>ohol Event Permit Example

Vermont presently issues various kinds of temporary consumption permits, including the festival, special event, and educational sampling permits.

These permits are inexpensive and require a simple application, which must be approved by a local licensing authority (town clerk).

The same licensees who are presently entrusted by the state of Vermont to manufacture and distribute alcohol could be entrusted to setup and check IDs at a cannabis consumption space, similar to a 'beer garden'.

Application for Temporary Alcohol Consumption at Vermont Events

Required Information:

- + Event Name and Basic Event Details
- + Consumption Rules -- where and how is legal consumption specifically allowed at the event? Licensed retailer.
- Responsibility -- who is legally responsible for ensuring consumption is legal? Licensed retailer.
- + Control of Sales -- Licensed retailer.

"How would this work within the specific guidelines for cannabis?"

Licensed retailers are currently meeting all training, sales, and inventory tracking requirements.

The people presently selling cannabis in a fixed location are immediately qualified to sell cannabis in a different location – IF the location and event setting meet security requirements:

- Double entrance with an ID requirement to enter sales/consumption area
- Siting of sales/consumption area to ensure adequate proximity from smell nuisance and/or underage participants (100yd buffer?)
- Licensed security present to perform ID check and assist with enforcement
- Security camera to document sales location
- Limited inventory at event location. Possibly require pre-purchase of inventory
- If sales happening on-site, require cashless sales at event

Short Answer: Keep it simple and do it exactly like alcohol.

¹ By maintaining the 'two hand' rule and eliminating cannabis and alcohol from being consumed at the same time, you reduce risk of multi-substance intoxication.

² This \$70 charge is twice as expensive than a special events permit for alcohol; since there are not legal sales of cannabis, a higher charge similar to a tasting permit for a brewers festival would not be justified.

Event Host

Event organizer collaborates with cannabis retail to define consumption location parameters on the permit application.

Cannabis Retail

Complete application defining where, when, and by whom cannabis will be sold and consumed at the event.

State Agency (CCB or DLL?)

State receives permit and % of permit revenue from municipal government; enforces permit as necessary

Local Government

Any additional local zoning issues are clarified at this stage to receive town approval.

Town clerk approves permit and collects payment, sends % of permit revenue to DLC.

Goal: Create a safe space for legal cannabis consumption in Vermont

Summary:

Legal consumption requires legal sales of regulated products.

We have legal sales and regulated products.

Legal sales have security, training, and tracking requirements.

Dispensaries already have security protocols, trained staff, taxed sales, and tracked inventory.

Consumption can't just happen anywhere.

A local permit approval will shape the location(s) and condition(s) that work best for each municipality and event.

What's wrong with the status quo?

Every Vermont business that serves 21+ adults is presently exposed by the lack of definition of legal consumption.

Licensed cannabis establishments not illegal dealers - should serve event consumers regulated products.
