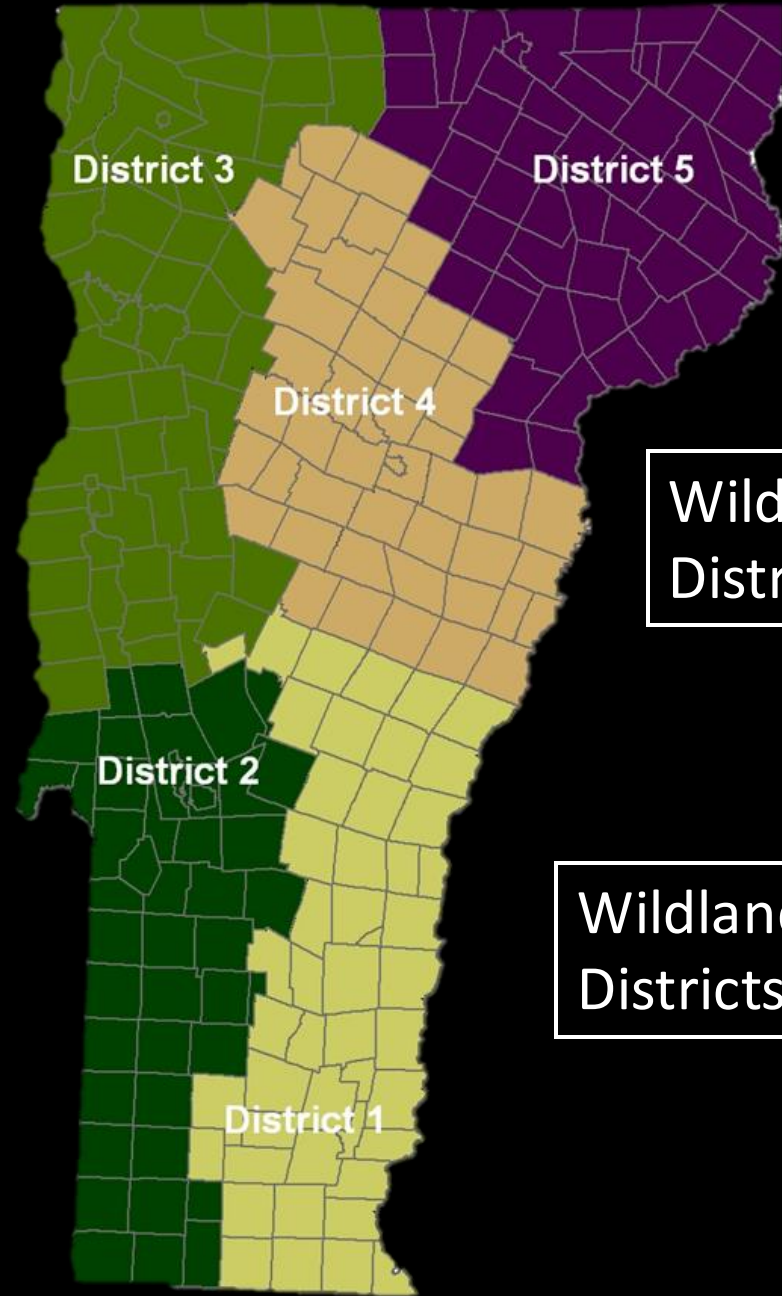

Outreach - In 2024, FPR held 40 Smokey Bear fire prevention events in 30 towns:

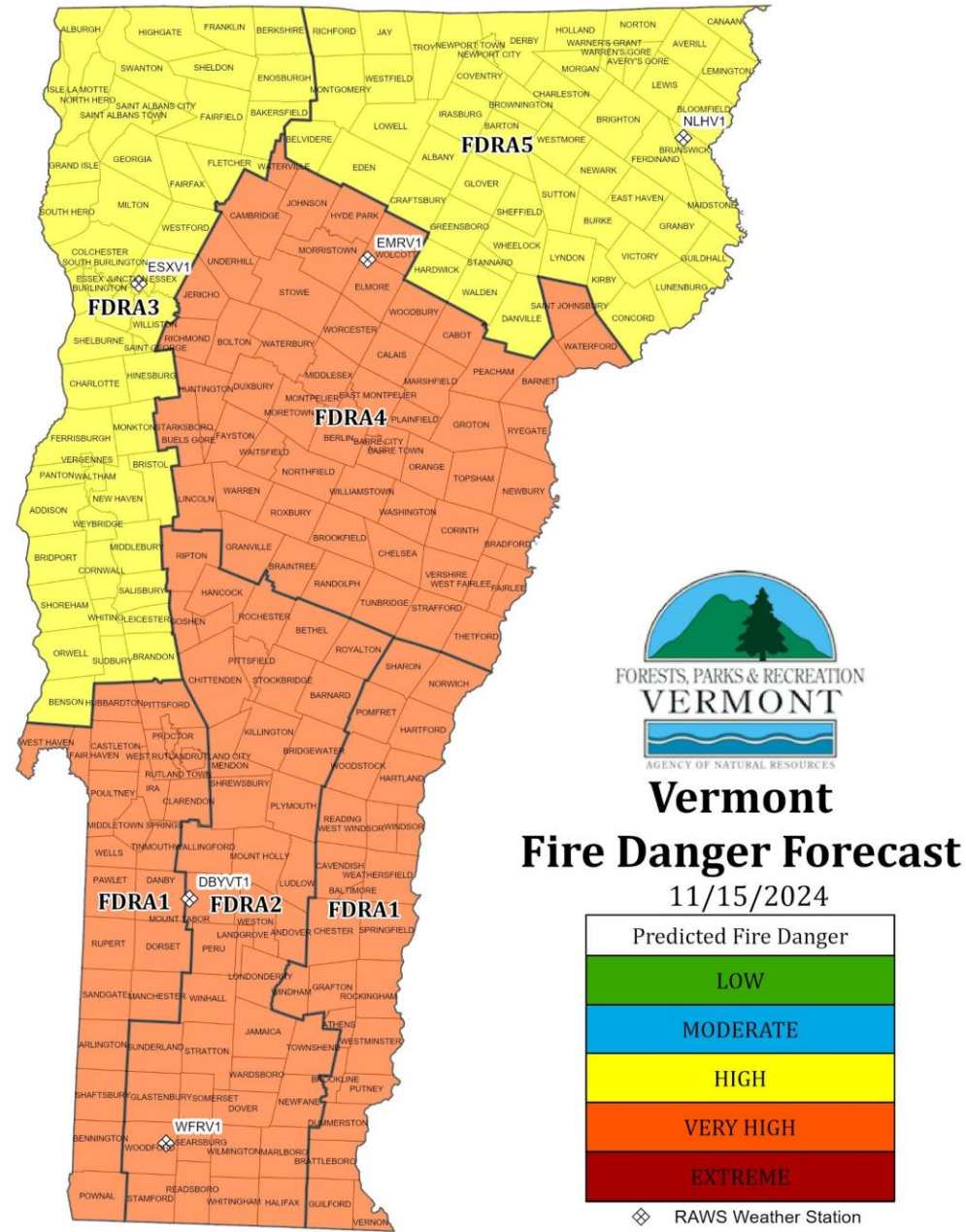

FPR Daily Fire Danger Forecast


- Daily Fire Danger Forecast map

- 50/50 PPE and Equipment Purchasing
 - 31 towns in 2024
 - \$58k total for rural fire departments.

FPR Wildland Fire Resources

FPR supports a team of wildland firefighters:

- 15 firefighters
- 6 Incident Management Team members
- 3 Fireline supervisors
- 23 staff nationally certified in 2024

- High pressure wildland pump
- 2000-foot forestry hose
- Chain saw kit, drip torch, hand tools
- Communications

4 Extended Attack Trailers

- 2 high pressure wildland pumps
- 4000-foot forestry hose
- Mop-up kits, backpack pumps
- Chainsaw kit, drip torch
- Hand tools for 20-person crew

Northeast Forest Fire Protection Compact

- Mandate: Provide the means for member agencies to cope with fires that might be beyond the capabilities of a single member
- Established in 1949 following the devastating wildfires in Maine in 1947 that burned over 220,000 acres
- New England states, New York, Quebec, New Brunswick, Nova Scotia, Prince Edward Island, Newfoundland and Labrador, Federal Agencies, and FDNY.



2024 FPR Resources Deployed

7 FPR staff were deployed to 20 different fires in California, Idaho, Minnesota, Montana, Nevada, Oregon, Washington

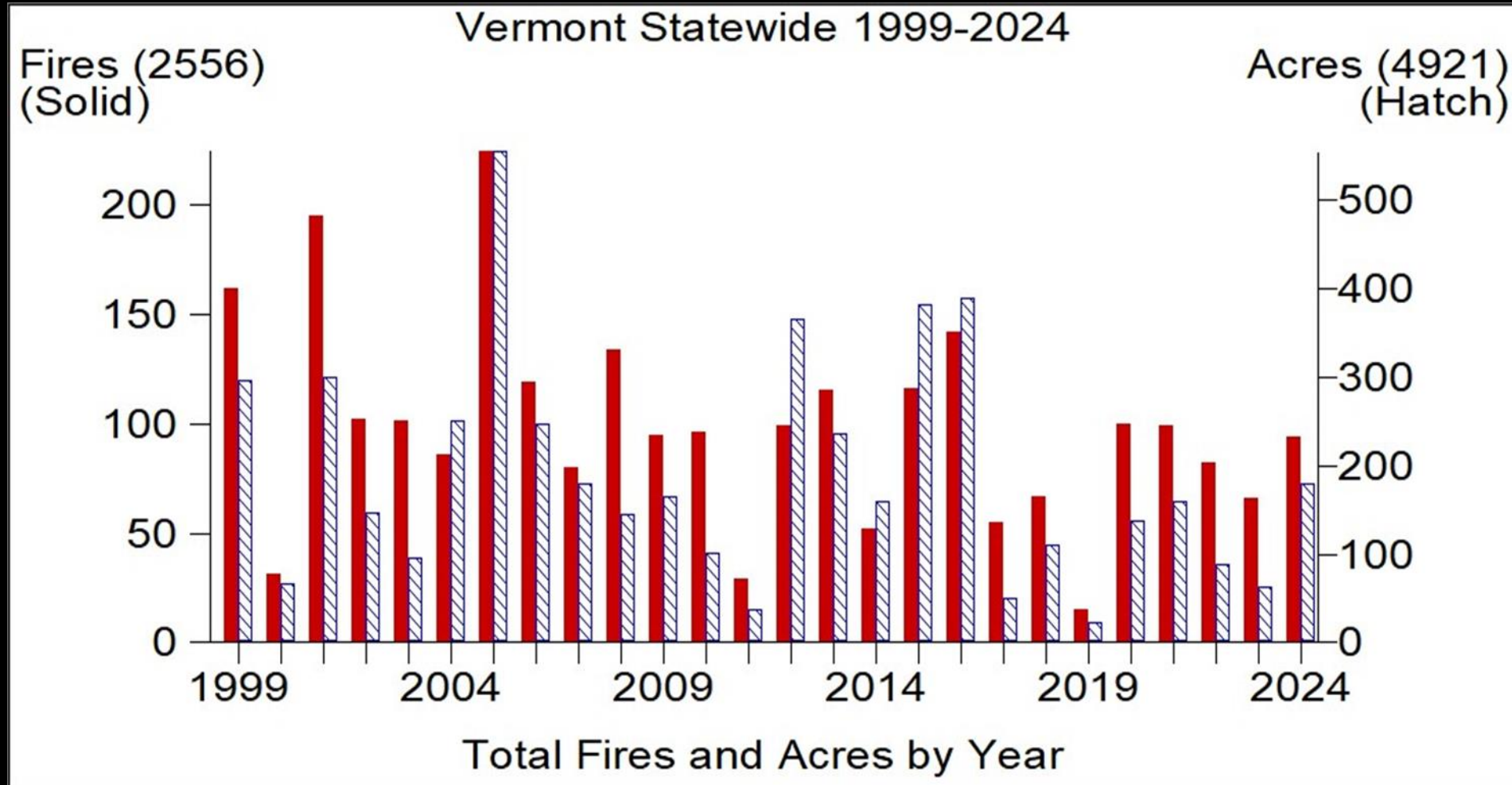

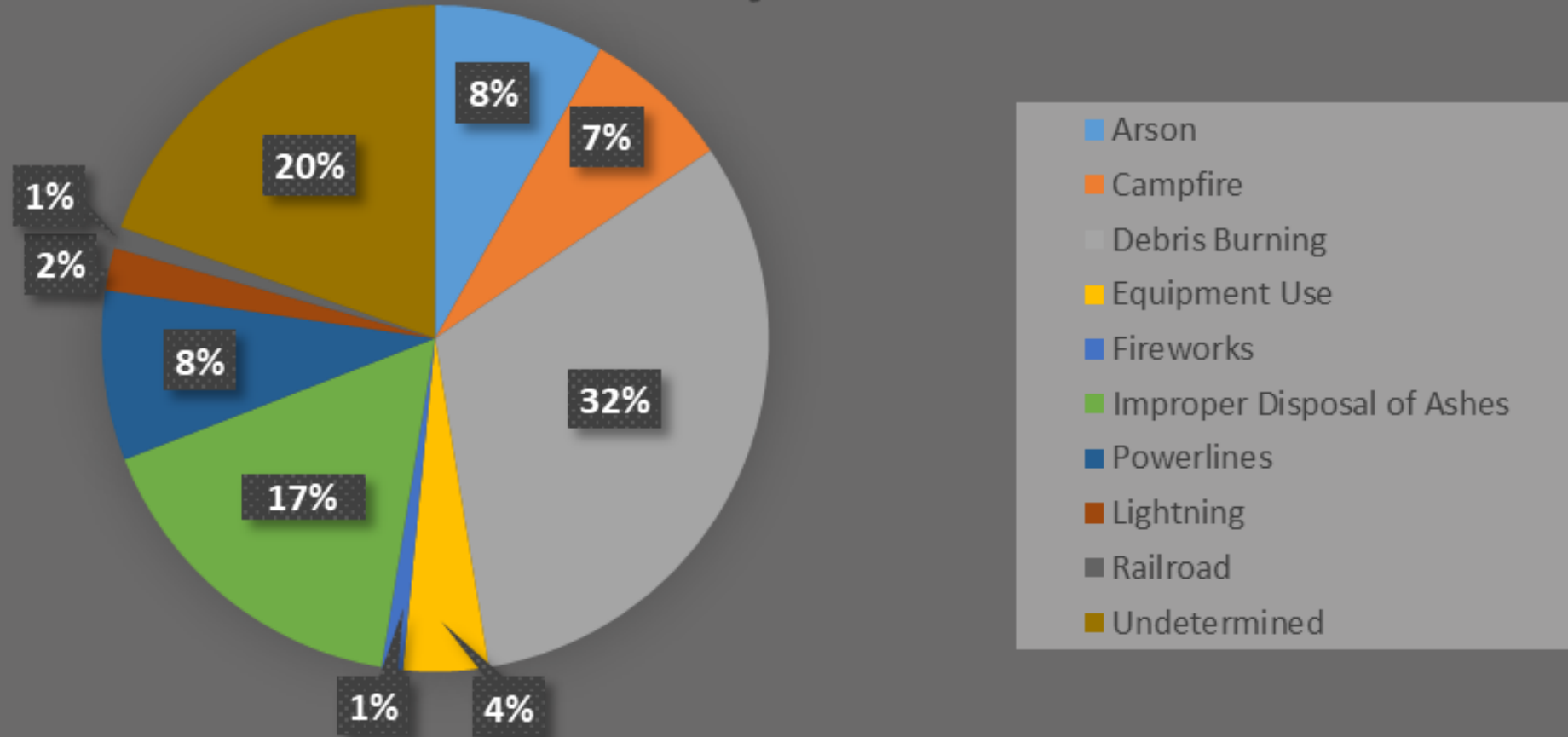

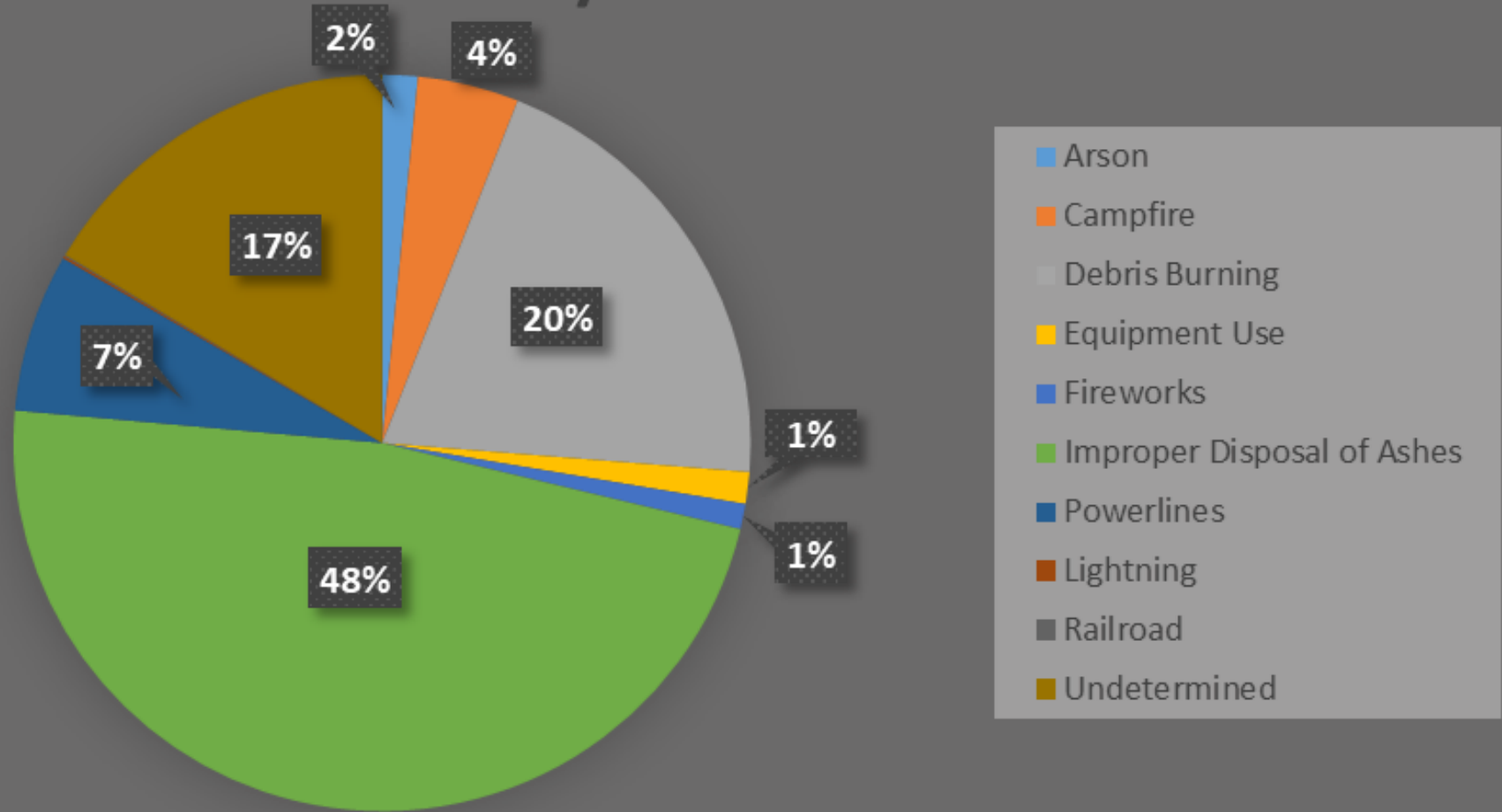
Number of Fires by Cause 2024

10-Year Average: 81.1 fires for 156.7 acres

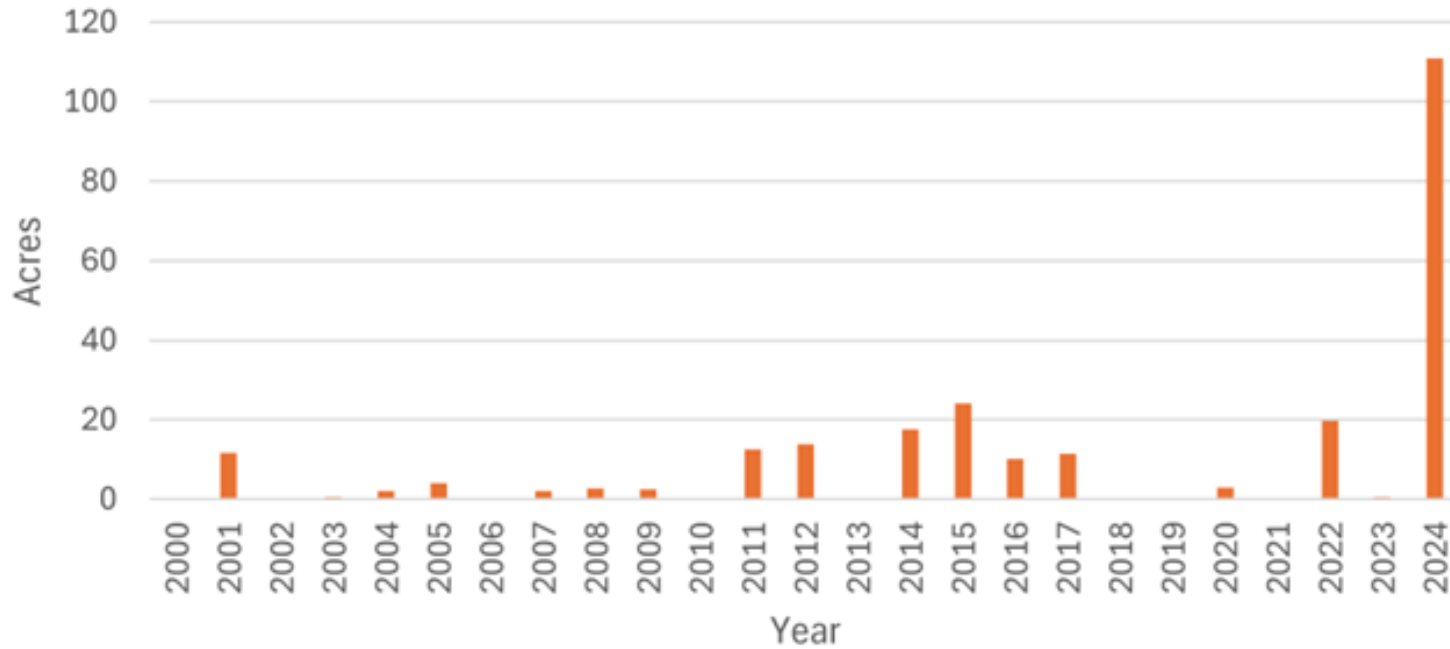
Total Acres by Cause 2024

Fall 2024:

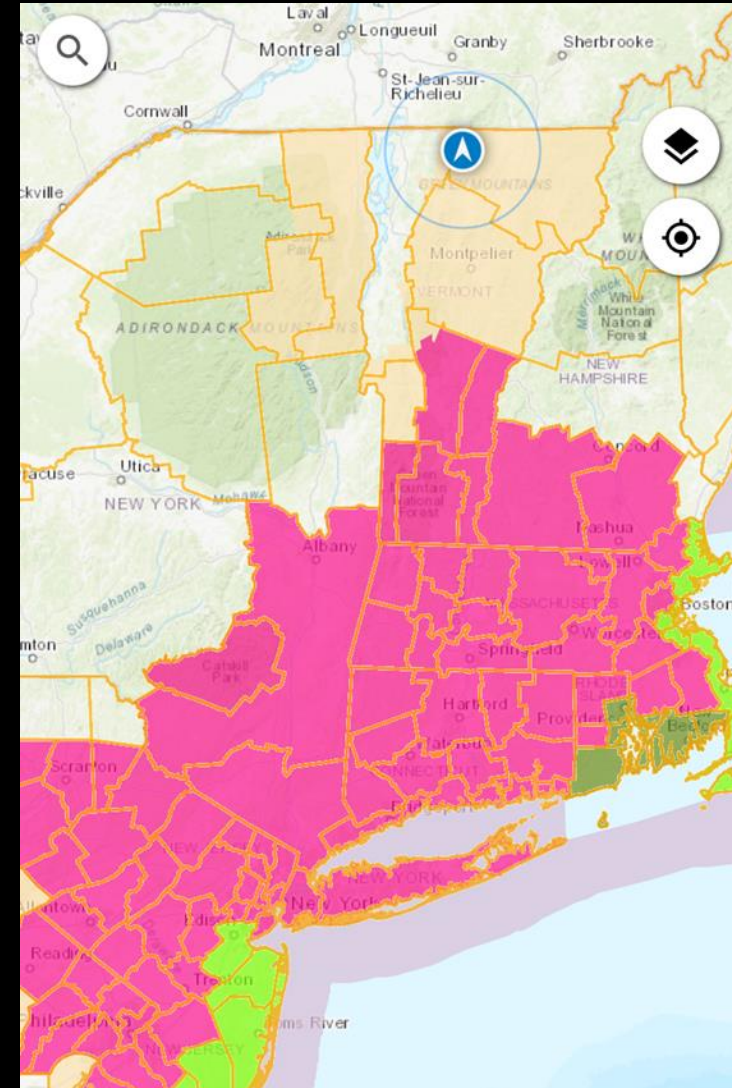

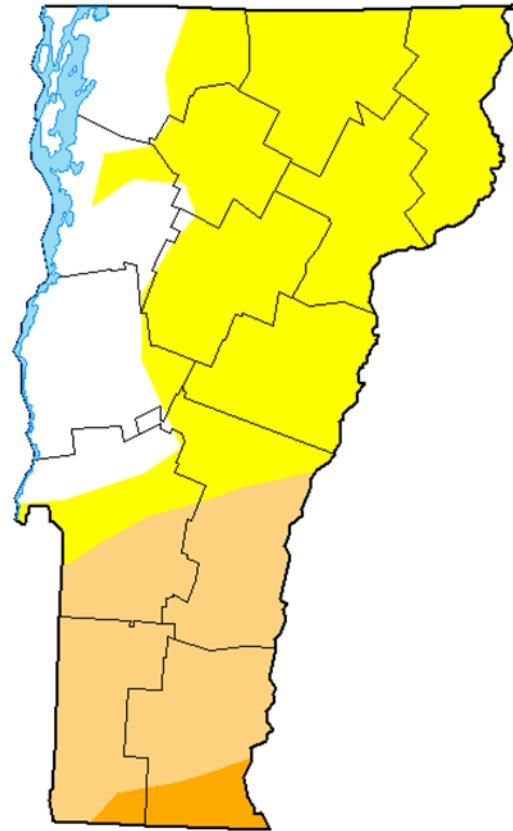

Many eastern states were experiencing multiple catastrophic wildland fires at the same time, putting a strain on local and regional resources

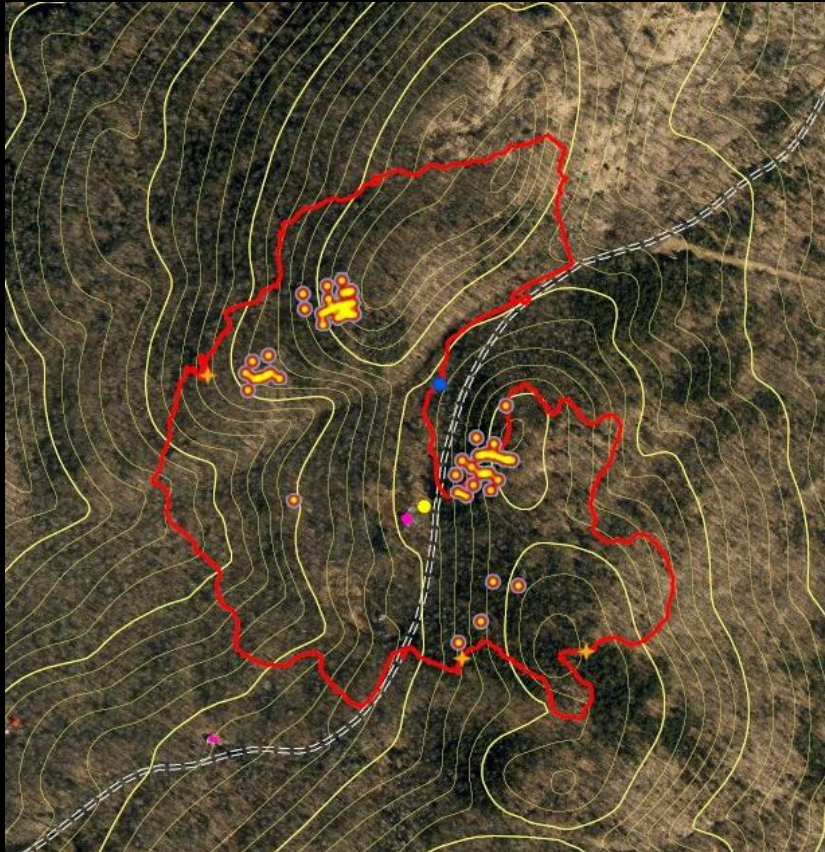
Firefighting resources were brought in from across the nation to meet the demand

There were 3 firefighter fatalities in the fall of 2024 responding to wildland fires in the northeast

Historically high fire activity year in Connecticut, Massachusetts and Rhode Island—on the heels of a historically high fire activity year in Eastern Canada the year prior

Morgan Road Fire (October 27)

- 57 acres
- 2 structures lost



Fire Program Goals



Prepare for the impact of climate driven increases in fire activity



Continue development of plan for large fire response



Create emergency firefighter program and develop staff with fireline supervision qualifications



Purchase a wildland fire engine for in-state response, prescribed burn support, and interagency fire details



Expand use of prescribed fire for wildlife habitat and fuels maintenance
