



Strengthen Vermont's Nonprofit Sector – A Call to Action

Appropriations Request, FY26-27

Vermont State Legislature

Uncertainty at the federal level is creating challenges for nonprofits serving Vermonters and our communities. Common Good Vermont is ready to help lead the effort to coordinate solutions to these challenges and seeks support from the State.

Funding this proposal will strengthen the nonprofit sector that employs one in five Vermont workers and delivers services on which the State relies. Vermont's nonprofits are ready to coordinate, adapt, and safeguard essential services with State partnership. The proposed public-nonprofit partnership will protect essential services, strengthen the workforce, and help Vermont respond to federal disruptions with coordination and resilience.

What We Are Asking For

Common Good requests that the State of Vermont provide:

- **\$295,665 in one-time funding** to help nonprofits navigate federal cuts, executive orders, and policy shifts that affect service delivery. 75% of funds will be allocated to nonprofit technical assistance.
- **\$267,777 in base funding** to improve nonprofit capacity, financial management, and compliance, strengthening the State's own grantmaking and contracting systems.

Why This Matters

Vermont's nonprofits are essential to Vermont communities. Nonprofits provide food, housing, health care, childcare, mental health services, arts and culture, and community development. Many organizations operate without the resources needed to keep pace with rising demand. Without coordinated action, federal changes could erode services that Vermonters rely on every day.

What This Proposal Delivers

Federal Impact Response (one-time funding)

- **Nonprofit Task Force:** Six meetings over one year, including one hybrid session, producing **two policy reports** with recommendations for State leaders.
- **Cross-Sector Convenings:** Two statewide convenings with nonprofits, municipalities, RPCs, lawmakers, state agencies, and small businesses. A **published report** will outline shared risks and coordinated response strategies.
- **Technical Assistance for 100 Nonprofits:** Support for organizations facing federal disruptions, including strategic planning, Medicaid scenario planning, legal guidance on conflicting directives, and evaluation of collaboration, merger, or dissolution options.

Sector Capacity Building (base funding)

- **Training and Resources:** Targeted training on grants, compliance, and financial resilience.
- **Improved State Partnerships:** Collaboration with state agencies to streamline grant and contracting processes and reduce administrative burdens.
- **Sector Data:** Sector specific data on wages and benefits to benchmark and set nonprofit compensation, inform policy decisions, and monitor employment trends.
- **Technical Assistance Fund:** Support for nonprofits working through state contract requirements, financial management, reporting, or compliance concerns.
