

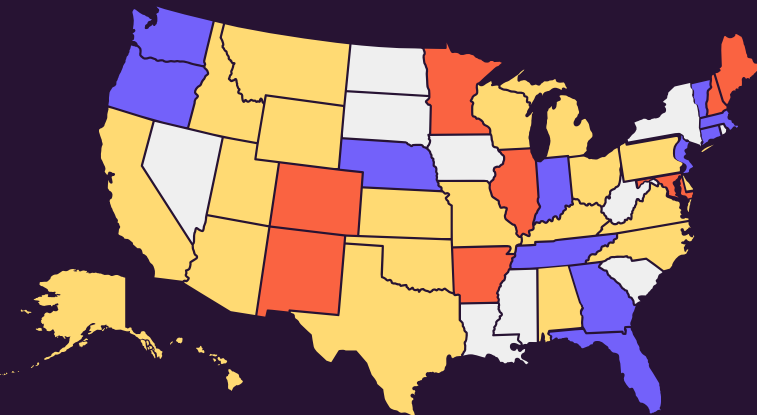
Empower through Movement
