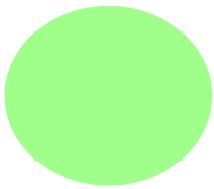
This structure facilitates:

- **Efficient Service Delivery**: The agency can manage complex cases and maximize federal funds more effectively with the benefit of both the close collaboration and specialization.

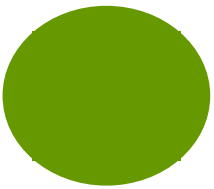

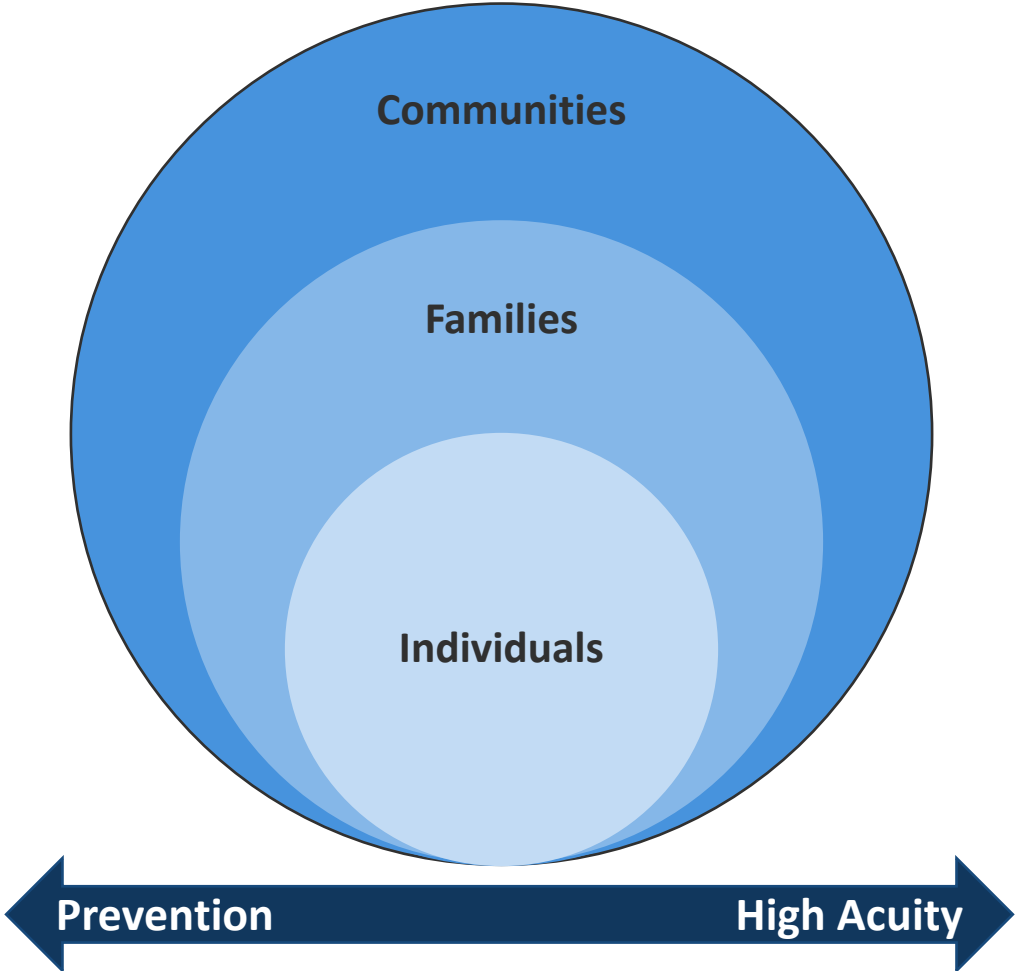

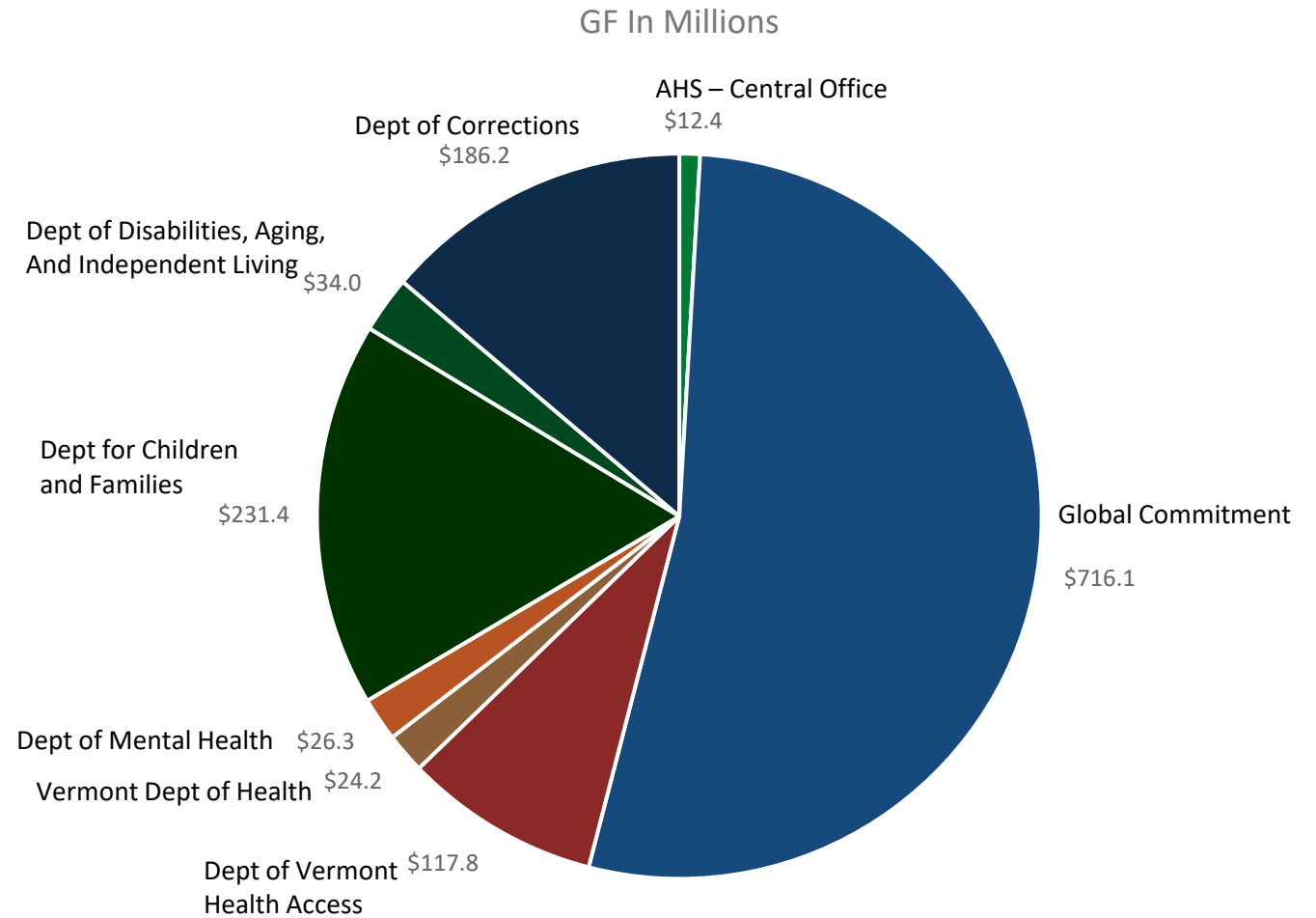

AHS – FY25 General Fund Budget by Department (\$ Millions)

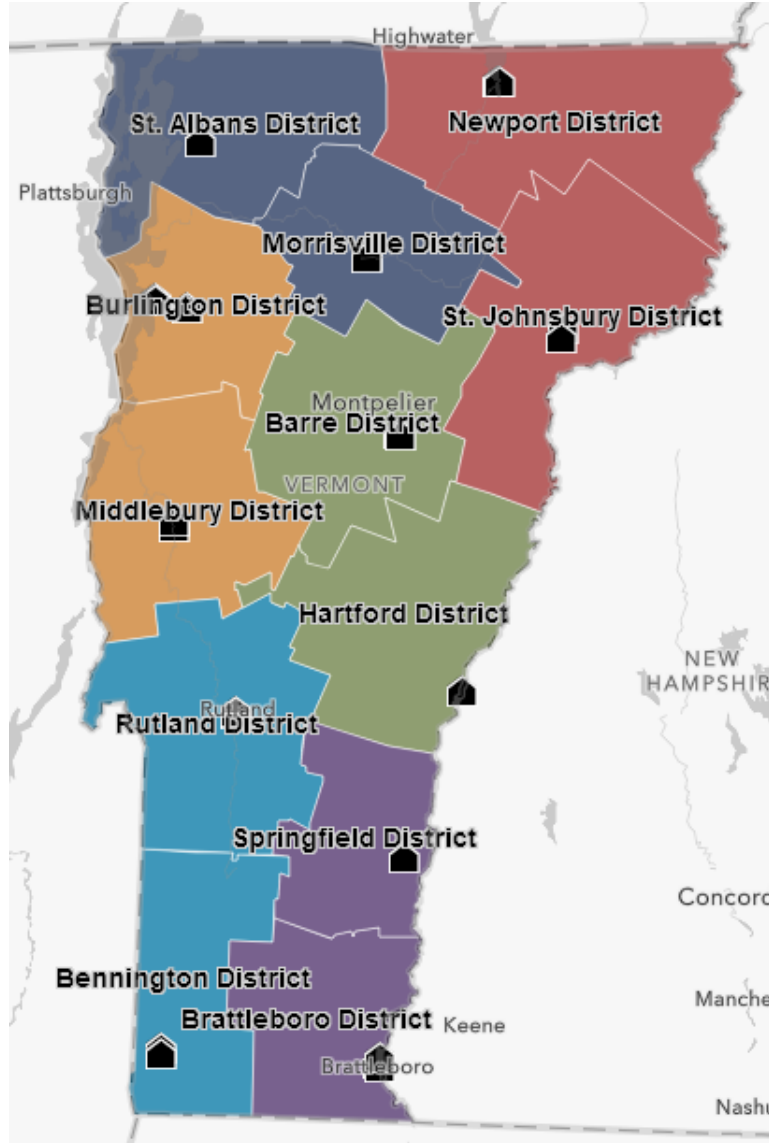


AHS – Positions by Department – 4,127

AHS District Offices



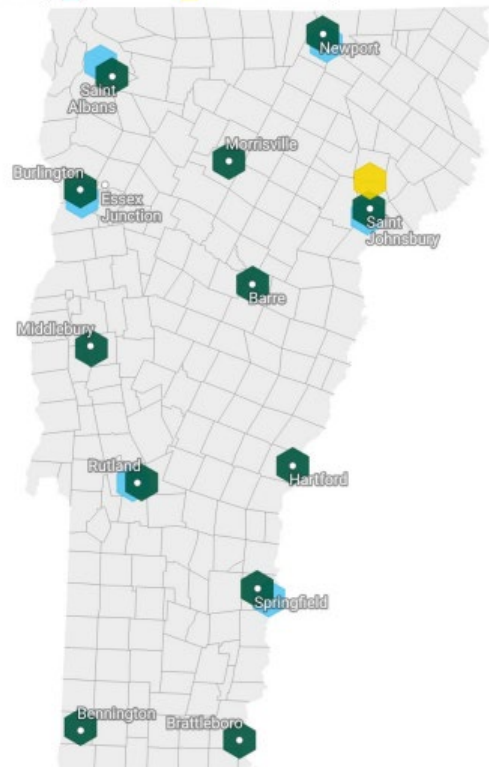
Services Provided:

- **Field Service Director** for each District - High Level AHS position that collaborate with local communities, legislators, municipal leaders and help to problem solve complex situations in their communities
- **Health Care Nurses** for community members to access multiple resources for health and wellness. Provide case management for complex cases that involve engaging multiple providers.
- **Children and Family support** for adoption, foster care, ensuring child safety, juvenile justice
- **Economic Services** to individuals and families
- **Employment and Training Resources** for those with physical disabilities and/or intellectual disabilities.
- **Parole and Probation** ensuring completion of court-ordered community-based sentences, rehabilitation programs, restorative justice
