

# Who We Are

- Addison Housing Works is a nonprofit affordable housing owner, developer, and manager based in Vergennes, Vermont.
- We provide over 750 permanently affordable homes in Addison County including rental apartments, manufactured housing communities, and shared equity single-family homes and condos.
- We also offer resident services to vulnerable families and to seniors to help them age safely at home (SASH).







# Full Statutory Funding (\$36.9M) for VHCB Supports:

- •Permanent affordability
- •Healthy homes with wraparound supports
- •Smart growth & energy efficiency
- •Downtown revitalization
- •But, it's not enough—an additional \$40 million is needed just to meet the demand for new construction over the next year.
- •Shown: 66 apartments built since 2015 including a new mixed-use neighborhood, an infill project, and a downtown revitalization project—all close to jobs and services in Middlebury, Bristol, and Vergennes.

#### VHCB & AHW Support the Most Vulnerable Vermonters

- •80 of AHW's 353 apartments (22%) are currently dedicated to formerly homeless households
- •28% of apartments leased in 2025 were to families and individuals exiting homelessness (18 households)
- •Over half of our apartment residents qualify as "Extremely Low Income" – they subsist on incomes at or below the poverty line (hundreds of households in Addison County) ~\$25,000/yr
- •37% are elderly, and 32% have a disability
- •Capacity grant from VHCB supports almost 10% of our operating budget we could not do what we do without VHCB



### Need for Resident Services

- Increasing need to serve more people exiting homelessness
- •Higher acuity of need among residents since the pandemic
- •Growing body of evidence for "Housing as a Platform for Health"
- •AHW launched the Family Support Program in 2021 through local philanthropy; expanded in 2024
- •Recognizing success and importance of resident services, VHCB received three-year grant to continue supporting this work through 2027



# Family Support Program

- •Focuses on families with children who are at-risk of eviction, but can serve anyone in AHW housing
- •Entirely voluntary, resident signs a release so AHW can coordinate with other local service provider of resident's choice
- •Goal is to stabilize housing and increase resident wellbeing, both at the individual level and the community level
- •Fills gap in "upstream services" which often aren't available to residents who are currently housed but struggling – intervenes before they lose their housing



#### Impact

- •104 households with 68 children participated in the program in 2023
- •Grew to 144 households with 94 children in 2024
- •96% remained stably housed at the end of the year
- •Highlights:
  - •Helped MHC residents access \$454,344 through MHIR and Weatherization
  - •34 Households brought current on rent; helped access \$27,352 from community partners
  - •Helped households with:
    - •Emotional Support (104)
    - Forms Assistance (255)
    - •Squalor Intervention (42)
    - Referrals to Other Agencies (309)
