Narrative: Vermont held a DRE school in Burlington in June, followed by field certifications held in Jacksonville, FL. Five officers and two audit students, made up of prosecutors and lab personnel that attended the school. Vermont experienced 387 requests for a DRE response from law enforcement agencies in 2023 through its statewide call-out system.

Other Training: Two full day recertification trainings were conducted during the year. Eight DREs were able to attend the IACP IDTS Conference held in Anaheim, CA. Two DREs attended the Borkenstein Drug Course in Madison, WI. In addition, the Vermont program offered several training webinars to DREs throughout the year.

Interesting Cases Involving DREs: A DRE assisted with a two-vehicle fatality collision in the town of Colchester. It was found that the at-fault operator drove off the roadway and struck a vehicle stopped at a stop sign at an intersection. The operator was evaluated and was found to be operating under the influence of CNS Depressants and Cannabis.

Accomplishments and Challenges: Vermont has experienced some challenges in recruiting new DREs and is currently at the lowest number of certified DREs since 2016. 2023 saw a 6% decrease in enforcement evaluations from 2022.
