






Count of All Clean Transportation Incentives by Resident Zip Code

% of All Incentives Issued by Income Level and Vehicle Type




All Incentives Issued 2020 - 2024








Quarterly New PEV Incentives Paid by Income Level and Vehicle Type

Leasing by Vehicle Type









Geographic Distribution of All MileageSmart Incentives Issued









Recommendations

REPLACE YOUR RIDE, NEW PEV AND MILEAGESMART

- Target incentive funding to Vermonters with lower incomes
- New PEVs: only All-Electric Vehicles
- Used PEVs: AEV + PHEV (no conventional hybrids)
- Second vehicle MSRP cap tier for light duty trucks
- Right-size incentive amounts for leased vehicles
- Real-time funding flexibility to adapt to demand

ELECTRIFY YOUR FLEET

- Increase incentive amounts for electric vehicles
- Increase eligibility, MSRP caps for vehicle types
- Target funding for battery-electric vehicles only
