## 3. Island Pond Airport Usage

Unfortunately, we do not have a current way to accurately measure the number of enplanements at Boylan State Airport in Brighton, VT (Island Pond). Understanding the number of "enplanements" at each one of our airports has been a historical challenge. Fortunately, with advancements in technology and airplane equipment requirements, we are looking into software solutions that will help us identify how many enplanements our airports receive annually. ADS-B (location reporting equipment) is carried on nearly all airplanes now, and the logged data can be utilized by specialty software to identify how many airplanes visited each airport over a period of time. We are undergoing an effort internally to understand the limitations with this type of aircraft count software and also the costs associated with it. As a sidenote, if we are better able to understand the amount of air traffic we receive, we can use those numbers to justify additional federal funding.
