# Mobility Services Guide

---

The Agency of Transportation, in consultation with existing nonprofit mobility services organizations incorporated in the State of Vermont for the purpose of providing Vermonters with transportation alternatives to personal vehicle ownership, such as through carsharing, and other nonprofit organizations working to achieve the goals of the Comprehensive Energy Plan, the Vermont Climate Action Plan, and the Agency of Transportation's community engagement plan for environmental justice, shall develop a web-page-based guide to outline the different mobility service models that could be considered for deployment in Vermont.

# Mobility Services Guide

---

At a minimum, the web-page-based guide required under subsection (a) of this section shall include the following:

1. Definitions of program types or options
2. Information related to existing initiatives
3. Details of other existing programs that may provide a foundation for or complement a new program in a manner that is not duplicative or competitive;
4. For each possible program type or option defined pursuant subdivision (1) of this subsection, additional details outlining:
  - A. the range of start-up, capital, facilities, and ongoing operating and maintenance costs;
  - B. the service area characteristics;
  - C. the revenue capture options;
  - D. technical assistance resources; and
  - E. existing or potential funding resources.

# Active Transportation

Active Transportation is the service model based on human-powered transportation that involves physical activity. This includes walking, cycling, using a wheelchair, skateboarding, rollerblading, and other similar modes of travel.

## LOCAL MOTION

- Provides on-the-ground advocacy, community organizing, project-specific technical assistance, workshops and classes for all ages, and bike-friendly resources for businesses and communities.
- Cost to VTrans for program of \$75,000 per year for ongoing operations.

## BIKESHARE

- A bikeshare program is a public or membership-based transportation service that provides people with convenient access to bicycles for short-term use. The goal is to make bikes available for quick, flexible trips—often to supplement public transit, reduce car dependency, or encourage active, sustainable travel.
- Chittenden Area Transportation Management Association operated a Bikeshare from 2021-2024 serving Burlington, South Burlington and Winooski.

## WALK TO SHOP

- Cost: \$50,000 to startup and \$100,000 in capital; \$100,000 for ongoing operations.
- Serves transit service areas, downtowns, and villages across Vermont.
- Revenue from the sale of trolleys covers a portion of the project costs.
- Funding from the State of Vermont, regional grants, corporate sponsorships, and cash and in-kind contributions from partners and volunteers.
- Resource for public education and community engagement, walking, 15 min-neighborhoods.

## MOBILITY AND TRANSPORTATION INNOVATION (MTI) GRANT PROGRAM

This program is designed to support innovative strategies and projects that improve mobility and access to services for transit-dependent Vermonters, reduce the use of single occupancy vehicles, and reduce greenhouse gas emissions.

# Passenger Transportation

Passenger transportation is the service model that moves people from one location to another using various modes of transport. These modes include bus, van, or car that are operated by public or private agencies.

## PUBLIC TRANSIT PLANNING THROUGH GO! VERMONT

- Cost: \$10,000 to start up & \$15,000 for ongoing operation.
- **Transit Royale:** free to download and create an account for any Vermont resident.
- All public transit routes are available to search and ride.
- June 2024: 10,203 riders opened the transit app to search for a bus route.
- Funding from VTrans FTA 5311 Formula and State funding at a (50/50 share) to cover operation subsidy.

## MICROTRANSIT

- Cost: \$250,000 to start up and \$200,000 in capital; \$250,000 ongoing operating and \$50,000 ongoing maintenance costs.
- Public Transit Operators: Green Mountain Transit, Tri-Valley Transit, Southeast Vermont Transit, Green Mountain Community Network, Rural Community Transit.  
— Microtransit should connect well to existing fixed route public transit services.
- Serves Montpelier, Middlebury, Manchester, Morrisville, Windsor, Brattleboro.  
— Towns/villages with existing underperforming fixed-route public transit or towns/villages with no public transit and a large transit dependent population and/or destination (Example Hospital).
- Creates revenue through rider fare.
- Funding from VTrans FTA 5311 Formula and State funding at a (50/50 share).

All eligible UVM employees can ride GMT buses for free. You must opt-in to the new system using the "Ride Ready" app.

## DOOR-TO-DOOR TRANSPORTATION VPTA

- Statewide Mobility Management /Travel Training.

- **Gopher**
  - Cost: \$317,810 to start up and \$235,258 in capital; \$157,523 ongoing operating and \$2,309 ongoing maintenance costs.
  - Serves Washington County and neighboring towns in Orange County.  
— Part of the larger transportation ecosystem— subcontractor to Green Mountain Transit in Washington County, provides solutions to gaps that exist with current public transit options.  
— Service area contains two cities (Montpelier and Barre) and one large town (Waterbury). All other towns in the service area can be characterized as rural.  
— Pockets of poverty within service area: City of Barre (24.1% poverty rate), Waterbury (18% poverty rate), and Northfield (15.5% poverty rate).
  - Aims to meet rural Vermonter's everyday transportation needs by providing convenient door-to-door rides to and from work, appointments, shopping, and social and recreational activities.
  - The Mobility For All services are intended to provide subsidized rides for individuals that are low-income and have limited or no access to transportation.
  - No fares for Mobility For All Trips. Market rate (\$10 booking fee + \$2.50/mile) is an option for folks who don't qualify for Mobility For All.
  - Pilot program: 80% subsidized from Global: State of Vermont funding. Referring agencies are asked to assist with 20% matching funds to help sustain program.
  - Further funding from State of Vermont public transportation program, foundation grants, individual donations, service contracts, and market-based rides.

## DOOR-TO-DOOR TRANSPORTATION (continued) Free Wheelin'

- Cost: \$33,000 to start up and \$50,000 for ongoing operation.
- Serves Mad River Valley (4 towns): Waitsfield, Warren, Fayston, and Moretown.  
— In 2022, provided 100 rides per month on average.  
— Seniors of the Valley members depend on them to get to and from medical appointments, social gatherings, grocery stores, the post office, beauty salon, and more. They are proud to be able to support seniors with this critical and free transportation service, as well as offering rides to non-senior Valley residents who don't have transportation.  
— All of Vermont, plus travel to Dartmouth-Hitchcock.  
— Complements existing dial-a-ride services in Washington County.
- Funding through donations from sponsors, users or the service, and the greater community. Ongoing funding from Mad River Valley Senior Citizens, Mad River Valley Community Fund, Mad River Valley Interfaith Council, donations, and grants.
- Free Wheelin' is operated by Mad River Seniors, a 501(c)3 Organization.

## Special Services Transportation Agency (SSTA)

- Founded in 1982.
- Many individuals have difficulty using conventional modes of transportation, such as cars and buses because of a physical or mental disability. For these people, SSTA's service may be the only transportation that they can use.
- SSTA currently has more than 50 vehicles in its fleet. Thirty are lift equipped for wheelchairs, providing an average of 600 to 700 rides per day.

- The organization currently employs over 70 full and part-time employees.
- Provides coordinated transportation service to many human service agencies. A few examples are the Visiting Nurse Association's Adult Day Programs, Champlain Senior Center (an important meal site for many of Burlington's older adults), Howard Community Health Services, and Age Well.  
— Complements existing dial-a-ride services in Chittenden County.
- The transportation SSTA provides clients an opportunity for social interaction, job training and employment, medical services, and therapy.
- Revenue from rider fare: punch card ticketing system, credit card, cash, money orders, and personal checks.
- Funding from rider fare, donations, Medicaid.

## Neighborhood Connections

- Cost: \$220,000 to start up and \$80,000 in capital; \$153,000 ongoing operating and \$10,000 ongoing maintenance costs.
- Serves Andover, Chester, and Weston in Windsor County; Jamaica, Londonderry, and Windham in Windham County; and Landgrove, Peru, and Winhall in Bennington County.  
— Highly rural; majority demand-response single riders.
- Founded in 2021.
- Revenue from MTI; exploring O&D funding thru subcontract with SEVT; exploring private hospital & school contracts.
- Funding through AOT, Towns in Service Area, Private grantors, private donors.

## GO! VERMONT CARPOOL MATCHING

Free carpool matching for anyone who is a Go! Vermont member.

Cost: \$10,000 to start up and \$60,000 for ongoing maintenance.

From October 31, 2024 - October 31, 2025, Vermont had 11,573 recorded carpool trips.

Funding from FHWA Road and Bridge Funding.

## VANPOOL / COMMUTE WITH ENTERPRISE

- Spends \$90,000 on ongoing operating costs.
- As of December 2025, Vermont had 19 operating vanpools.
- Go! Vermont provides a 50% subsidy for the first three months and then a 50% subsidy for each month after.  
— Funding through VTrans FTA 5311 Formula and State funding at a (50/50 share) to cover operation subsidy.
- Vanpool riders pay a fare to ride in the van. This fare covers the remaining operating costs after the Go! Vermont subsidy.

- The Flex option is tailored to meet the needs of individuals who don't always commute to work every day (e.g. hybrid work schedules). Riders can subscribe and coordinate their participation through an app, allowing some to join only on the days they need to the locations they need. You pay only for the days that you commute and can be updated each month. All costs, including fuel and insurance, are included in your individual monthly rate.
- Concerned About Last Minute Travel Changes? Never Worry with Guaranteed Ride Home. Go! Vermont pays for charges up to \$70 (up to twice a month, or a total of 4 times per year).

## CARSHARE VERMONT

- Serves Burlington, South Burlington, and Winooski.
- Revenue captured through Membership and Tier-based pricing.
- Cost of Carshare program to VTrans \$30,000 per year for ongoing operating costs.
