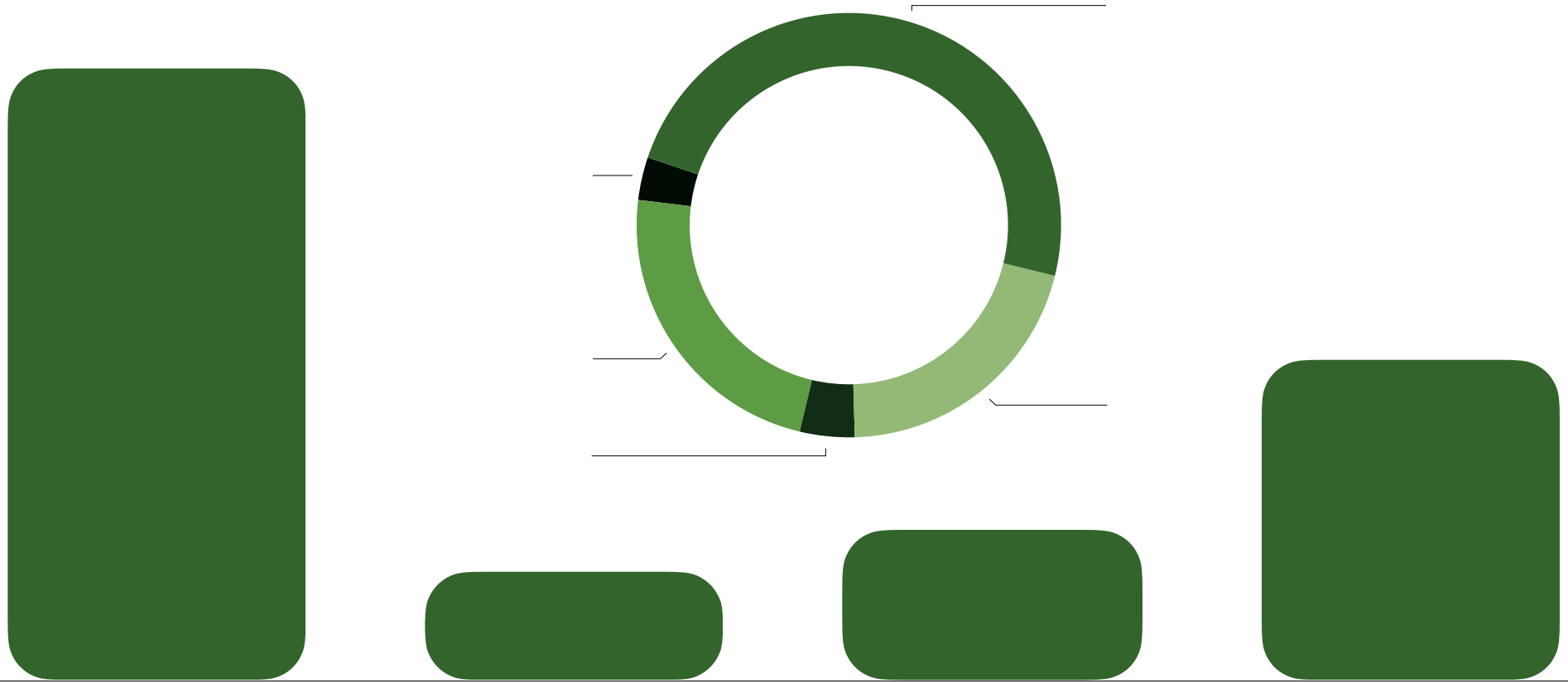

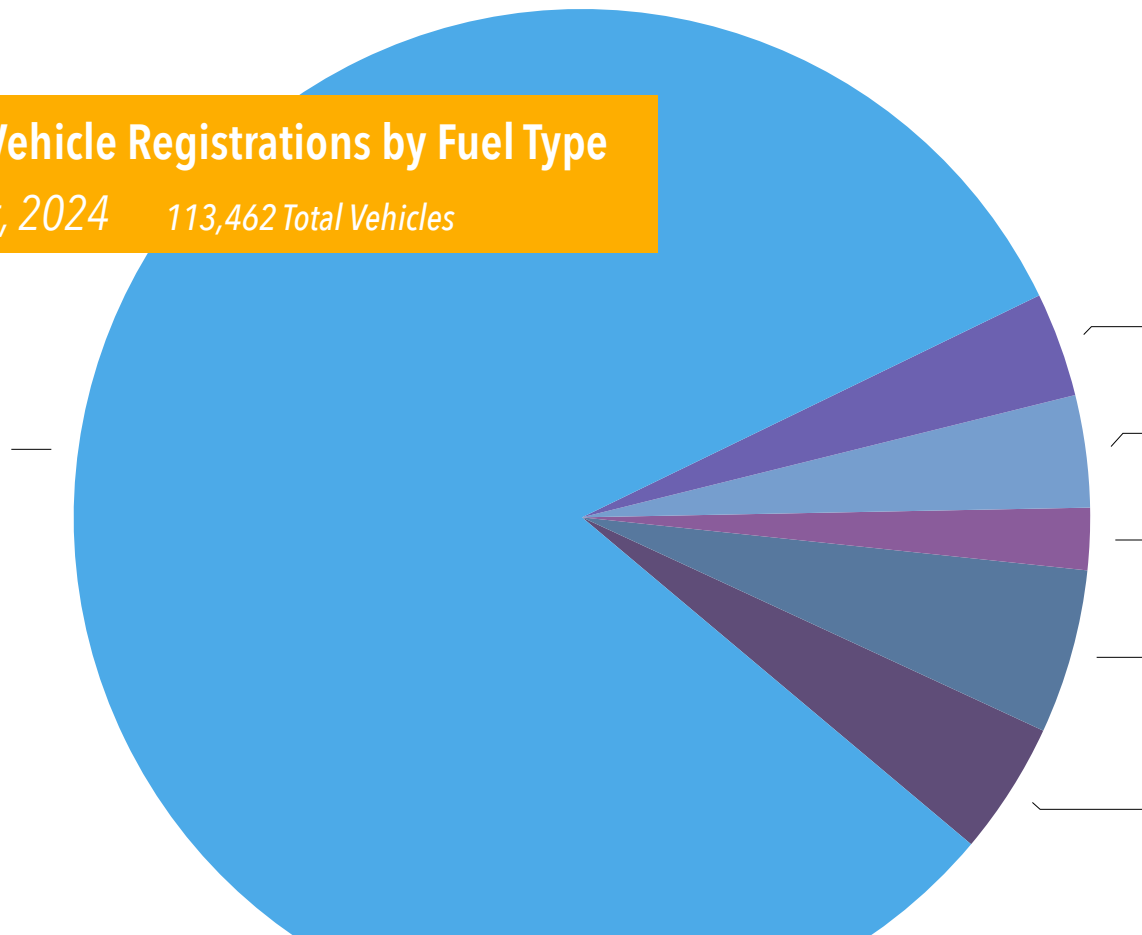

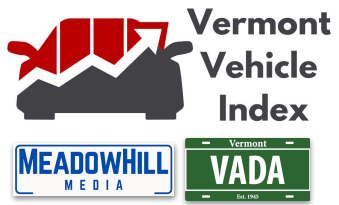

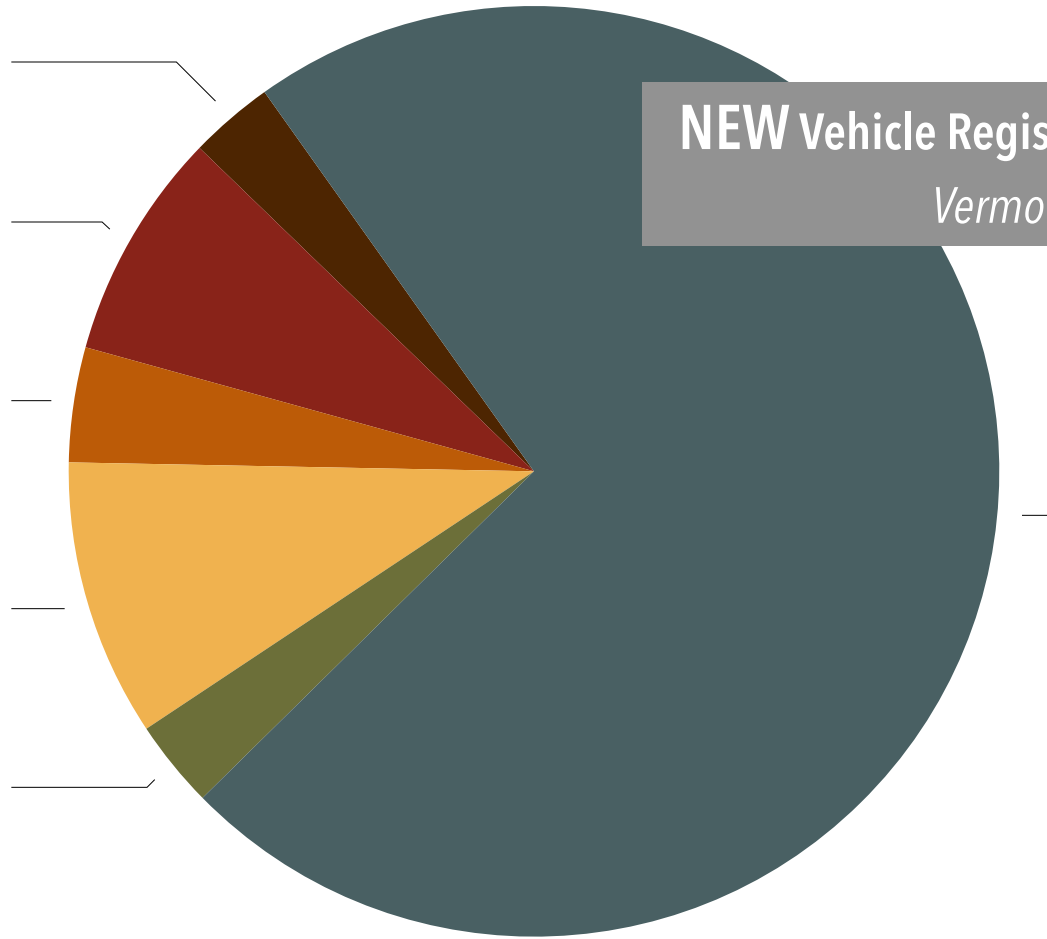

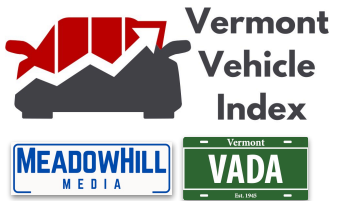


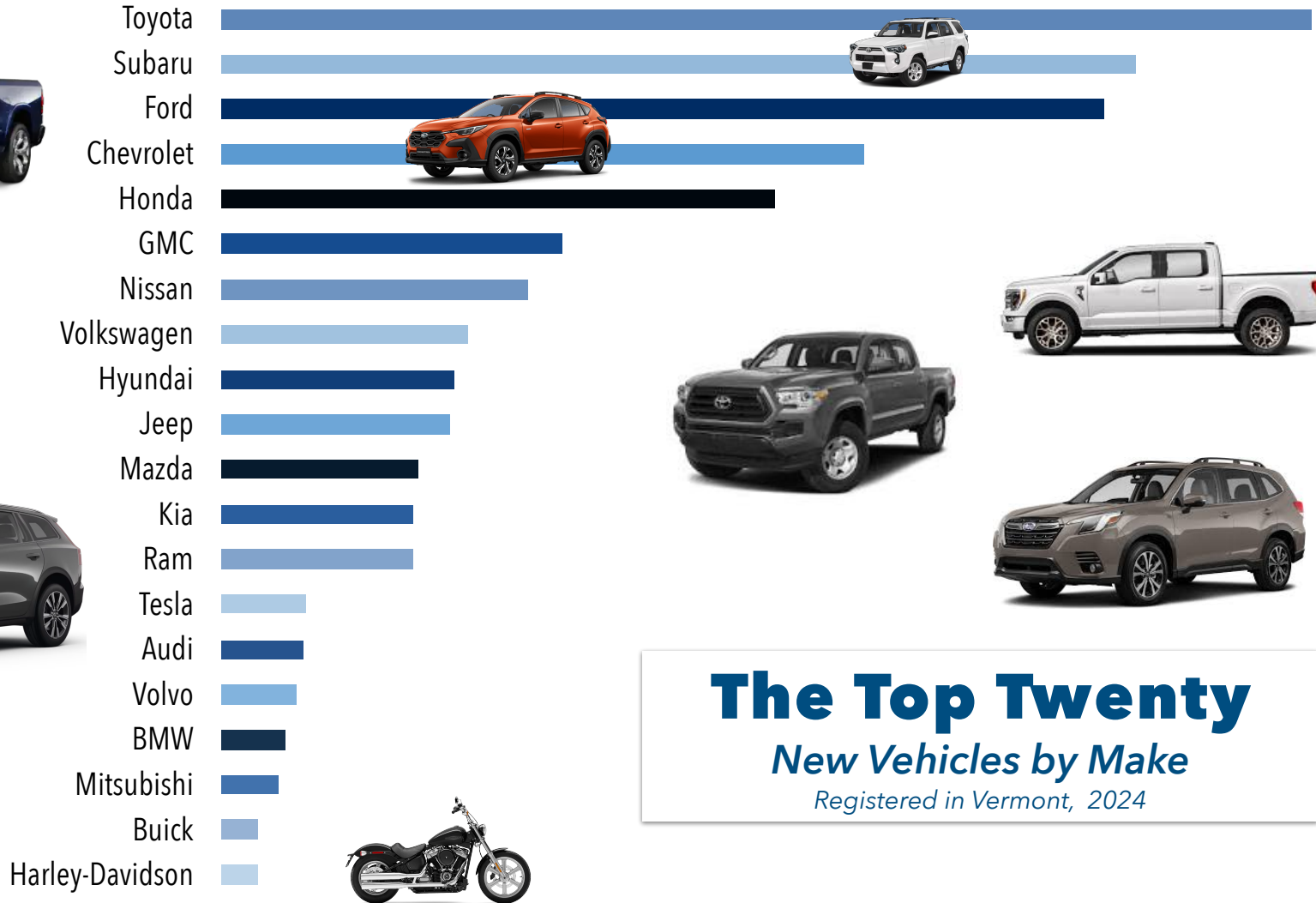
# NEW Vehicle Registrations by Fuel Type

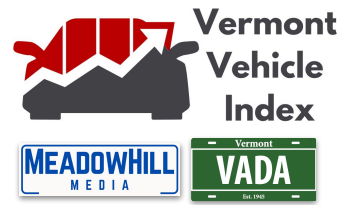

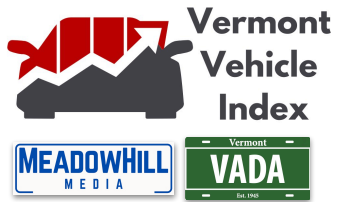
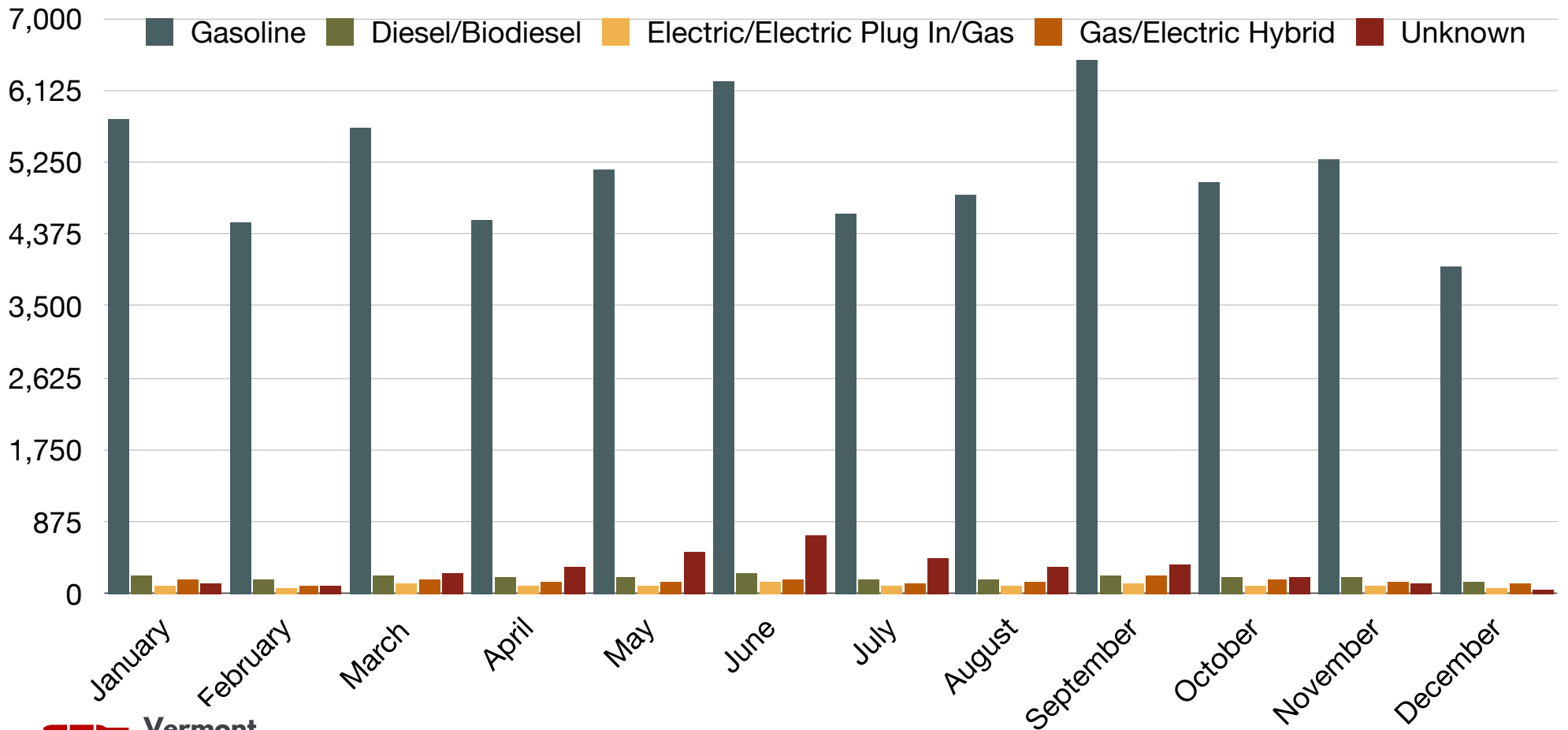

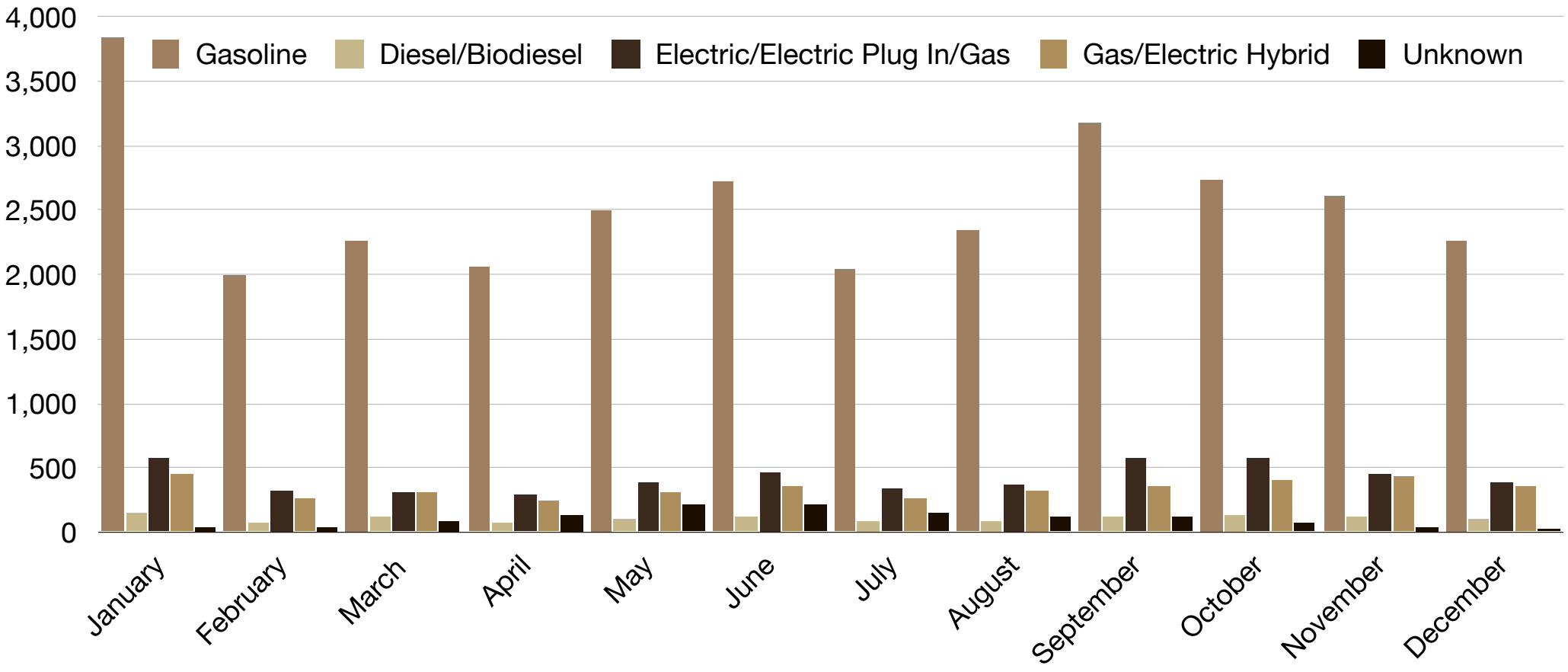

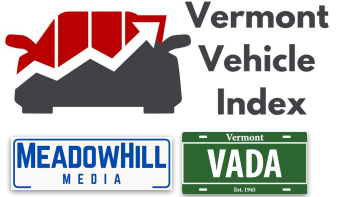


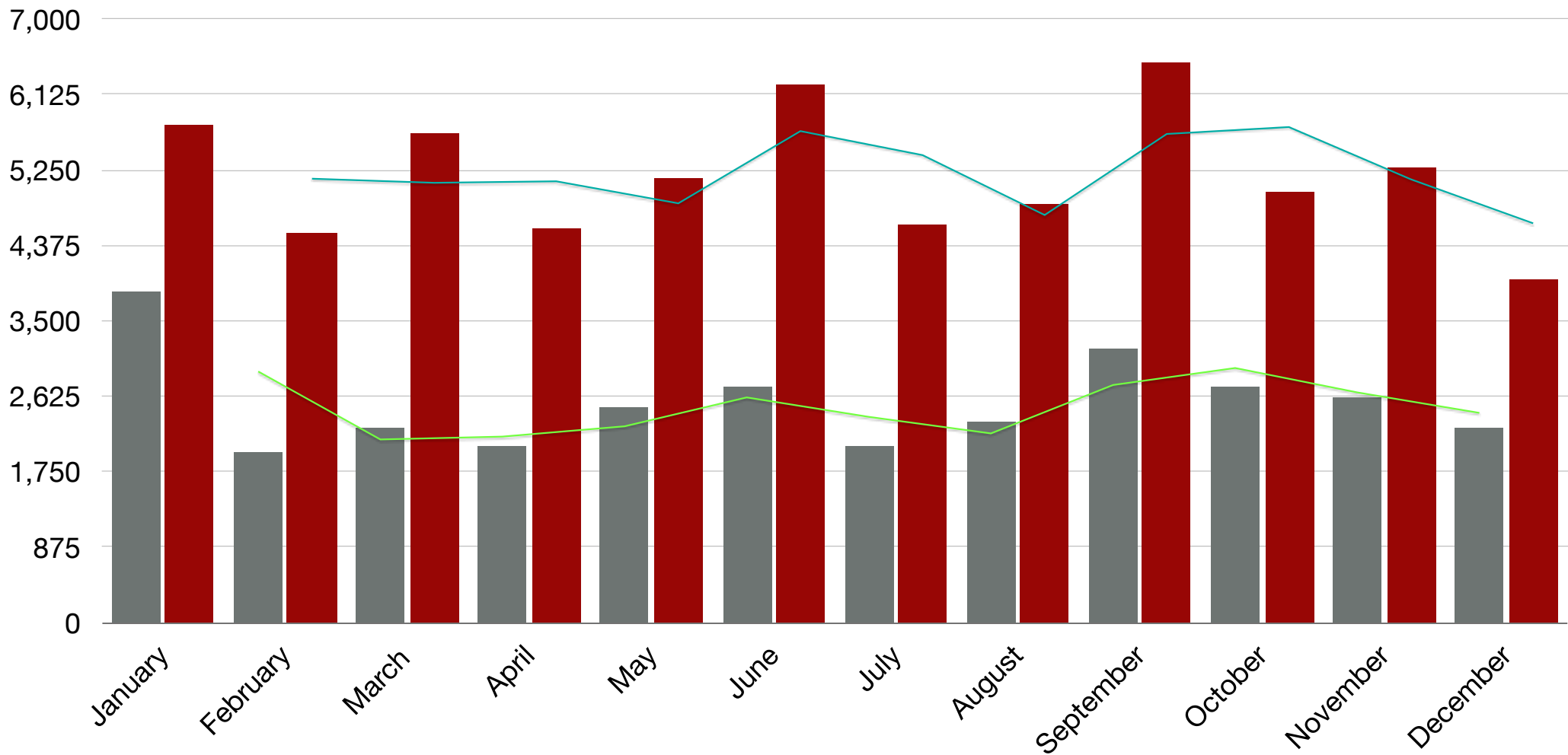


***USED Vehicles Registered in Vermont by Month, 2024***

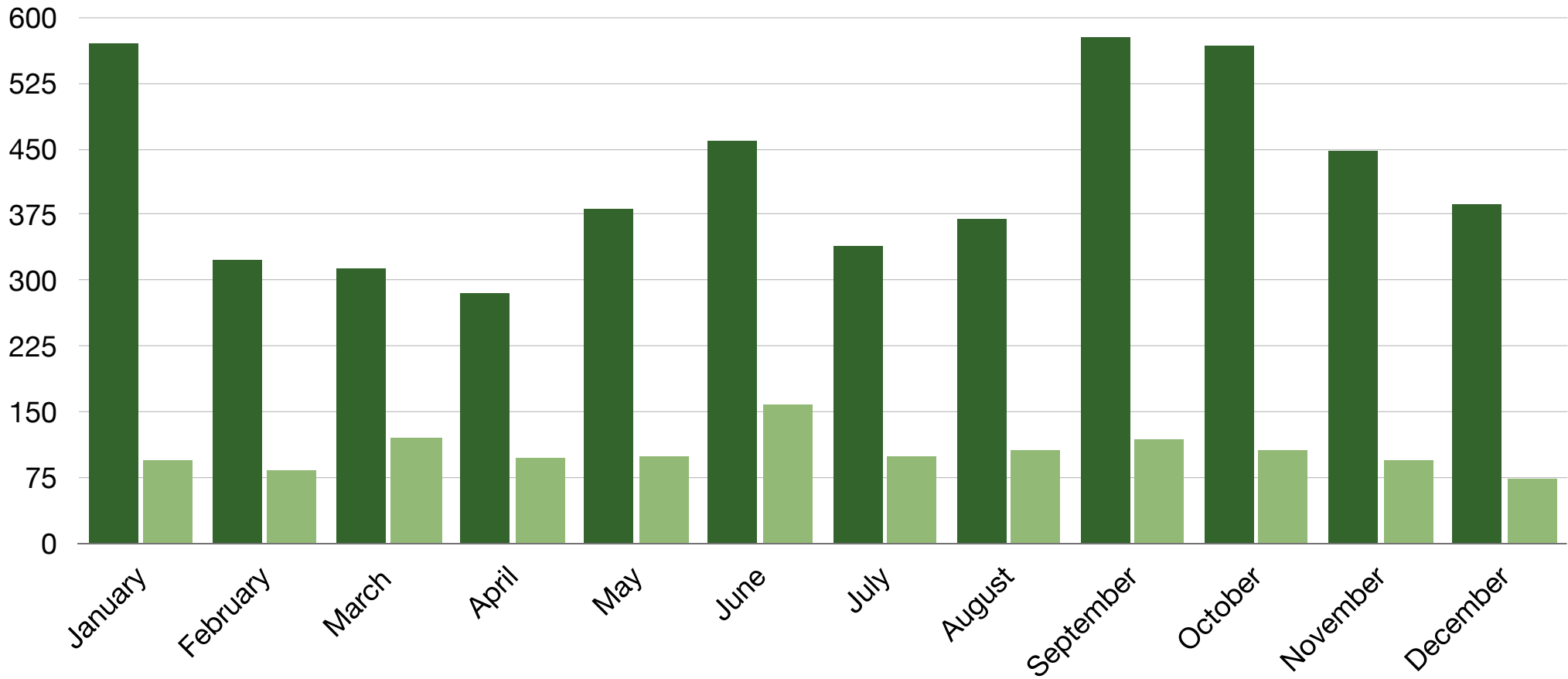

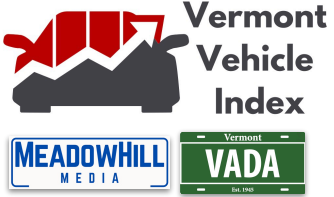

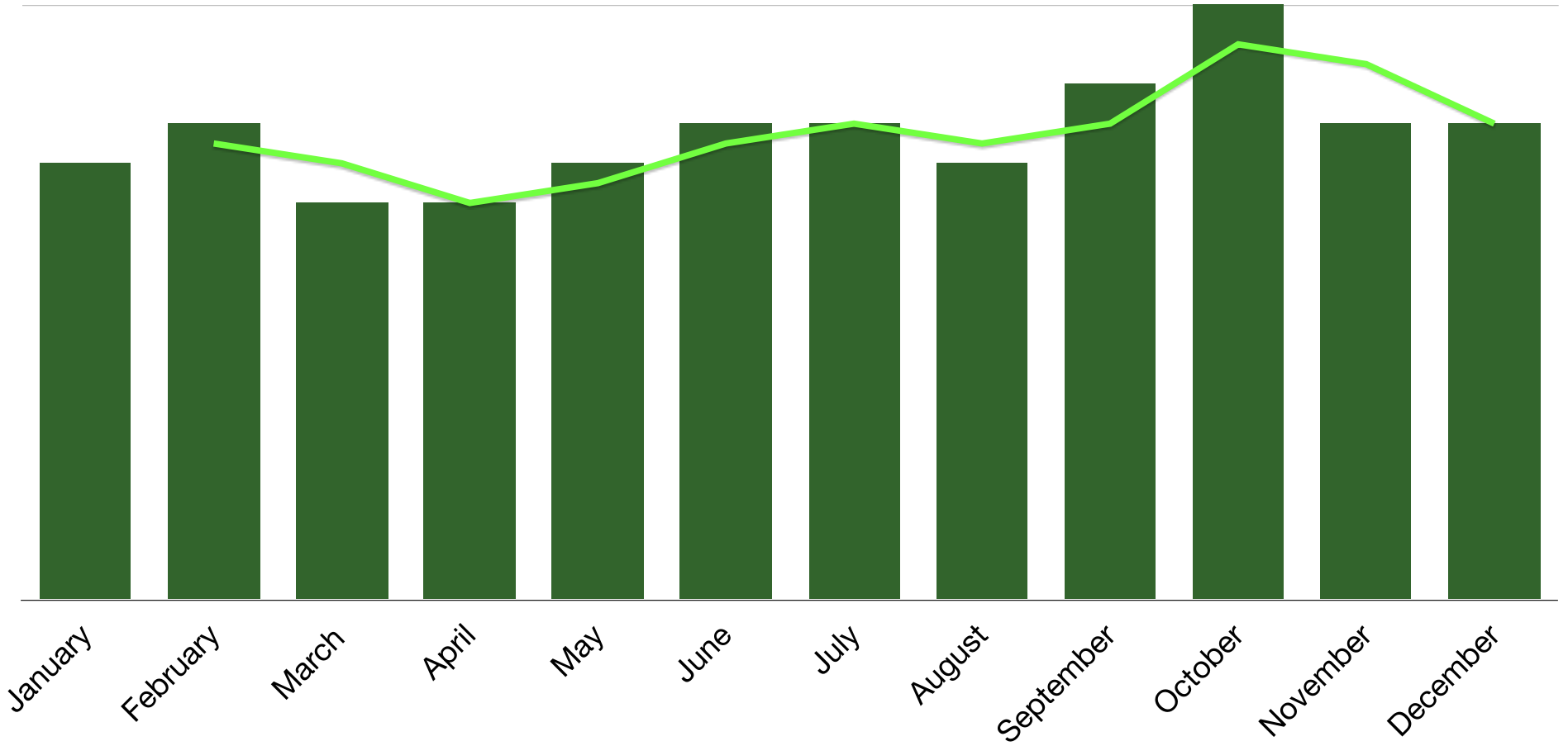
*Electric & Electric Plug In/Gas Registered in Vermont by Month, 2024*

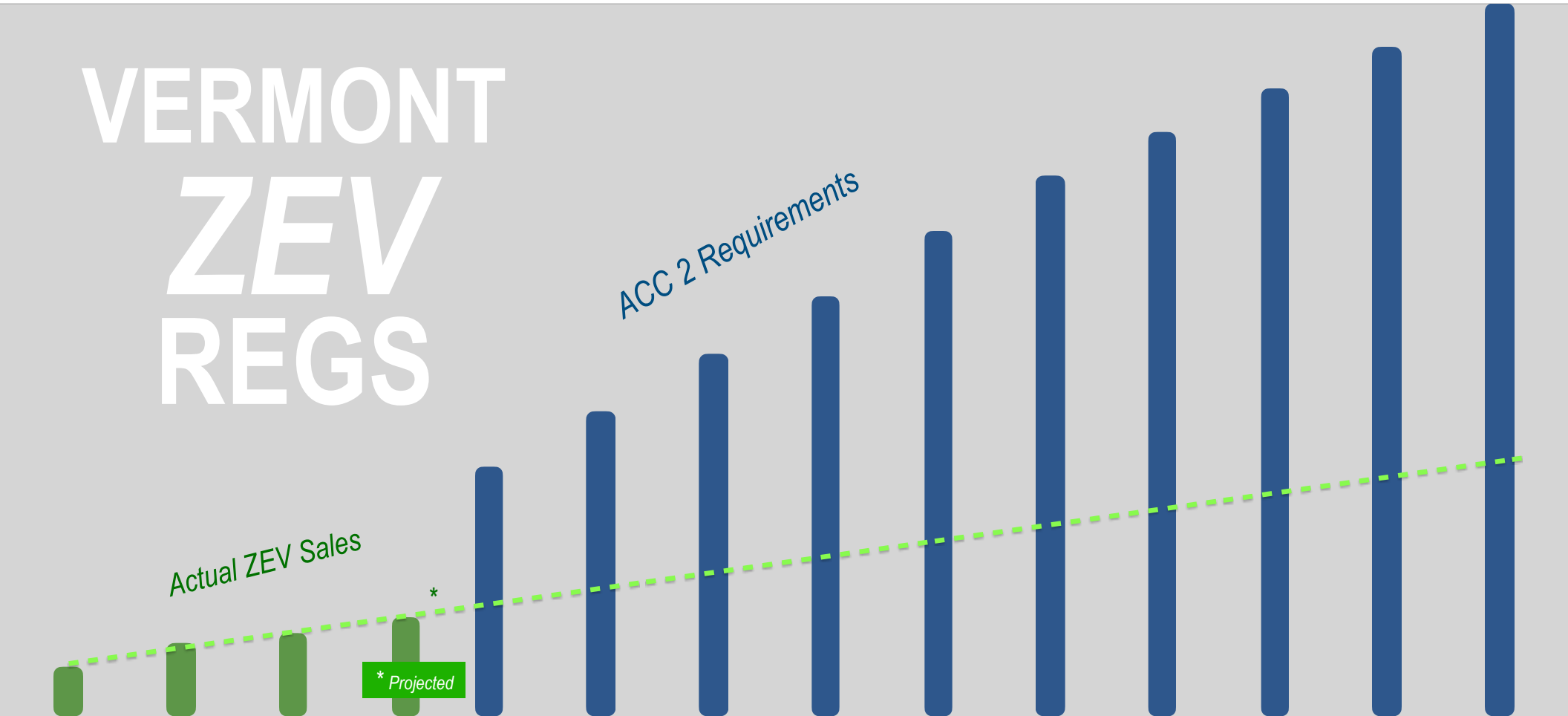
