6 Sec. 1. FINDINGS; INTENT

7 The General Assembly finds that:

8 (1) The study commissioned in 2024 titled “An Evidence-Based
9 Approach to Identifying an Adequate Education Spending Level in Vermont”
10 by Allan Odden and Lawrence O. Picus evaluated Vermont education spending
11 against research-informed best practices. The evidence-based model is
12 designed to identify an array of staffing and resources that high-performing
13 schools need to provide every student with robust opportunities to meet college
14 and career-ready standards. Performing to those standards would substantially
15 improve student achievement and reduce demographic related performance
16 gaps.

17 (2) The evidence-based model represents an adequate model for the
18 level of education funding necessary to improve student achievement. It was
19 developed by experts in education funding with more than 25 years of
20 experience across the United States in determining how to adequately fund
21 schools, meaning providing a level of resources that would enable schools to

1 provide every student with an equal opportunity to learn to high performance
2 standards. The State has a Constitutional obligation to ensure that all students
3 are provided a quality education on a reasonably equal basis, without regard to
4 town of residence. Doing so will require significant change to the current
5 system of education.

6 (3) Vermont's current funding model equalizes school district's ability
7 to raise education taxes, leveling out the distinctions in property wealth among
8 districts. The current funding system does not provide equalized education
9 dollars to districts. The choice to spend or not spend equitable amounts of
10 education funding per student across the State rests with individual districts.
11 Spending patterns demonstrate that many districts do not utilize the tax
12 equalization mechanisms to increase spending, even in the districts with the
13 most demonstrated student need.

14 (4) Vermont's current school and school district sizes do not align with
15 the Evidence-Based Model, and contribute to higher costs that are not fully
16 addressed by the Model. In order to ensure the Model can be implemented in a
17 way that improves education quality, the State must be organized into larger
18 school districts that are responsible for approximately at minimum 3,900
19 students, a population that represents the minimum to achieve efficiency in
20 delivering the Evidence-Based Model.

1 (5) Additionally, larger school districts, consistent with State-level
2 guidance for school size, average class size, and budgetary priorities, must
3 examine the appropriate number of schools for the student population,
4 geography, student need, and community desires of the school district.

5 (6) The intent of the proposed five districts is to charge school boards to
6 represent a diverse set of student and community needs to promote equitable
7 budgeting and district policies and to create central offices that provide
8 specialized resources and support for students and teachers in alignment with
9 best practices for teaching and learning.

(12) Distribute at ~~his or her~~ the Secretary's discretion upon request to approved independent schools appropriate forms and materials relating to the education quality standards for elementary and secondary students.

(13) Ensure the provision of services to children and adolescents with a severe emotional disturbance in coordination with the Departments of Mental Health, for Children and Families, and of Disabilities, Aging, and Independent Living pursuant to the provisions of 33 V.S.A. chapter 43.

(14) Annually, communicate to each superintendent a list of information that ~~a supervisory union,~~ a school board, a school district, a school, or a school

1 district employee, ~~or a supervisory union employee~~ is required under State or
2 federal law to make available to the electorate, community members, parents,
3 or students. It is the intent of this subdivision that the Secretary shall make a
4 good faith effort to compile a complete list of the information to be made
5 available. Due to the difficult nature of compiling such a list, it is also the
6 intent that failure to include relevant information on the list shall not constitute
7 grounds for an action against the Secretary.

18 (a) In order to carry out Vermont’s policy that all Vermont children will be
19 afforded educational opportunities that are substantially equal in quality, each
20 Vermont public school, including each career technical center, shall meet the
21 following education quality standards:

1 (1) The school, through a process including parents, teachers, students,
2 and community members, develops, implements, and annually updates a
3 continuous improvement plan to improve student performance within the
4 school. The plan shall include goals and objectives for improved student
5 learning and educational strategies and activities to achieve its goals. The plan
6 shall also address the effectiveness of efforts made since the previous
7 continuous improvement plan to ensure the school maintains a safe, orderly,
8 civil, and positive learning environment that is free from harassment, hazing,
9 and bullying. The school shall assess student performance under the plan
10 using a method or methods of assessment developed under subdivision 164(9)
11 of this title.

12 (2) The school, at least annually, reports student performance results to
13 community members in a format selected by the school board. In the case of a
14 regional career technical center, the community means the school districts in
15 the service region. The school report shall include:

16 (A) Information indicating progress toward meeting standards from
17 the most recent measure taken.

18 (B) [Repealed.]

19 (C) Information indicating progress toward meeting the goals of an
20 annual continuous improvement plan.

1 (D) Any other statistical information about the school or community
2 that the school board deems necessary to place student performance results in
3 context.

6 receives appropriate career counseling and program information regarding
7 availability of education and apprenticeship program offerings at career
8 technical centers.

11 data presented in a manner designed to protect student confidentiality on the
12 dropout and graduation rates.

13 (K) Data provided by the Secretary that enable a comparison with
14 other schools, or school districts if school level data are not available, for cost-
15 effectiveness. The Secretary shall establish which data are to be included
16 pursuant to this subdivision and, notwithstanding that the other elements of the
17 report are to be presented in a format selected by the school board, shall
18 develop a common format to be used by each school in presenting the data to
19 community members. The Secretary shall provide the most recent data
20 available to each school ~~no~~ not later than October 1 of each year. Data to be

presented include student-to-teacher ratio, administrator-to-student ratio,
administrator-to-teacher ratio, and cost per pupil.

(3) The school substantially meets standards adopted by rule of the ~~State~~
~~Board~~ Agency of Education regarding conditions, practices, and resources of
schools. The standards shall address those aspects of the following that are
most closely associated with improving student performance:

(A) school leadership, staffing, ~~and~~ support services, and average
minimum class sizes that shall require that for grades four through 12 average
class sizes to be equivalent to a teacher to student ratio of 1:25 and for grades
kindergarten through three shall be equivalent to a teacher to student ratio of
15:1;

(B) instructional practices and curriculum leadership, content, and
coordination;

(C) educational materials and school facilities;

(D) access to current technology.

(4) The school shall provide for and the staff shall use needs-based
professional development designed to improve the quality of education
provided to the students and directly connected to standards for student
performance established by the ~~State Board~~ Agency of Education and any
other educational performance goals established by the school board.

1 (5) The school uses staff evaluation to advance educational performance
2 objectives.

3 (6) The school ensures that students receive appropriate career
4 counseling and program information regarding the availability of education
5 and apprenticeship program offerings at career technical centers. In addition,
6 the school, if it is a secondary school, offers a genuine opportunity to access
7 career technical education programs.

8 (7) The school ensures that students are furnished educational services
9 in accordance with any State or federal entitlements and in a nondiscriminatory
10 manner.

11 (8) The school maintains a safe, orderly, civil, and positive learning
12 environment that is free from hazing, harassment, and bullying, and is based on
13 sound instructional and classroom management practices and clear discipline
14 policies that are consistently and effectively enforced.

15 (b) Annually, the Secretary shall determine whether students in each
16 Vermont public school are provided educational opportunities substantially
17 equal to those provided in other public schools. If the Secretary determines
18 that a school is not meeting the education quality standards listed in subsection
19 (a) of this section or that the school is making insufficient progress in
20 improving student performance in relation to the standards for student
21 performance set forth in subdivision 164(9) of this title, ~~he or she~~ the Secretary

1 shall describe in writing actions that a district must take in order to meet either
2 or both sets of standards and shall provide technical assistance to the school. If
3 the school fails to meet the standards or make sufficient progress within two
4 years of the determination, the Secretary shall recommend to the State Board
5 one or more of the following actions:

6 (1) the Agency continue to provide technical assistance for one more
7 cycle of review;

8 (2) the State Board adjust ~~supervisory union boundaries or~~
9 responsibilities of the superintendency pursuant to section 242 of this title;

10 (3) the Secretary assume administrative control of an individual school,
11 or school district, or supervisory union, including budgetary control to ensure
12 sound financial practices, only to the extent necessary to correct deficiencies;

1 (a) Authority. An independent school may operate and provide elementary
