17	(b) Nothing in this act shall be construed to restrict or repeal, or to
18	authorize, encourage, or contemplate the restriction or repeal of, the ability of a
19	school district that, as of the effective date of this section, provides for the
20	education of all resident students in one or more grades:

1	(1) by paying tuition on the students' behalf, to continue to provide
2	education by paying tuition on behalf of all students in the grade or grades; or
3	(2) by operating a school offering the grade or grades, to continue to
4	provide education by operating a school for all students in the grade or grades
