

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Ways and Means to which was referred House Bill No.  
3 928 entitled “An act relating to technical corrections to fish and wildlife  
4 statutes” respectfully reports that it has considered the same and recommends  
5 that the bill be amended by striking out Sec. 3, 10 V.S.A. § 4255, in its entirety  
6 and inserting in lieu thereof new Sec. 3 to read as follows:

9 (a) Vermont residents may apply for licenses on forms provided by the  
10 Commissioner. Fees for each license shall be:

12 (o) If the Board determines that it is necessary to issue or require additional  
13 big game tags or big game permits that are not otherwise identified in this  
14 section, the Department may issue such tags and permits and may assess a  
15 provisional fee for such tags and permits of not more than the lowest fee for a  
16 big game tag as provided in subsection (a) of this section. The Department  
17 shall seek legislative approval of the provisional fee pursuant to 32 V.S.A.  
18 § 603 within one year following the Department’s assessment of the fee. The  
19 Department’s failure to obtain legislative approval of the provisional fee shall  
20 void the provisional fee and the Department shall not assess a new provisional  
21 fee for the same big game tag or big game permit.
