Current Challenges



For Vermonters

- Repeated data entry across programs
- No unified application or renewal process
- Limited mobile access and language support
- Risk of coverage gaps due to confusing notices

For State Staff

- Manual, time-consuming processes
- Siloed systems and fragmented data
- High maintenance costs and compliance risk



Current System Challenges

Legacy systems are siloed, not mobile-friendly, and each with unique problems

- Human-centered design and usability testing

The Risk of Delay



- Compliance & Funding: Federal standards, recoupment risk
- Operational Fragility: Aging technology, sourcing skilled staff for legacy system support
- Technical Fragility: Complex programming hinders timely updates and responsiveness
- Service Impact: Benefit disruption, accessibility gaps

"ACCESS Mainframe risk is widely recognized – delay increases exposure"

VT-IES: Investing in People & Modern Systems

- Design & Technology: Tailored for Vermont, reuse of state technology investments
- Technical Debt Reduction: Consolidating two legacy systems into a single, modern platform
- Efficiency & Integrity: Configurable rules engine, statewide health data analytics, program integrity
- Federal Partnership: CMS/FNS co-funding, strategic validation

Timeline - Why it Takes Time

RFP Development (Jan 2022 – Sept 2024)

- 3 RFIs to gather vendor input and validate feasibility
- Federal partner collaboration with CMS and FNS



RFP posting, scoring, demos, contracting, federal and state reviews

Design, Development, Implementation (2026 – 2030):

Phased delivery over 3-4 years with early wins
