The Committee reviewed the following rules:

24-P35 - Licensing and Operating Regulations for Therapeutic Community Residences.

The proposed rule amendment adopts provisions necessary to authorize the use of emergency involuntary procedures, including the administration of involuntary medication, at a secure residential facility pursuant to 2024 Acts and Resolves No. 137.

On motion of Rep. Squirrell, the Committee voted to postpone action until January 30, 2025.

24-E08 - General Assistance Emergency Housing Assistance Emergency Rules.

Heidi Moreau, Policy Analyst, Department for Children and Families, explained the rule and answered questions from the Committee. Brenda Siegel, Executive Director, End Homelessness Vermont, and Leah Burdick, Staff Attorney, Elder Law Project, also testified on the rule.

The emergency rule extends the General Assistance Emergency Housing Assistance Emergency Rules.

On motion of Senator Lyons, the Committee voted to neither approve nor object to the proposed emergency rules.

<u>24-P42 - General Assistance Emergency Housing Assistance Rules.</u> Heidi Moreau, Policy Analyst, Department for Children and Families, explained the rule and answered questions from the Committee. Brenda Siegel, Executive Director, End Homelessness Vermont; Leah Burdick, Staff Attorney, Elder Law Project; and Katie McLinn from the Office of Legislative Counsel also testified on the rule.

This rule amends the General Assistance Program Emergency Housing Assistance Rules.

On motion of Rep. Squirrell, the Committee voted to postpone action on this rule until January 30, 2025.

<u>24-P20 - Agency of Human Services/Agency Designation - Adoption Deadline Extension</u>
<u>Request.</u> Ashley Johns, Staff Attorney, Agency of Human Services, explained the request and answered questions from the Committee.

On motion of Rep. Bongartz, the Committee approved the extension of the adoption deadline to March 31, 2025.

24-P21 - Recovery Services Organization Certification Rule - Adoption Deadline Extension Request. Natalie Weill, Public Health Policy Advisor, explained the request and answered questions from the Committee.

On motion of Rep. Bongartz, the Committee approved the extension of the adoption deadline to March 7, 2025.
