
### Base Budget

#### FY 2027 SUMMARY & HIGHLIGHTS

**MISSION:** Facilitate, support and encourage the growth and viability of agriculture while protecting the working landscape, human health, animal health, plant health, consumers and the environment.

**VISION:** Help develop a safe, secure, ecologically responsive, profitable and fair local foods system for Vermont and Vermont customers which will enable Vermont to be a leader and participant in the global food system. The Agency will do this by assuming a leadership position important to the evolving food system, through access to and the application of resources (human, financial, social and environmental) and by supporting the creation of new opportunities.

## Flow of Funds

## AAFM FY 27 Budget

- **General Fund** – 22% of base budget. Our General Fund is appropriated each year, typically with a modest increase, for internal services/benefits and other expenditures that are not eligible for federal funding.
- **Federal Funds** – 33% of base budget. The Agency receives funds from multiple federal agencies to complete work locally, that expands their bandwidth. Our federal funds come through USDA, FDA, and EPA.

**Federal Grant and/or Federal Designation**  **State Department of Agriculture**

- **Special Funds** – 40% of base budget. The Agency is charged with collecting a variety of fees for licenses and registrations. The revenue received from the fees is used as part of our base budget and supports staff and operations. Example: Pesticide registration fees are used to support pesticide enforcement and lab work.

**Registration/License Fees**  **Attributed to Base Budget**

- **Interdepartmental Transfer Funds** – 5% of base budget. Funding that is transferred from another Agency or Department to assist with their work. Example: Funding from the Department of Labor for farmworker housing inspections.

**Memorandum of Understanding (MOU) with another Agency/Department**  **Attributed to Base Budget**

► **The Agency is comprised of six appropriations**

- Administration (Admin)
- Food Safety & Consumer Protection (FSCP)
- Agricultural Development (Ag. Dev)
- Plant Industry (PI)
- Vermont Agricultural and Environmental Laboratory (VAEL)
- Agricultural Water Quality (WQ)

► **The Agency budget maintains staffing & operations to ensure main areas of focus**

- Jobs – Agricultural Development, New Businesses and Markets, Fair Marketplace
- Water Quality
- Regulation of feed, seed, fertilizer, and pesticides
- Food Safety Consumer Protection – Food Safety Modernization Act, Animal Health, Dairy, Meat & Weights and Measures

► **Internal service costs such as Fee for Space, Insurances, VISION, etc., are allocated throughout the Agency, generally based on number of positions**

### **Crosswalk Overview – Ag Development – B.224**

- The Ag Development Division has seen standard increases to salaries and benefits.
- Local Food Systems in Schools - reduction of \$300K due to USDA rescinding this grant on 3/7/25
- Resilient Food Systems Infrastructure (RFSI) – \$1.5 million – one-time cooperative agreement
- Local Food Purchase Assistance - reduction of \$500K due to USDA rescinding this grant on 3/7/25
- Farm to School reduction of \$30K – Vermont Dairy Promotion Council funding ended.

Established as part of the 2018 Farm Bill, the DBII was created to support dairy businesses in the development, production, marketing, and distribution of dairy products. All DBI funding is allocated in the Farm Bill and comes through the USDA Agricultural Marketing Service.

**Amount awarded to NE-DBIC for projects extending through 2027.\***

The NE-DBIC prioritizes using funds as grants to dairy businesses. Past and current projects include farm modernization, processor expansion, food safety improvements, access to technical assistance, and marketing and branding services.

\*Previously, we reported that we'd received \$53 million. This was adjusted in July 2025, when the funding awarded for the Organic Dairy Product Promotion Grant was cancelled by the USDA. Congressionally approved funding through the Farm Bill remains, allowing our core grant programs to continue moving forward.


