

Please Support S.60, the Farm & Forestry Operations Security Special Fund Bill



Funding for Farmers & Loggers in the Wake of Extreme Weather

Farms and forestry operations across the state have come together to ask the legislature to establish a Farm & Forestry Operations Security Fund to ensure farmers and loggers have financial assistance they need to recover from the impacts of extreme weather. The Farm & Forestry Operations Security Special Fund (S.60) passed unanimously out of both the Senate and the House Agriculture, Food Resiliency & Forestry Committee in 2025. Grants from the fund will reimburse a farm or logging operation for up to 50% of uninsured or otherwise uncovered losses, up to \$150,000, or no more than 5% of the funds available at the start of the fiscal year. The fund would be administered by the Vermont Agency of Agriculture, Food & Markets in collaboration with a review board.



Why This, Why Now

A storm, frost, or drought at the wrong time can devastate a farm or forestry business. We all rely on farmers and loggers for our basic needs, and we are all responsible for supporting them as they face increased climate instability. It's time to start adapting to the climate crisis and ensuring our farms and loggers can continue producing the food and forest products we need.
