H.218 – An act relating to fiscal year 2026 appropriations from the Opioid Abatement Special Fund

As Passed by the House of Representatives¹

Bill Summary

The bill proposes to appropriate \$9,888,210 from the Opioid Abatement Special Fund for use in fiscal year 2026. Below is a summary of proposed appropriations.

All grant agreements associated with funds appropriated above would require outcome and measurement data to be collected and reported to the department issuing the grant and to the Opioid Settlement Advisory Committee.

The fund is estimated to have \$2.16 million left unappropriated before receiving the next allocation. The following chart shows the estimated allocations to the Opioid Abatement Special Fund based on all current settlements, except for the Sackler/Purdue settlement which is currently going through bankruptcy and court approval processes. More information on final payouts from the settlement are not anticipated to be known until fall 2025.
