# H.219 – An act relating to establishing the Department of Corrections' Family Support Program

As passed by the House of Representatives<sup>1,i</sup>

### **Bill Summary**

his bill would require the Department of Corrections (DOC) to establish the Family Support Program, which would provide free parenting and family support services to incarcerated parents and guardians in Vermont correctional facilities. It instructs DOC to implement the Program via a phased approach, beginning with the Chittenden Regional and Northern State Correctional Facilities before expanding the program statewide, contingent on additional appropriations, with the intent of expanding to all Vermont correctional facilities by 2028.

As recommended by the House Committees on Appropriations and on Corrections and Institutions, H.219 was previously titled "an act relating to creating a family support pilot program for incarcerated parents and guardians." Upon passage by the House of Representatives, the title of the bill was amended to read "an act relating to establishing the Department of Corrections' Family Support Program"

#### **Fiscal Impact**

As originally recommended by the House Committee on Corrections and Institutions, this bill appropriated \$383,579 from the General Fund to DOC in fiscal year 2026 to implement the Family Support Program at the Chittenden Regional and Northern State Correctional Facilities. The House Committee on Appropriations recommended deleting the appropriation from the bill, as DOC identified fiscal year 2026 base funding for this purpose. The bill as passed by the House does not include an appropriation.

The bill directs DOC to develop a plan to expand this program to all Vermont correctional facilities by 2028 and to propose ongoing funding for trauma-informed family support services in future budget proposals submitted to the General Assembly in accordance with 32 V.S.A. § 306. While the bill does not contain an appropriation to fund this requirement, it could increase future costs, depending on the amount of funds proposed and the extent to which these budget proposals are enacted in future years.

### **Background and Details**

The following sections of the bill have a fiscal impact.

#### **Sections 1-3: Establishing the Family Support Program**

Section 1 expresses legislative intent that DOC develop a phased plan to establish a statewide Family Support Program for all Vermont correctional facilities by 2028.

Section 2 requires the Commissioner to include funding to sufficiently provide and sustain trauma-informed family support services in all future DOC budget proposals submitted to the General Assembly pursuant to 32 V.S.A. § 306.

Section 3 directs DOC to establish the Family Support Program, outlines the required elements of the Program, states that its implementation is contingent on funds appropriated for its operation, and requires DOC to report annually on the implementation of this bill's requirements to the House Committees on Corrections and Institutions and on Judiciary, and the Senate Committees on Institutions and on Judiciary.
