**Sec. XX 2024 Acts and Resolves No.78, Sec. B.1100 (g)(1), as amended by 2026 Acts and Resolves No. 27, Sec. E221(b) is further amended to read:**

1. ~~\$1,200,000~~ \$1,500,000 for three years' financial support of a three-phase accreditation process to include Job Task Analysis, Curriculum Development and Piloting.

**EXPLANATION:**

Provides an additional \$300,000 from the General Fund for the Criminal Justice Council to complete the contract work of a full curriculum review and development for all police academy training by IADLEST (International Association of Directors of Law Enforcement Standards and Training). The contract was reduced from \$1,800,000 to the actual cost of \$1,500,000 and is more than halfway completed.
