

2023-2024 GRADUATES





VSC Budget Distribution

- Ongoing general fund appropriation was 26% of VSC revenues in FY24 compared to 17% in FY20
- General fund appropriation has increased 68% since FY20 from \$30.5M to its current \$50.9M
- 57% of all VSC spending goes toward personnel as compared to 63% in FY20
- Total spending on personnel is down 9% annually since FY20
