2 Senator Perchlik of Marshfield moves that the bill be amended as follows:

3 First: In Sec. B.1100, fiscal year 2026 one-time appropriations, by striking
4 out subdivision (n) in its entirety and inserting in lieu thereof a new
5 subdivision (n) to read as follows:

6 (n) Department of Housing and Community Development. In fiscal year
7 2026, funds are appropriated for the following:

8 (1) \$9,100,000 General Fund for the Vermont Bond Bank Vermont
9 Infrastructure Sustainability Fund;

10 (2) \$14,500,000 General Fund for the Vermont Housing Finance
11 Agency Rental Revolving Loan Fund, the Middle-Income Homeownership
12 Development Program, and the First Generation Homebuyer Program. Up to
13 \$1,000,000 of these funds may be for the First Generation Homebuyer
14 Program;

15 (3) \$4,300,000 General Fund for the Vermont Housing Improvement
16 Program 2.0 and for staff to support the Program; and

17 (4) \$15,000 General Fund for the Residential Universal Design Study
18 Committee.

19 Second: In Sec. D.101, fund transfers, following subdivision (a)(1)(H) by
20 inserting a new subdivision (a)(1)(I) to read as follows:

21 (I) Farm Security Special Fund: \$1,000,000.

1 Third: In Sec. D.102, reversions, by striking out “\$5,000,000.00” and
2 inserting in lieu thereof “\$6,000,000.00”

3 Fourth: In Sec. E.100, positions, by striking it out in its entirety and
4 inserting in lieu thereof a new Sec. E.100 to read as follows:

2 (B) Office of the Attorney General:

3 (i) one Assistant Attorney General.

4 (C) Department of State’s Attorneys and Sheriffs:

5 (i) one Financial and IT Specialist; and

6 (ii) two Transport Deputies.

7 (b) The establishment of four permanent positions to be established through
8 existing vacant positions is authorized in fiscal year 2026 for the following:

9 (1) Permanent classified positions:

10 (A) Criminal Justice Council:

11 (i) one Canine Head Trainer.

12 (B) Cannabis Control Board:

13 (i) one Compliance and Enforcement Attorney.

14 (2) Permanent exempt positions:

15 (A) Human Rights Commission:

16 (i) one Intake Specialist; and

17 (ii) one Staff Attorney Investigator.

18 (c) The establishment of one limited service position is authorized in fiscal
19 year 2026:

20 (1) Office of the State Treasurer:

21 (A) one Climate Superfund Specialist.

1 (d) The conversion of 11 limited service positions to permanent exempt
2 status is authorized in fiscal year 2026 as follows:

3 (1) Land Use Review Board:

4 (A) two District Coordinators.

5 (2) Department of State’s Attorneys and Sheriffs:

6 (A) six Deputy State’s Attorneys;

7 (B) two Legal Assistants; and

8 (C) one Victim Advocate.
