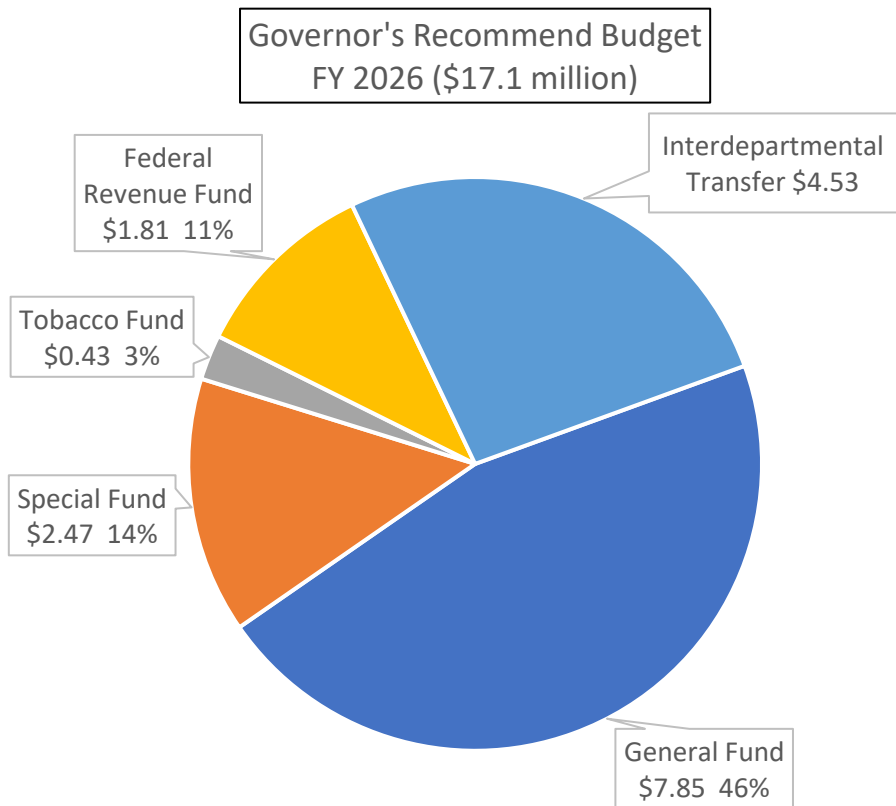

# FY 2026 SUMMARY & OFFICE COMPILATION

**MISSION:** To use our authority and expertise as the State of Vermont's independent law office to represent state government, protect the public interest and the environment, and enforce the law with equal right and justice to all.



- \$453,579, 6.1% GF increase over FY 2025
- 147 Positions Managed Statewide

## What's Happening?

- Continued pursuit of enforcement actions related to:
  - Exxon and similar petroleum companies for concealing information and disseminating misleading statements about fossil fuels and climate change;
  - Manufacturers of PFAS and related chemicals for contaminating Vermont;
  - Opioid marketers and others responsible for the opioid crisis;
  - Meta for Instagram's harm to teens' mental health and TikTok for their similarly harmful platform, including unregulated money transfers;
  - Monsanto for producing, marketing and selling harmful PCB toxic chemicals and causing damage to Vermont's natural resources and schools;
  - CVS, Express Scripts and other pharmacy benefit managers (PBMs) for unfairly driving up prescription drug costs and misrepresenting their pricing formulations; and
  - Vaping and online illegal sales of tobacco.
- Secured jury conviction in aggravated sexual assault of a child, now awaiting sentencing.
- Defending laws passed by Vermont Legislature including Vermont's: large-capacity magazine ban and waiting period, climate superfund, and crisis pregnancy centers.
- General counseling to state agencies including contract review and guidance on rapidly changing law.
- Continuing to lead on privacy and data security, including enforcing Vermont's data breach laws, protecting Vermonters through education about data privacy, and ensuring compliance with the first-in-the-nation data broker registry.

➤ **\$181,000 – BASE FUNDING FOR APPELLATE UNIT ASSISTANT ATTORNEY GENERAL**

Position requested in FY 2025 BAA

➤ **\$181,000 – CREATION & BASE FUNDING FOR “BIG TECH” ASSISTANT ATTORNEY GENERAL**

As demonstrated with lawsuits against technology giants such as Blackbaud, Meta, Amazon, Google, etc., Attorney General Clark is unwilling to accept the Consumer Protection Act violations Vermonters face every day online. In addition to protecting Vermonters, this position will bring in money, in excess of its cost, to the State.

➤ **\$119,300 – BASE FUNDING FOR PRE-CHARGE ADMINISTRATOR POSITION**

Position requested in FY 2025 BAA

➤ **\$79,000 – CONVERSION & BASE FUNDING FOR HOME IMPROVEMENT SPECIALIST POSITION**

Home Improvement Specialist – This limited-service position was created by the Legislature in Act 182 (2022) for a period of two years. Since filling the position in July 2023, through October 2024, the Consumer Assistance Program has received 266 home improvement complaints. Of those complaints, 89 have been resolved resulting in recovery and/or savings of over \$687,000 to Vermonters. The one-time funding for this position will be exhausted at the end of FY 2025.

## Programmatic Performance Measure Report Consumer Assistance Program

Program Description: The Consumer Assistance Program (CAP), a partnership with the University of Vermont, is Vermont’s designated office for the reporting of scams and other consumer complaints. CAP makes referrals and uses a letter mediation process to resolve consumer complaints. CAP also provides outreach and education to Vermont consumers.

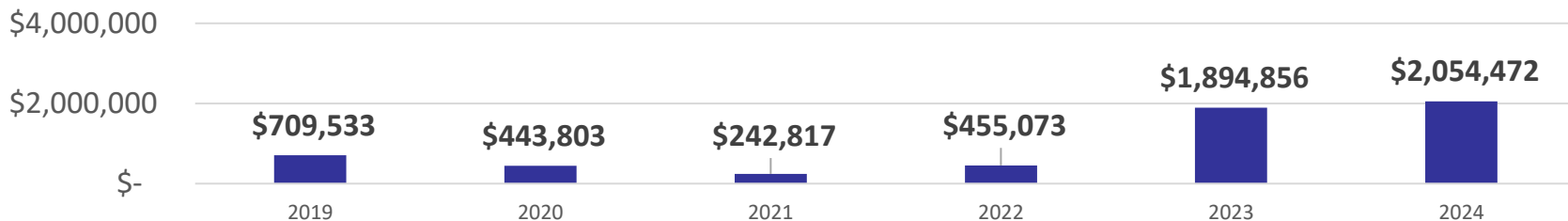
- These measures can be tricky in that many complaints do not involve a financial recovery. An example would be a constituent who needs propane delivered or a consumer who was scammed and needs advice about identity theft.
- The third measure – “average constituent recovery per resolved complaint” – is not a perfect one in that, as mentioned above, many resolutions do not involve a financial recovery.

#### NOTES:

- \* Recoveries and savings are under review as we prepare the CAP Annual Report.
- \* Savings example: A Vermont consumer received a \$20,000 phone bill from a major carrier – CAP was able to get the business to drop it. Not a recovery, but a huge relief to the consumer who was stressed and anxious about the prospect of that amount of debt due to a billing error that the consumer was unable to resolve on their own.

## Enforcement Settlements

### COMMON POINTS OF CONFUSION:

- Settlement announcements generally encompass the entire settlement amount, not just the state share (if any), and not necessarily the payment terms.
- Some settlement agreements have extended payment plans. Others are paid in a lump sum. Still others do not result in any deposit to the State but protect and, in some cases, reimburse Vermonters.
- Settlement agreement terms often become public before funds are actually received.

The table above reflects all the AGO's actual collection of settlement dollars into the AG-Fees & Reimbursements-Court Order fund (this does **not** include tobacco, opioid or Medicaid fraud, **nor** does it reflect settlement announcements).

The AGO's base budget includes \$1,802,200 of these revenues annually. Receipts then replenish the Complex Litigation special fund. Receipts exceeding these needs are distributed via Big Bill language, usually as a direct app to the General Fund.

## Medicaid Fraud & Residential Abuse Unit (MFRAU) Settlements

Multi-State Global: Settlements, which include Medicaid damages, and additional penalties and recoveries,\* are typically paid in one lump sum.

Vermont Civil: Settlements are on a case-by-case basis and may include additional penalties and recoveries.\*

Vermont Criminal: Criminal cases with Restitution Orders only include Medicaid damages. There are no additional penalties or recoveries. MFRAU does not receive any of the restitutions paid in criminal cases.

\*Revenue Sharing – Per the MOU with DVHA, all additional penalties and recoveries, less any relator (private party who initiates the suit) fees, are split 50/50.

Any instance of the MFRAU receiving funds is strictly related to additional penalties and recoveries without any sacrifice to restitution owed to the State.

### MISSION STATEMENT

Programs within Court Diversion share a common goal of diverting offenders out of the standard judicial system to community-based providers where they are held accountable, respond to the needs of victims, and address underlying reasons for their actions. The programs are Court Diversion, Youth Substance Awareness Safety Program (YSASP), and the DLS (Driver License Suspension) Program.

Pretrial Services' goal is to address defendants' substance use and mental health treatment needs and thereby limit future adverse involvement with the criminal justice system. Pretrial Services encompass risk assessment and needs screening, court-ordered pretrial services, and the Tamarack Program.

## Funding Requested in Addition to Governor's Recommend

### ➤ **\$1,696,177 – GRANTS TO IMPLEMENT PRE-CHARGE SERVICES STATEWIDE – ACT 180 (2024):**

This figure is based on information supplied by providers and State's Attorneys throughout the State, as well as FY 2024 statistics related to the pre-charge program funded by the Department of Corrections through FY 2025.

#### *CALCULATION METHODOLOGY:*

- \$1,105,989 – Continued funding of existing pre-charge services. Calculated as a portion of the FY 2024 DOC base grants to eight organizations which have significant pre-charge referrals. Some of these organizations are not current AGO grantees. The pre-charge referrals to these organizations range from 25% to 89% of all referrals based on the three-year average of DOC data. The respective percentage was used to calculate the “pre-charge” portion of DOC funding plus a 6% inflationary increase over FY 2024 base funding.
- \$590,188 – Funding to expand pre-charge services statewide. There are eight organizations that currently provide no or minimal pre-charge services. All these organizations provide post-charge Diversion and are current AGO grantees. This amount is the estimated funding needed for additional FTE per organization.

## VERMONT OFFICE OF THE ATTORNEY GENERAL

**VISION:** A Vermont where the public interest and the natural environment are protected by a just and effective state government.

**MISSION:** To use our authority and expertise as the State of Vermont's independent law office to represent state government, protect the public interest and the environment, and enforce the law with equal right and justice to all.

The Attorney General's Office (AGO) is comprised of 148 positions, including 99 Assistant Attorneys General (AAGs), that serve across six divisions. The AGO payroll consists of 92 of these 148 positions, with the remaining 56 positions, AAGs and staff, embedded within seven partner agencies covering at least a dozen departments, including most Agency of Human Services (AHS) departments.

### ADMINISTRATION DIVISION

Office administration, policy, and oversight of litigation is directed by the Attorney General through the Deputy Attorney General, Chief Assistant Attorney General, Chief of Staff, and Director of Policy and Legislative Affairs, together with the Division Chiefs and the Solicitor General. Overall budget and financial administration are handled by the Office's Fiscal Director and two business office positions. The IT Manager provides training and technology services. The Attorney General is supported by an Outreach and Communications Coordinator and an Administrative Services Coordinator who serves as the Office's front desk. The above positions represent the Administration Division.

*POLICY AND ADVISORY WORK* - The AGO engages in supportive policy and advisory work for several state-wide initiatives. For example, the AGO supports the Mental Health Crisis Response Commission (MHCRC), created by Act 45 of 2017. The Commission is responsible for investigating law enforcement encounters with individuals suffering from mental health crises wherein the encounter led to the death or serious bodily injury of the individual in crisis. The MHCRC then provides recommendations to the Legislature for how to improve mental health services and law enforcement responses to individuals in crisis. The AGO also chairs the Domestic Violence Fatality Review Commission, created in 2002 (15 V.S.A. § 1140). That Commission reviews and analyzes fatalities related to domestic violence and makes recommendations to the Governor and Legislature to reduce fatalities related to domestic violence.

The AGO is also involved in leading and supporting racial justice initiatives. These include helping to revise the state's model Fair and Impartial Policing Policy with the Vermont Criminal Justice Council; administering and actively participating on the Racial Disparities in the Criminal and Juvenile Justice System Advisory Panel; and serving on the Vermont Judiciary's Commission on Diversity, Equity, and Inclusion.

In addition, the AGO serves on the Vermont Criminal Justice Council, which oversees the certification, training, and decertification of law enforcement officers and which drafts and monitors the implementation of policies and standards for all law enforcement officers.

### ENVIRONMENTAL AND PUBLIC PROTECTION DIVISION

The Environmental and Public Protection Division is comprised of four units: (1) Consumer Protection, Antitrust, and Tobacco (Consumer Protection Unit); (2) Consumer Assistance Program; (3) Civil Rights; and (4) Environmental Protection.

The *CONSUMER PROTECTION UNIT* (CPU) investigates and enforces Vermont's Consumer Protection Act prohibiting unfair or deceptive practices, and other similar laws, including those related to data privacy. In addition, the *TOBACCO GROUP* within CPU enforces the 1998 Tobacco Master Settlement Agreement (MSA) and Vermont's tobacco statutes, including laws that prohibit the sale of certain tobacco products over the internet and laws

that require all cigarettes sold in the state to meet reduced ignition standards. In SFY2024 Vermont received an annual tobacco payment of approximately \$24,885,098 pursuant to the MSA. The ANTITRUST GROUP of the CPU investigates and prosecutes anti-competitive business practices such as attempts to monopolize, price-fixing, and market allocation agreements. It continues to participate in matters related to alleged attempts by drug manufacturers to bar competition. It has joined major multi-state litigation involving Apple, Amazon and Live Nation. It also reviews national and local mergers and acquisitions, monitors Vermont's health care system, and works with the Office of Professional Regulation and other agencies on anti-trust law issues.

The CPU is a leader on health, technology, privacy and data security (including enforcing Vermont's data breach notification and data broker registry laws). Some CPU highlights include:

- In October 2024, the CPU filed a lawsuit against TikTok to protect young Vermonters from the mental health and related harms associated with excessive TikTok usage.
- The CPU continues its lawsuit against Meta, filed in 2023, having prevailed against Meta's motion to dismiss, to protect young people from Instagram's addictive algorithms.
- In July 2024, the CPU filed a lawsuit against pharmacy benefit managers (such as CVS and ExpressScript) for illegally driving up prescription drug prices (such as insulin).
- In June 2024, the CPU settled (as part of a multistate lawsuit) with Johnson & Johnson for using talc-containing asbestos products, resulting in \$3.1 million dollars paid to Vermont over four years.

The CPU continues to pursue justice on behalf of Vermonters affected by opioid use disorder, including through settlements with opioid manufacturers and distributors. Between July 2023 and November 2024, CPU's efforts resulted in Vermont receiving approximately \$20,045,765 from manufacturers, distributors, and marketers of opioids. In most of these matters, funds are split among the State [15%], the State Opioid Abatement Fund [70%], and Vermont subdivisions (municipalities and counties) [15%]. Of these settlements, \$4,023,014 was marked for State payments, with the remaining \$16,022,751 going to abatement.

- The CPU enforces our consumer laws against vaping (and tobacco) manufacturers and distributors to Vermont, including Vermont's online sales ban. In October 2024, the Unit settled with Amazon for allowing third parties to sell illegal vaping products on the Amazon platform, resulting in a \$400,000 payment to the State.
- This year will also bring in another annual payment from JUUL as a result of a 2022 consent judgment, part of a 5-year payment structure that began last year.

In sum, from July 2023 to November 2024, the CPU settled or litigated 16 cases resulting in recoveries of approximately \$10,319,929 to the State and included restitution to consumers where appropriate (this excludes the Opioids and MSA tobacco settlements). Some of the amounts are still pending and will be paid over future installments; and some were reserved for restitution/other state agencies. The cases involved a wide variety of consumer topics, such as lending practices, mobile phone usage, mortgage payments, data breaches, online vaping/tobacco sales, payment processing, and others.

The *CONSUMER ASSISTANCE PROGRAM* (CAP) is located on the University of Vermont campus in Burlington. CAP assists Vermont consumers with questions, referrals, complaint letter mediation and scam prevention strategies/identity theft recovery education. CAP handled nearly 9,000 constituent contacts in SFY2024. CAP staff review trends and monitor complaints for investigation by the CPU and provide information to the Legislature.

CAP has redesigned and reinvigorated its processes to be more responsive to consumers and attempt to resolve matters that come to it *within 90 days*. CAP's Home Improvement Specialist continues to resolve homeowner disputes with residential contractors resulting in recovery and/or savings of over \$687,000 to Vermonters since July 2023, along with developing guidance for consumers on how to avoid common

problems and pitfalls. Along with our Small Business Advocate, we now have experts assisting key aspects of consumer complaints to bring resources and solutions to bear in discrete problem areas.

\*\*The result of these reforms has yielded record restitution for Vermonters in calendar year 2024; we anticipate more than \$2 million in recoveries and savings for Vermonters.

The *CIVIL RIGHTS UNIT* (CRU) enforces laws that: (1) ensure fair employment practices, including reasonable accommodation for disabled workers, protection for nursing mothers, parental and family leave, National Guard leave, and workers who request flexible work; (2) protect Vermonters from discrimination and harassment in the workplace; and (3) protect victims of hate crimes. In addition, the CRU collaborates with other units within the AGO on a range of other civil rights issues affecting Vermonters at the local or national level, including immigration policy, racial justice, sex discrimination and/or gender and LGBTQIA+ equity issues, and restorative justice.

The CRU continues to monitor a five-year consent decree (entered in July 2022) requiring Vermont's largest operator of fast-food restaurant franchises to substantially reform its practices and protect employees from harassment and retaliation. The consent decree arose out of a 2021 sexual harassment lawsuit that the CRU joined along with the Equal Employment Opportunity Commission (EEOC) and private counsel that resulted in the largest public sexual harassment settlement in the history of the AGO and one of the largest reported employment discrimination settlements in Vermont. In addition, the CRU entered and continues to monitor several other Assurances of Discontinuance with private employers regarding changes to their policies and procedures around employment discrimination, harassment, and retaliation.

The CRU produces informational materials and conducts regular outreach with a wide range of stakeholders, including trade groups, educational institutions, civil rights advocates, immigrant support organizations, and youth entering the workforce. The CRU also hosts a Bias Incident Reporting System (BIRS) with appropriate referrals to law enforcement agencies for investigation and follow-up as necessary.

Between January 2024 and November 2024, the CRU:

- Responded to 525 inquiries about Vermont's civil rights laws;
- Opened 221 new employment discrimination investigations based on complaints from members of the public;
- Served 76 administrative complaints (charges of discrimination) on employers for further investigation;
- Resolved 73 complaints of employment discrimination prior to issuing an administrative charge of discrimination;
- Resolved 87 complaints of employment discrimination after issuance of an administrative complaint (charge of discrimination);
- Transferred 9 complaints of employment discrimination to the EEOC prior to issuing an administrative charge of discrimination;
- Sent 36 administrative complaints to CRU's voluntary mediation program, where 15 resolved through that process (11 of the 36 are pending and have not yet mediated)
- Obtained \$511,254 in settlement money to complainants, including \$435,771.40 through CRU's voluntary mediation program; and

➤ Opened 30 files to review hate crimes or non-criminal bias incidents occurring in Vermont communities.

The *ENVIRONMENTAL PROTECTION UNIT* litigates cases of statewide and national importance across a wide range of subject areas including water quality, toxic and contaminated sites, air quality and climate, forests, agriculture, and land use. The Unit also provides counsel as needed to agency clients, and one AAG is specifically assigned to the Agency of Agriculture, Food and Markets. The Unit also works on legislative matters for the Attorney General.

On the litigation front, the Unit files actions to enforce Vermont's environmental laws and recover State clean-up funds based on referrals from the Agency of Natural Resources, the Natural Resources Board, and the Agency of Agriculture, Food and Markets. The Unit also leads complex AGO-initiated actions against national/multinational companies for contaminating Vermont's environment. When the State and its agencies are sued over environmental matters, the Unit typically helps with or handles the defense along with our Civil Division. The Unit also handles environmental appeals before the Vermont Supreme Court. On a national level, the Unit participates in joint environmental initiatives with other states to advance federal environmental protections.

From July 2023 to November 2024, the Unit has settled several cases resulting in corrective actions, \$203,750 in civil penalties (with \$20,000 suspended for demonstrated inability to pay), and \$2,350,733 in environmental clean-up funds. The Unit also participated in a variety of Vermont Supreme Court environmental appeals on behalf of the State.

In the complex litigation area, the Unit remains actively involved in several major cases: two cases against 3M, DuPont, and related entities for contaminating Vermont's natural resources with PFAS; a case against Monsanto to recover damages for PCB contamination in Vermont schools and natural resources; and a case against fossil fuel companies for consumer deception.

On the multistate front, the Unit continues to be actively involved in joint efforts to protect the environment with other Attorneys General nationwide. The AGO has joined over 20 comments and amicus briefs since July 2023 and is currently involved in over 30 litigation cases.

## CIVIL DIVISION

The Civil Division represents the State of Vermont and its agencies, officers, and employees who are named in civil lawsuits brought in state and federal courts, including personal injury, wrongful death, employment, and other civil rights actions.

One of the most important roles of the Civil Division is to defend legislative acts and administrative rulings that are challenged on constitutional or other grounds. For example, the Division is defending a federal lawsuit challenging the State of Vermont's large capacity magazine ban and firearm sales waiting period. The Division is also defending the constitutionality of Act 15 (2023), which prohibits false and deceptive advertising by limited-services pregnancy centers about the services performed at those centers. The Division is defending the Department for Children and Families and several DCF officials in two federal lawsuits brought by prospective foster parents who were denied foster licenses for failure to comply with DCF's policies prohibiting discrimination on the basis of sexual orientation and gender identity.

The Civil Division plays a role in enforcing state law and may bring affirmative actions on behalf of the State. For example, in the last year, the Division pursued the enforcement of a subpoena issued by the Green Mountain Care Board and directed to OneCare, which resulted in a determination as to the Board's authority to obtain compensation information for OneCare executives.

Litigation of civil appeals before appellate tribunals, such as the Vermont Supreme Court, the United States Courts of Appeals, and the United States Supreme Court, is also handled by the Civil Division.

## CRIMINAL DIVISION

The Criminal Division is a statewide prosecutorial agency. The Division prosecutes a wide variety of serious criminal offenses prioritizing homicide, sexual assault, and other violent crimes. Additionally, the Division reviews all officer-involved shootings, as well as other use-of-force cases involving law enforcement officers as needed. The Division, on behalf of the AGO, serves as the lead agency for the *VERMONT INTERNET CRIMES AGAINST CHILDREN* (VT-ICAC) Task Force; the Division also includes the *MEDICAID FRAUD AND RESIDENTIAL ABUSE* (MFRAU) UNIT.

VT-ICAC emphasizes the prosecution of child exploitation crimes, including possession and trafficking of child sexual abuse materials (CSAM, formerly referred to as child pornography), the manufacturing of CSAM, online enticement of children by sexual predators, and other related child sexual exploitation crimes.

The VT-ICAC Task Force is currently comprised of the four full-time AGO Criminal Investigators and an AGO ICAC Commander. The VT-ICAC is assisted by some affiliate agency members who are employed by state, local, and federal law enforcement agencies on a limited part-time basis.

VT-ICAC also has a new Electronic Device Detection Dog named Kaia. Kaia is a golden retriever, trained to detect chemicals of electronic storage devices that can contain digital files. Kaia is utilized at search warrant scenes and has been responsible for locating numerous hidden devices.

The number of reported crimes against children received by VT-ICAC historically increases dramatically each year. The size and amount of data and devices needing to be examined while conducting investigations has also drastically increased.

The following notes the last three years of VT-ICAC data:

Every cyber tip and investigation represents countless hours of detailed investigations and complex forensic examinations. In SFY2024, VT-ICAC examined 68,133 gigabytes of data. For perspective, a gigabyte can hold a standard 1 ½ hour length movie.<sup>1</sup>

The Criminal Division also carries a significant general criminal caseload that includes a wide variety of serious criminal matters, including homicides, throughout the state.

The Criminal Division, back in SFY2021, took on the complex prosecution and evaluation of two homicide cases and one attempted homicide case that were dismissed from the Chittenden County State's Attorney's Office. The AGO refiled all three cases, successfully securing convictions in all three matters. This year the Division continued its commitment to two of those cases: we are currently handling the appeal of one of the cases that went to trial, and another which has been revived through a probation violation as the defendant has again been accused of a new Attempted Murder in the Second Degree, which the Division is also currently prosecuting. Additionally, the Division is involved in seven charged homicide prosecutions throughout the state and a number of homicide investigations.

The Division also prosecutes other serious felonies such as sexual assaults, child exploitation, luring, domestic violence, neglect of a vulnerable adult, financial fraud and a limited number of drug related cases. Currently, the Criminal Division is prosecuting over sixty-five pending charged complex sexual assaults and child exploitation cases alone. Further, to date this year the Division has also handled thirty-five extraditions for the

State of Vermont. The Division also works with the Legislature on a wide range of criminal justice issues and is an active participant in several committees and working groups that shape Vermont's criminal justice policies.

Housed within the Criminal Division, the MFRAU is designated as the Medicaid Fraud Control Unit for Vermont. Specifically, MFRAU is responsible for investigating and prosecuting: (a) fraud by healthcare providers in the Vermont Medicaid program; (b) fraud in the administration of the Vermont Medicaid program; (c) the abuse, neglect, and financial exploitation of individuals who live in skilled nursing facilities and board-and-care facilities in Vermont, regardless of payor, and (d) the abuse, neglect, and financial exploitation of Medicaid beneficiaries, including children, when the conduct is connected to the provision of Medicaid services.

MFRAU also brings affirmative civil enforcement actions on behalf of the State related to Medicaid fraud and abuse and neglect of vulnerable adults, and cases arising under the Vermont False Claims Act involving Medicaid Fraud.

In SFY2024, the Unit obtained settlements and restitution judgment orders totaling \$499,787 in Medicaid damages and additional recoveries.

For SY2024, MFRAU received 232 referrals. The Unit continues to see a consistent number of referrals from the Single State Agency's Program Integrity Unit known in Vermont as the Special Investigations Unit (SIU); Adult Protective Services (APS); ARIS Solutions, our fiscal integrity agency, that processes payments for Medicaid waiver programs; Office of the Chief Medical Examiners (OCME); Survey and Certification (S&C); and Law Enforcement. SFY2024 saw an increase in referrals from the State's Attorneys' Offices.

In addition to state partners at the Agency of Human Services, Agency of Education, and the Office of Secretary of State, MFRAU works with the United States Attorney's Office (USAO) for the District of Vermont and the Boston Office of Investigation at the U.S. Department of Health and Human Services.

During SFY2024, the Unit filed eight new criminal cases and successfully prosecuted eleven criminal cases. Additionally, the unit filed two civil enforcement actions and settled one other civil action.

The Unit receives 75% of its funding from the U.S. Department of Health and Human Services under a grant award totaling \$1,332,724 for FFY2025. The remaining 25%, totaling \$444,241 for FFY2025, is funded by the State of Vermont.

In any given civil settlement, MFRAU receives a portion of the collected penalties or fines, as opposed to recovered Medicaid funds. Per a Memorandum of Understanding with the Agency of Human Services and the Special Investigations Unit in the Department of Vermont Health Access (DVHA), these additional penalties are split 50/50 between the DVHA and the AGO MFRAU. These additional monies received by MFRAU pay for the 25% state share of the MFRAU Unit's budgeted operations. Not all settlements include additional penalties.

#### GENERAL COUNSEL AND ADMINISTRATIVE LAW DIVISION

The General Counsel and Administrative Law (GCAL) Division provides legal advice and representation to Vermont's constitutional officers, appointed officials, and state agencies on a wide variety of topics and in multiple forums. GCAL is the primary source of legal services to the Agency of Transportation, including the Department of Motor Vehicles, the Tax Department, the Department of Buildings and General Services, the Department of Liquor and Lottery, the Veteran's Home, and the Board of Medical Practice. GCAL is also a source of legal services to the Military Department, the Agency of Education, the Agency of Digital Services, and other agencies. The Division includes the *COMMUNITY JUSTICE UNIT*, described below.

GCAL AAGs handled approximately 577 contested matters in various administrative and judicial forums in SFY2024. AAG representation in such matters avoids substantial costs to the State in many cases, and in other cases brings in funds. Members of the *ADMINISTRATIVE LAW UNIT* investigate and prosecute disciplinary

complaints against physicians and other health professionals before the Medical Practice Board and represent the State in labor matters before the Vermont Labor Relations Board, Vermont courts, and the Human Rights Commission. Transportation litigation includes federal and state environmental permitting for transportation projects, defense of contractor claims for additional compensation, motor vehicle law, challenges to DMV enforcement activities, eminent domain proceedings to acquire needed land and rights for State transportation projects, diesel fuel tax administration, and defense of tort and property law claims.

Contested tax matters include audit assessments and refund denials for all tax types, as well as enforcement and collections of unpaid liabilities. The Tax Unit also supports the property valuation work of the Department, including litigating property valuation appeals of complex properties such as hydroelectric generation facilities.

GCAL AAGs provide legal advice on agency-specific issues as well as issues common to all agencies such as public records, open meetings, contracts and other legal agreements. The Division assists with drafting and negotiating complex contracts, including investment and information technology contracts. The Division reviewed approximately 1,746 contracts, grants, and other agreements in SFY2024. The AAG assigned to the Department of Buildings and General Services advises the Commissioner regarding real estate, government procurement, and the use of state property. The AAG assigned to the Agency of Education provides advice and representation in contested licensing matters, education-related litigation such as challenges to Act 46, and constitutional matters.

The *COMMUNITY JUSTICE UNIT* administers the statewide Court Diversion and Pretrial Services programs, including the Youth Substance Abuse Safety Program and DLS (driving with a suspended license) Diversion. Last year, the Legislature added to this list the Pre-Charge Program. The mission, program description, and data related to the Unit’s work is provided below in a separate section.

The *SOLICITOR GENERAL AND APPELLATE UNIT* is responsible for oversight of state and federal appeals of lower court decisions and has supervisory authority for the roughly 100 appeals handled by the AGO each year. Those appeals are argued in the Vermont Supreme Court, the U.S. Court of Appeals for the Second Circuit and other federal appellate courts, and the U.S. Supreme Court. In SFY2024, the Office opened 104 appeals – 6 in criminal matters and 98 in civil matters (including corrections and child protection). That docket included 36 appeals from child protection cases (mainly termination of parental rights appeals). These child protection appeals, which must be briefed on an expedited schedule set by court rule, continue to outstrip the available resources of the Human Services Division. In addition to the AHS AAGs, the Appellate Unit draws on its own resources and those of AAGs throughout the Office to brief and argue child-protection appeals in civil matters (including corrections and child protection).

The approximate breakdown for appeals opened in SFY2024 is as follows:

Of the appeals opened in SFY2024, 11 were in federal appellate courts and the remainder were Vermont Supreme Court cases.

The Solicitor General and the Appellate Unit respond to requests for briefing from the Vermont Supreme Court and oversees the filing of “friend of the court,” or amicus, briefs in that Court when appropriate. The Solicitor General also manages Vermont’s authorship and participation in dozens of “friend of the court” briefs filed by states in the U.S. Supreme Court and federal appellate courts every year. The Unit also coordinates and manages Vermont’s participation in multi-state litigation across the country on issues where Vermont has significant interests—for example, in challenging adverse federal policies and regulations.

The Unit also frequently represents the State in civil, criminal, and administrative trial-court litigation that presents significant constitutional issues and advises executive branch officials on significant constitutional issues.

**HUMAN SERVICES DIVISION**

The Attorney General’s Human Services Division serves as the trial and litigation counsel to all departments of the Agency of Human Services (AHS). These include the Departments of Health; Corrections; Mental Health; Disabilities, Aging and Independent Living; Vermont Health Access; and the Department for Children and Families – Family Services Division and Economic Services Division.

The Division’s AAGs also advise the Agency and its component Departments on legal issues that arise indirectly from litigation, proposed legislation and rules, and public records matters. They provide significant input and assistance in the review, drafting, and approval of hundreds of contracts and grants for the Agency and its Departments.

The AHS AAGs litigate cases before every division of the Vermont Superior Court, the federal district court, the Vermont Supreme Court, federal appellate courts, the Human Services Board and other administrative forums. Cases often involve issues related to child protection (abuse and neglect), child in need of care or supervision, juvenile justice, involuntary mental health treatment and discharges therefrom, incarcerated individual litigation, parole issues and furlough revocation, emergency housing and public benefits programs such as 3SquaresVT and fuel assistance, medical care and entitlements, Health Department emergency management, and federal and state grants. Many of the programs that AHS AAG's defend have dealt with budget cuts with the loss of federal pandemic funding, especially around emergency housing and public assistance programs.

## **VERMONT COURT DIVERSION**

**MISSION:** Programs within Court Diversion share a common goal of diverting offenders out of the standard judicial system to community-based providers where they are held accountable, respond to the needs of victims, and address underlying reasons for their actions. The programs are Court Diversion, the Tamarack Program, the Youth Substance Awareness Safety Program (YSASP), and the DLS (Driver License Suspension) Program.

Pretrial Services' goal is to address defendants' substance use and mental health treatment needs and thereby limit future adverse involvement with the criminal justice system. Pretrial Services (PTS) encompass risk assessment needs screening, and court-ordered pretrial services.

### **REFERRAL TRENDS**

During SFY2024, prosecutors referred 2,099 cases from the Criminal Division of the Vermont Superior Court to Court Diversion and the Tamarack program. Family Division referrals numbered 350 (including 83 Youthful Offenders) and approximately 975 youth were referred to the YSAP. Over 1,000 people participated in PTS.

Based on SFY2023 data, the rate of referral to Court Diversion has stabilized after the fluctuations associated with the effects of the pandemic. During the past three years, Diversion and Tamarack referrals represented 20% of all misdemeanors statewide, with some variations in a few counties. From the Family Division, approximately 35% of delinquencies are referred to Court Diversion. Judges continue to rely on PTS. More young people were referred to YSASP during SFY2024 than the previous years, although the number remains lower than before the onset of the pandemic.

Staff at the community-based Diversion and PTS programs continue to report difficulties in helping people access treatment services. People's needs related to substance misuse, mental health problems, and lack of housing constrain their ability to effectively engage in repairing harm and following program agreements.

## **PROGRAM DESCRIPTION**

The AGO provides grants for the provision of services statewide in twelve counties with non-profit agencies and in two counties under a municipality. All the programs belong to the Vermont Association of Court Diversion and Pretrial Services.

### **COURT DIVERSION**

Court Diversion began in the 1970's by diverting minor offenders out of the court system to community-based programs staffed largely by volunteers. During the past 50 years, Diversion has expanded to work with repeat offenders of all ages and operates two other programs: one for civil violations of underage possession of alcohol, cannabis, and buprenorphine (YSASP), and one designed to help people regain their driver's license while paying fines and fees owed to the State (DLS).

Through Court Diversion, offenders have the opportunity to accept responsibility for their actions, to repair the harm done, and to avoid a criminal record. Prosecutors refer typically first- or second-time offenders charged with misdemeanors, although felony charges are also referred. Following a restorative justice approach, victims are invited to describe their needs and, if they choose to do so, join community members in meeting with the responsible person to develop contracts that repair harm to the extent possible and address the offense and underlying reasons for the responsible person's actions. Clients, through their contracts, agree to paying restitution, participating in counseling or substance use treatment, writing letters of apology, and other individualized commitments. Participation in the program is voluntary and, upon successful completion of the program, the case is dismissed. If an offender does not complete the terms of the contract, the case is returned for prosecution.

In 2017, Court Diversion expanded to work with people with substance use or mental health treatment needs regardless of their prior criminal history (3 V.S.A. §164 (b)(2)). This new program was named Tamarack, to differentiate the services for those referred to Court Diversion.

In addition, Court Diversion programs run the YSASP. Youth, ages 16 to 20, caught with alcohol or small amounts of cannabis or buprenorphine, are referred by law enforcement to YSASP. Youth participate in a substance use screening and brief educational intervention tailored to the individual, and those at higher risk are referred for an assessment and any recommended treatment. If an individual fails to complete the contract, the ticket is sent to the Vermont Judicial Bureau. Penalties include a fine and license suspension.

During SFY2024, 972 referrals were made to YSASP. Over 80% of the youth who engaged in the program completed it successfully.

During SFY2024, Court Diversion programs helped approximately 1,200 people identify driver license reinstatement requirements and navigate related government and insurance systems. Prosecutors, law enforcement, and other community partners refer individuals; many people also learn of this service through word of mouth. Recent legislative changes have helped many people regain their driving privileges. Often, people who are required to complete the Impaired Driver's Rehabilitation Program (IDRP) to regain their driver's license struggle to pay the IDRP fee or face burdensome financial requirements from other states.

### **PRETRIAL SERVICES**

PTS encompasses risk assessment, needs screening, and court-ordered pretrial services. The aim of these services is to improve the referred person's health and reduce future adverse involvement in the justice system. Staff support is also designed to increase an individual's success with court requirements particularly regarding substance use and mental health treatment needs.

PTS are for youth aged 18 and older and adults thought to need substance use or mental health treatment. Judges issue court orders to defendants to engage in PTS; however, a person's refusal to engage is not a

violation of conditions of release. Individuals may also choose to engage voluntarily. Needs screenings are also offered to individuals lodged at correctional facilities. These screenings suggest the vast majority of these defendants (75%) have mental health or substance use treatment needs, or both. PTS Coordinators aim to quickly connect people to substance use, mental health, and other supportive community-based services.

### **GOALS/OBJECTIVES/PERFORMANCE MEASURES**

### **COURT DIVERSION**

Objective: to hold low-level offenders diverted from traditional court proceedings accountable for the harm caused to others and themselves to reduce recidivism.

Staff are working with people who are at higher risk to re-offend and who often have higher needs, requiring additional case manager supervision and support. The successful Diversion completion rate for people with prior involvement and those charged with criminal DLS in the justice system is lower than for first-time participants.

These services are cost effective. A cost analysis done by Crime Research Group in 2019 documented that Diversion is much less expensive than the traditional criminal justice system. For example, an assault case resolved through Diversion costs \$216, while a similar case would cost \$1,480 in the traditional system. On average, the cost of resolving Diversion cases is 15% of the cost of court adjudication.

### **PRETRIAL SERVICES**

Objective: to support a person thought to need substance use or mental health treatment to connect quickly to treatment supports during the pretrial period.

### **KEY BUDGET ISSUES**

The ongoing reliance of prosecutors and judges on Court Diversion and PTS speaks to the value and effectiveness of these services. Steady increases in program operation costs, including cost-of-living increases provided to staff and rising insurance premiums, and the unpredictable/non-sustainable nature of fee revenue are the primary budget pressures facing Court Diversion and PTS providers.

The Court Diversion Special Fund records fees from clients that are used to support the programs. Each Court Diversion program reports fees collected and spent quarterly to the AGO.

The Court Diversion Special Fund's revenue started to decline in SFY2015, with significant decreases following the onset of the pandemic. SFY2019 fee revenue was approximately \$380,000; during the past three years, fee revenue has ranged between \$212,000 to \$218,000.

Program directors have noted the changing demographic of participants, most of whom earn low wages and struggle with other financial challenges. Data collected during SFY2023 showed that only approximately 25% of Diversion program participants paid the \$175 fee and over 50% paid no fee. County programs follow a standard fee scale to reduce and waive fees based on participants' financial situation.

At one point, fee revenue from participants accounted for approximately 25% of the revenue used to support Court Diversion and PTS. In recent years this figure has been less than 10%.
