

We, the undersigned, fully support an appropriation of \$500,000 in base funding in fiscal year 2027 to strengthen Vermont farm viability and improve food security by sustaining proven programs: Crop Cash (Plus) and Farm Share.

- **Crop Cash** doubles 3SquaresVT (SNAP) benefits for fruits and vegetables purchased at Vermont farmers markets.
- **Crop Cash Plus** expands Crop Cash to meat, dairy, eggs, bread, and more, extending the program’s impact to all agricultural vendors. State funding is necessary to continue this critical program so that hundreds more farmers will benefit, and thousands of low-income Vermonters can purchase more local, fresh food.
- **The Farm Share Program** pays for 25-75% of the CSA cost. It has subsidized community supported agriculture (CSA) shares for limited-income Vermonters for 30 years. State funding would mean up to 700 families could be supported in purchasing a consistent supply of locally grown food.

Vermonters count on these programs every week. Thanks to the State’s support, these programs have leveraged nearly \$1.6 million in local food purchases in the past two years. This support was also vital during the federal shutdown, as we were able to ensure that folks could continue using Crop Cash Plus even during the delay in SNAP benefits distribution.

These programs have a double impact. With every dollar invested, low-income Vermonters can purchase healthy, fresh, local food and Vermont farmers receive a reliable, fair price for their products.
