3	(2) With respect to services performed in any other capacity for an
4	educational institution, benefits shall not be payable on the basis of such
5	services to any individual for any week of unemployment that commences
6	during a period between two successive academic years or terms if the
7	individual performs such services in the first of the academic years or terms
8	and there is a reasonable assurance that the individual will perform such
9	services for any educational institution in the second of the academic years or
10	terms, except that if benefits are denied to any individual under this
11	subdivision and the individual was not offered an opportunity to perform such
12	services for the educational institution for the second of the academic years or
13	terms, the individual shall be entitled to a retroactive payment of the benefits
14	for each week for which the individual filed a timely claim for benefits and for
15	which benefits were denied solely by reason of this subdivision. [Repealed.]
16	(3) With respect to any services described in subdivision (1) or (2) of
17	this subsection, benefits shall not be payable on the basis of services in any
18	such capacities to any individual for any week that commences during an
19	established and customary vacation period or holiday recess if the individual
20	performs such the services in the period immediately before the vacation
21	period or holiday recess, and there is a reasonable assurance that the individual

3	(4) With respect to any services described in subdivision (1) or (2) of
4	this subsection, benefits shall not be payable on the basis of services in any
5	such capacities as specified in subdivisions (1) , (2) , and (3) of this subsection
6	to any individual who performed such the services in an educational institution
7	while in the employ of an educational service agency. As used in this
8	subdivision, the term "educational service agency" means a governmental
9	agency or governmental entity that is established and operated exclusively for
10	the purpose of providing such services to one or more educational institutions.
