Remember...

- The fiscal year 2025 Education Payment is \$1.88 billion
- Long-Term Weighted Average Daily Membership (LTWADM)
 is the weighted student count that drives funding to a district
 in a foundation formula
- The modeling presented today uses various weights to generate a funding amount under Current Law districts
- Pupil weight abbreviations presented here:
 - FPL: Federal Poverty Level Students experiencing economic disadvantage
 - EL: English Learner students



Overview of Modeling



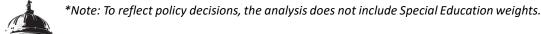
Underlying Assumptions

- The modeling uses fiscal year 2025 data and current law districts
- Models were built to hold the total education payment at the fiscal year 2025 level
 - In fiscal year 2025, the education payment was \$1.88 billion
- Weights direct a certain proportion of the designated base, not a target dollar amount
 - All weights are additive



Modeled Scenarios

- Scenarios apply different bases and weights that could be included in a foundation formula, while maintaining an overall cost of \$1.88 billion
- Scenario C:
 - APA's Enhanced EB weights* set to current Education Payment except for FPL (which is kept at 1.02), and eliminated the CTE and 101-249 enrollment small school weight, applied to current law districts
 - (Grades 6-8 receive 0.02, grades 9-12 receive 0.10)
 - Small school weight is maintained for schools with fewer than 100 pupils in a district with sparsity <55



Scenario B-2.2

H.454 Weights, Constrained to Current Education Payment with Added Pupil Grade Weights and Eliminated Sparsity, Applied to Current Law Districts

- Retains everything from Scenario B-2.1
- Eliminates the sparsity weight

Scenario APA's "Enhanced EB Model" Utilizes Revised Weights, an Expansion of Small School Weight, and the Addition of a CTE Weight

- Maintains the elimination of the sparsity weight
- Assumes other policy changes beyond what is included in H.454
- Introduces a variable small school weight for schools with enrollments between 101-249

Scenario C

APA Weights (with changes for FPL, CTE, and small schools), Set to Current Education Payment, Applied to

Current Law Districts

- Maintains APA's weights from the "Enhanced EB Model" with the following changes:
 - FPL is maintained at B-2.2's 1.02 weight
 - There is no CTE weight
 - The small school weighting construct is maintained from B-2.2
- Applies the weights to current law districts, resulting in a new base

Considerations



Considerations

- These estimates only reflect how different base and weight decisions would affect funding under the constraint of the current Education Payment
- They don't reflect any other research on appropriate funding levels
- Different district configurations would result in different estimates
- Like the analysis we performed for the House proposal, this only considers the Education Opportunity Payment
- It does not include supplemental district spending or categorical aid
 - Supplemental district spending would likely have impacts on the Education Fund and property tax rates

- Restricts sparsity eligibility
 - Applies the small school weight to small schools in districts with fewer than 55 people per square mile
