2 An act relating to creating immigration protocols in Vermont schools

3 The House proposes to the Senate to amend the bill by striking out all after  
4 the enacting clause and inserting in lieu thereof the following:

5 Sec. 1. PURPOSE

6 The purpose of this act is to secure the right of every child to equal access  
7 to a free public education and to a school that is safe from intimidation and  
8 fear, regardless of immigration status. In order to ensure the right to  
9 educational equality, schools must take steps to protect the integrity of school  
10 learning environments for all children, so that no parent is discouraged from  
11 sending a child to, and no child is discouraged from attending, school,  
12 including due to the threat of immigration enforcement on a school campus.

17 § 1486. IMMIGRATION PROTOCOLS

18 (a) Definitions. As used in this section:

19 (1)(A) “Law enforcement officer” has the same meaning as in 20 V.S.A.

20 § 2351a and includes any officer of a federal law enforcement agency or any

21 person acting on behalf of a local, state, or federal law enforcement agency.

1           (B) “Law enforcement officer” does not include a school resource  
2 officer or safety officer who is stationed at a school.

3           (2) “Nonpublic area of a school” means an area of a school that  
4 normally requires authorization to enter, consistent with the policy required by  
5 section 1484 of this chapter, and includes any area a superintendent or head of  
6 school or designee determines to be nonpublic.

7           (3) “School” means a public school or an independent school approved  
8 under section 166 of this title.

9           (b) Immigration resources and support.

10           (1) A superintendent or head of school shall:

11           (A) distribute the immigration resource guide developed by the  
12 Office of the Attorney General pursuant to subdivision (2) of this subsection

13 (b) to staff, students, and family members of students;

14           (B) at each school the superintendent or head of school oversees,  
15 designate at least one individual to serve as a resource for immigration-related  
16 matters who shall receive on an ongoing basis updated information and  
17 training material as provided to the superintendent or head of school by the  
18 Office of the Attorney General; and

19           (C) provide support, to the greatest extent possible, to a student with  
20 regard to immigration-related concerns, including connecting the student and

1 the student's family with an immigration advocacy institution and similar  
2 resources.

3 (2)(A) The Office of the Attorney General, in consultation with the  
4 Agency of Education, shall develop an immigration resource guide that shall:

5 (i) include immigration- and civil rights-related resources;  
6 information regarding standby guardianships pursuant to 14 V.S.A § 2626a;  
7 and a list of immigration, human rights, and relevant advocacy organizations  
8 available to provide immigration assistance to students and staff; and

9 (ii) be developed in a manner that serves to protect the privacy and  
10 safety of students and staff.

11 (B) The Office of the Attorney General shall review the guide at least  
12 once annually and send any updates made to the guide to the Agency of  
13 Education for distribution to all superintendents and heads of schools not later  
14 than 30 days after completing the update.

15 (c) Student information privacy. School districts and independent schools  
16 are prohibited from:

17 (1) collecting or requesting information regarding citizenship or  
18 immigration status of a student or of a family member of the student except as  
19 required by State or federal law or as required to administer a State- or  
20 federally supported educational program;

1           (2) disclosing a student’s immigration status, citizenship, place of birth,  
2 nationality, or national origin:

3                   (A) in any database that the school maintains; or

4                   (B) as directory information, as that term is defined by the Family  
5 Educational Rights and Privacy Act (FERPA), 20 U.S.C. § 1232g and 34  
6 C.F.R. Part 99; and

7           (3) voluntarily sharing student information, including immigration  
8 status, citizenship, place of birth, nationality, national origin, sexual  
9 orientation, status as a survivor of domestic violence or sexual assault, status as  
10 a recipient of public assistance, or school discipline records, with a third party  
11 unless required to do so by State or federal law.

12           (d) Law enforcement on-site and requests for information.

13                   (1) A superintendent or head of school shall:

14                           (A) subject to subdivision (B) of this subdivision (1), be the sole  
15 authority to admit a law enforcement officer who appears on an immigration-  
16 related matter into a nonpublic area of school; and

17                           (B) designate at least one individual who works at each school to  
18 serve as a designee of the superintendent or head of school in the event that the  
19 superintendent or head of school is not present when the law enforcement  
20 officer appears on-site.

1           (2) The superintendent or head of school or designee shall not allow a  
2 law enforcement officer appearing on an immigration-related matter into a  
3 nonpublic area of a school unless the officer provides official identification and  
4 a judicial warrant that authorizes entrance into a specific area of the school and  
5 names a specific individual located within the school who is subject to a search  
6 or arrest.

7           (3) Absent a judicial warrant pursuant to subdivision (2) of this  
8 subsection, no school or individual working at a school shall reveal any  
9 information about a student or school staff member in response to an  
10 immigration-related request from a law enforcement officer unless otherwise  
11 required by law.

12           (4) As used in this subsection, “immigration-related matter” and  
13 “immigration-related request” mean an administrative warrant, civil warrant,  
14 immigration detainer, or any other document or request that pertains to an  
15 individual’s immigration or citizenship status.

16           (e) Immigration agreements.

17           (1) Except as required by State or federal law, no school, school district,  
18 or supervisory union shall enter into an agreement with a State, local, or  
19 federal government entity that furthers the enforcement of any immigration  
20 law.

1           (2)(A) Any proposed agreement pursuant to subdivision (1) of this  
2 subsection (e) that purports to be required by State or federal law shall be  
3 subject to review by the superintendent or head of school after the  
4 superintendent or head of school has consulted with the Office of the Attorney  
5 General.

6           (B) The superintendent or head of school shall provide a  
7 recommendation on the proposed agreement to the school's appropriate  
8 governing body after the superintendent's or head of school's review pursuant  
9 to subdivision (A) of this subdivision (2).

10          (f) Applicability. Nothing in this section is intended to prohibit or impede  
11 any public agency from complying with the lawful requirements of 8 U.S.C.  
12 §§ 1373 and 1644. To the extent any school, school district, or supervisory  
13 union policy or practice conflicts with the lawful requirements of 8 U.S.C.  
14 §§ 1373 and 1644, the policy or practice is, to the extent of such conflict,  
15 abolished.

16          (g) Policy required.

17          (1) Model policy and recommended procedures. On or before January  
18 1, 2027, the Agency of Education, in consultation with the Office of the  
19 Attorney General, the Vermont Independent Schools Association, and the  
20 Vermont School Boards Association, shall develop, and review at least

1 annually, a model policy along with recommended procedures that reflect the  
2 requirements set forth in subsections (c) and (d) of this section.

3 (2) Adoption of policy and procedures.

4 (A) Beginning with the 2027–2028 school year, each school board  
5 shall develop, adopt, ensure the enforcement of, and make available in the  
6 manner described under subdivision 563(1) of this title an immigration  
7 protocol policy that shall be at least as stringent as the model policy developed  
8 by the Agency. Any school board that fails to adopt a policy shall be  
9 presumed to have adopted the most current model policy published by the  
10 Agency.

11 (B) Beginning with the 2027–2028 school year, each independent  
12 school shall develop, adopt, and ensure the enforcement of an immigration  
13 protocol policy that shall be at least as stringent as the model policy developed  
14 by the Agency. Any approved independent school that fails to adopt a policy  
15 shall be presumed to have adopted the most current model policy published by  
16 the Agency.

17 Sec. 3. IMMIGRATION RESOURCE GUIDE

18 The Office of the Attorney General shall complete the immigration resource  
19 guide required pursuant to 16 V.S.A. § 1486(b)(2) on or before August 1,  
20 2026, and shall send the completed guide to the Agency of Education for

- 1 distribution to all superintendents and heads of schools on or before August 31,
