7	Statement of purpose of bill as introduced: This bill proposes to require the
8	Agency of Transportation to request conditions as part of the federal
9	relicensing of the Bellows Falls Hydroelectric Project that would require the
10	dam owner or operator to contribute to costs associated with maintaining
11	publicly owned bridges crossing the canal that supplies water to the facility.
12 13	An act relating to requiring the Agency of Transportation to request conditions in relation to the relicensing of the Bellows Falls Hydroelectric
14	Project
15	It is hereby enacted by the General Assembly of the State of Vermont:
16	Sec. 1. BELLOWS FALLS PROJECT HYDROELECTRIC DAM; AGENCY
17	OF TRANSPORTATION; FEDERAL RELICENSING; REQUEST
18	FOR CONDITIONS
19	(a) The Agency of Transportation shall, as soon as practicable, submit
20	comments, recommendations, and proposed terms and conditions to the

1	Federal Energy Regulatory Commission regarding the relicensing of Project
2	No. 1855-050, the Bellows Falls Hydroelectric Project (the Project).
3	(b) The Agency shall specifically request that the license for the Project
4	include terms and conditions that would require the owner or operator of the
5	Project to develop a plan for, and contribute to, the cost of repairs,
6	maintenance, and, if necessary, replacement of publicly owned bridges that
7	cross the power canal that supplies water to the Project.
8	(c) The Agency's filing shall include evidence and facts supporting the
9	inclusion of the terms and conditions described in subsection (b) of this
10	section, including that:
11	(1) the power canal currently serves no purpose other than providing
12	water necessary for the operation of the Project, which could not produce
13	electricity without the water supplied by the power canal;
14	(2) the power canal creates a physical barrier that separates the island
15	from the rest of the Village of Bellows Falls and the Town of Rockingham;
16	(3) the bridges across the canal are necessary to the physical and
17	socioeconomic activity on the island in the Village of Bellows Falls, including
18	access to:
19	(A) the Connecticut River and cultural sites, including a petroglyph
20	site, lithic site, and Native American burial site; and

1	(B) rail and transit facilities that serve the Village of Bellows Falls,
2	Town of Rockingham, and surrounding communities;
3	(4) economic redevelopment efforts are planned for the island, including
4	mixed-use developments and the reconnection of Bellows Falls, Vermont, to
5	Walpole, New Hampshire, via the Vilas Bridge; and
6	(5) the bridges are critical to ensuring adequate regular and emergency
7	access to businesses, structures, landmarks, and activities on the island, as well
8	as future residents of the island.
9	(d) The Agency of Transportation shall provide a copy of all materials that
10	it submits to the Federal Energy Regulatory Commission to the House and
11	Senate Committees on Transportation.
12	Sec. 2. EFFECTIVE DATE
13	This act shall take effect on passage.
