What is Captive Insurance?

A captive is a self-insurance company owned by the organization it insures, created to provide custom coverage that may be unavailable in the commercial market. Common lines of insurance for captive companies include: **P&C, Climate, Workers' Comp, Cyber and more.** Captives may serve a social utility as many higher ed. institutions and hospitals, including UVM Health Network, operate a captive to manage insurance costs.
