2 Senator Collamore moves that the Senate propose to the House that the bill
3 be amended by striking out Sec. 1, 3 V.S.A. § 455, in its entirety and inserting
4 in lieu thereof a new Sec. 1 to read as follows:

6 § 455. DEFINITIONS

7 (a) As used in this subchapter:

8 * * *

9 (11) “Member” means any employee included in the membership of the
10 Retirement System under section 457 of this title.

12 (F) “Group G member” means:

13 (i) the following employees who are first employed in the
14 positions listed in this subdivision (F)(i) on or after July 1, 2023, or who are
15 members of the System as of June 30, ~~2022~~ 2023, and make an irrevocable
16 election to prospectively join Group G on or before June 30, 2023, pursuant to
17 the terms set by the Board: facility employees of the Department of
18 Corrections, as Department of Corrections employees who provide direct
19 security and treatment services to offenders under supervision in the
20 community, employees of a facility for justice-involved youth, and employees

1 of the Vermont Psychiatric Care Hospital or its successor in interest, who
2 provide direct patient care; ~~and~~

3 (ii) the following employees who are first employed in the
4 positions listed in this subdivision (F)(ii) or first included in the membership of
5 the System on or after January 1, 2025, or who are members of the System as
6 of December 31, 2024, and make an irrevocable election to join Group G on or
7 before December 31, 2024, pursuant to the terms set by the Board:

8 (I) all sheriffs; and

9 (II) deputy sheriffs who:

10 (aa) are employed by county sheriff's departments that
11 participate in the Vermont Employees' Retirement System;

12 (bb) have attained Level II or Level III law enforcement
13 officer certification from the Vermont Criminal Justice Council;

14 (cc) are required to perform law enforcement duties as the
15 primary function of their employment; and

16 (dd) are not full-time deputy sheriffs compensated by the
17 State of Vermont whose primary function is transports as defined in 24 V.S.A.
18 § 290(b) and eligible for Group C pursuant to subdivision (9)(B) of this
19 subsection (a); and

20 (iii) the following employees who are first employed in the
21 positions listed in this subdivision (F)(iii) or first included in the membership

1 of the System on or after January 1, 2027, or who are members of the System
2 as of December 31, 2026, and make an irrevocable election to join Group G on
3 or before December 31, 2026, pursuant to the terms set by the Board and who:

4 (I) are employed by a municipal employer that participates in
5 the Vermont Employees' Retirement System;

6 (II) have attained Level II or Level III law enforcement officer
7 certification from the Vermont Criminal Justice Council; and

8 (III) are required to perform law enforcement duties as the
9 primary function of their employment.
