2 The Committee on Health and Welfare to which was referred House Bill
3 No. 293 entitled “An act relating to health equity data reporting and registry
4 disclosure requirements” respectfully reports that it has considered the same
5 and recommends that the Senate propose to the House that the bill be amended
6 by striking out all after the enacting clause and inserting in lieu thereof the
7 following:

12 statewide prevalence and incidence estimates of amyotrophic lateral sclerosis,
13 including any trends occurring over time across the State. Reports shall not
14 contain information that directly or indirectly identifies an individual patient or

12 racial and ethnic disparities, as well as disparities along the lines of primary
13 language, sex, disability status, sexual orientation, gender identity, and
14 socioeconomic status, and report the results of such analysis on the
15 Department's website periodically, but not less than biannually. The
16 Department's analysis shall be used to measure over time the impact of actions
17 taken to reduce health disparities in Vermont. The data informing the
18 Department's analysis shall be made available to the public in accordance with
19 State and federal law.
