- Provide analyses to support the Board in its mission
- Manage and steward two main databases
 - Vermont Health Care Uniform Reporting and Evaluation System (VHCURES)
 - Vermont Uniform Hospital Discharge Data System (VUHDDS)
- Data Governance Council

GMCB's Data Duties



- The GMCB is charged with maintaining a unified health care database, which includes VHCURES and VUHDDS to help fulfill its duties of:
 - determining the capacity and distribution of existing resources;
 - identifying health care needs and informing health care policy;
 - evaluating the effectiveness of intervention programs on improving patient outcomes;
 - comparing costs between various treatment settings and approaches;
 - providing information to consumers and purchasers of health care; and
 - improving the quality and affordability of patient health care and health care coverage.
- The GMCB is also required to make the data available as a resource to "continuously review health care utilization, expenditures, and performance in Vermont."

18 V.S.A. § 9410

VHCURES



- All-payer claims database (APCD)
 - Medical and pharmacy claims and eligibility, demographics
 - 100% of Medicare and Medicaid enrollees
 - ~ 60% of commercially insured
 - Longitudinal and comprehensive
 - Includes information for Vermonters seen out of state
 - But only information needed to adjudicate claims
- Established in 2009
 - Vermont was one of the first states to have an APCD
 - As of 2015.01.22, 25 states have an APCD

VHCURES Basics



Who	Commercial, Medicaid, Medicare
What	Claims data from 2007 dates of service Fully insured, some self-insured claims
Where	Data are for Vermont residents only
When	Insurers, Third-Party Administrators (TPAs) and Pharmacy Benefit Managers (PBMs) register annually and report monthly, quarterly, annually depending on number of members (plans with fewer than 200 members not required to report)
How	Onpoint Health Data is GMCB's data aggregation vendor

About Onpoint Health Data



- Vermont's APCD vendor since inception (2009-current).

VUHDDS



- Hospital discharge data
 - All patients seen at Vermont hospitals, even if nonresident
 - Inpatient discharge data
 - Outpatient procedures and services
 - Emergency department services
 - Sharable with state agencies, providers, payers, and researchers
 - In process of moving data management from VDH to GMCB
