

1 TO THE HONORABLE SENATE:

2 The Committee on Institutions to which was referred House Bill No. 494  
3 entitled “An act relating to capital construction and State bonding” respectfully  
4 reports that it has considered the same and recommends that the Senate  
5 propose to the House that the bill be amended as follows:

6 First: In Sec. 1, legislative intent, by striking out subsection (a) in its  
7 entirety and inserting in lieu thereof a new subsection (a) to read as follows:

8 (a) It is the intent of the General Assembly that of the \$111,965,288.44  
9 authorized in this act, not more than \$62,314,761.44 shall be appropriated in  
10 the first year of the biennium, and the remainder shall be appropriated in the  
11 second year.

12 Second: By striking out Sec. 2, State buildings, in its entirety and inserting  
13 in lieu thereof a new Sec. 2 to read as follows:

14 Sec. 2. STATE BUILDINGS

15 (a) The following sums are appropriated to the Department of Buildings  
16 and General Services, and the Commissioner is authorized to direct funds  
17 appropriated in this section to the projects contained in this section; however,  
18 no project shall be canceled unless the Chairs of the Senate Committee on  
19 Institutions and the House Committee on Corrections and Institutions are  
20 notified before that action is taken.

5 Capital and Essential Investments under 32 V.S.A. § 1001b that:

6 (1) provides the historical context, including the economic rationale, for  
7 the Cash Fund;

8 (2) distinguishes between the intended uses of the Capital Infrastructure  
9 subaccount and the Other Infrastructure, Essential Investments, and Reserves  
10 subaccount;

11 (3) describes, for each year since the Cash Fund's inception:

12 (A) the sources of funds; and

13 (B) the annual expenditures from the Capital Infrastructure  
14 subaccount; and

15 (4) outlines the current legislative process by which appropriations are  
16 made from the Cash Fund.
