Over the last year, AHS has made noteable progress on it's modernization project.

The IE&E team completed the Request for Proposal (RFP) for a notification system to replace the current noticing solution which is at end of life. (This work is REQUIRED by the federal government as the current noticing system is not in compliance.) The RFP received the required federal approval and was posted, and the preferred vendor has been selected.

In addition, the IE&E team completed the RFP to procure a new integrated eligibility system that will replace legacy systems for IE&E programs. This effort is a positive step towards mitigating business continuity risks associated with legacy enrollment systems (ACCESS and VHC). This RFP received the required federal approval and was posted in the fall of 2024. The bids are due on January 28, 2025.

This system is referred to as VT-IES (Vermont Integrated Eligibility System) and includes a new client portal, case management, and business rules engine. The IE&E team has indicated that additional state funding will be needed to fund the state match for this project. This project will roll out incrementally over four years.

An important aspect of the VT-IES project is that it will use a new backend database and not rely on mainframe ACCESS for operations. The system will still load data into ACCESS because programs remaining on ACCESS need the data. Still, this is a significant step toward retiring what will be the last state mainframe application.

The risks associated with the age of the ACCESS system and the lack of documentation were key drivers for the funding of the initial IE&E project.

The VT-IES project will be subject to the CIO's independent review before any bid is accepted. Currently, the estimated time for the CIO's independent Review¹ is fall 2025. At this point, JFO will do a complete IT review of this project.

This project consists of Phase 1, Vehicle Services (VS), which includes titling, registration, and other customer-facing eServices, and Phase 2, Driver's Services (DS), including driver's licenses and other identification, customer-facing eServices, and other supporting functions. Project monitoring involves the review of weekly status reports, project plans, and other project documents. Phase 1 was completed on time and went live in Nov 2024. Phase 2 was started on June 5, 2024 and has an estimated date for completion of Phase 2, Driver's Services, is set for Nov 2025. Please note that although the review this this project included an estimated completion date of July 2025, this date was revised to reflect the Phase 2 start date of June 2024 and a completion date of November 2025. The current project is on track and is rated as "Excellent".

Budget: \$4,680,000

All courthouses were integrated into the network as of April 2024. Secure public WiFi has been implemented at all courthouses. All courthouses have a minimum of 3 network connections, which means if one network is unavailable, two other distinct secure networks are available. As of June 21, 2024, all infrastructure housed by the VT Agency of Digital Services was moved to the Judiciary. The project was completed on time and budget. The team at Judiciary did a fantastic job, and ADS staff provided essential support, which allowed this project to succeed.

4. Department of Labor – Unemployment Insurance (UI) Modernization Project

Estimated Technical Implementation Costs: \$30,814,942 Total 5 year Operating Costs: \$14,498,400 Total: \$45,313,342

Note: Costs do not include business costs related to staff augmentation and business process redesign.

The project scope identified two project delivery phases. Phase 1 included a Tax Module to be delivered at the end of year 1, and Phase 2 included the Benefits module to be delivered at the end of year 2. The project kickoff was September 17, 2024. The first project status report noted a change order was issued to combine the two phases with both modules to be delivered in May 2026. This change reduced the FAST project delivery schedule from 24 to 18-22 months.² The total cost of the contract with FAST remains the same. The project status reports mention an overall \$2.14 million reduction of expected costs due to combining the launch of the two phases, which will be used for several optional deliverables included in the contract amendment³. At the time of this update, the updated amendment and ABC form were still in draft and unavailable for review. Data conversion is a concern for projects that include significant legacy data, but status reports indicate this work has already started, which is very encouraging. A key department staff member departed, but Commissioner Harrington is managing this change. JFO will continue to monitor this project.

5. Agency of Administration – Enterprise Resouce Management Project (ERP)
