COMMITMENT TO AWAIT EXTRADITION; BAIL 7 If upon examination it appears that the person held is the person charged 8 with having committed the crime alleged and that the person probably 9 committed the crime, and, except in cases arising under section 4946 of this 10 title, that the person has fled from justice, the judge or magistrate shall commit 11 the person to jail by a warrant, reciting the accusation, for such a time, not 12 exceeding 30 90 days, to be specified in the warrant as will enable the arrest of 13 the accused to be made under a warrant of the Governor on a requisition of the 14 executive authority of the state having jurisdiction of the offense, unless the 15 accused give bail as provided in section 4956 of this title, or until the person 16 shall be legally discharged. On request of the state, the hearing may be 17 continued for up to three working business days, only for the purpose of 18 determining whether the person probably committed the crime. Findings under 19 this section may be based upon hearsay evidence or upon copies of affidavits,

whether certified or not, made outside this State. It shall be sufficient for a

- service of the warrant provided for in sections 4947 and 4948 of this title and
- all other procedure incidental to extradition proceedings, by executing or
- subscribing in the presence of a judge of any court of record within this State a
- writing that states that he or she the person consents to return to the demanding
- state; provided, however, before such the waiver shall be is executed or

5	(2) If the person previously signed an authenticated waiver of
6	extradition to the demanding state, the waiver shall be presumed valid. If the
7	person contests the validity of the previously signed waiver, the person bears
8	the burden of proving that the waiver is not valid. If the court finds that the
9	waiver is valid, it may proceed as if the person had consented to return to the
10	demanding state in accordance with subdivision (1) of this subsection.
11	(b) If and when such consent has been duly executed, it shall forthwith be
12	forwarded to the office of the Governor of this State and filed therein. The
13	judge shall direct the officer having such person in custody to deliver forthwith
14	such person to the duly accredited agent or agents of the demanding state, and
15	shall deliver or cause to be delivered to such agent or agents a copy of such
16	consent; provided, however, that nothing in this section shall be deemed to
17	limit the rights of the accused person to return voluntarily and without
18	formality to the demanding state, nor shall this waiver procedure be deemed to
19	be an exclusive procedure or to limit the powers, rights, or duties of the
20	officers of the demanding state or of this State.

- 3 (a) If an arrest is made in this State by an officer of another state in
- 4 accordance with the provisions of section 5042 of this title, he or she shall the
- 5 officer, without unnecessary delay, shall take the person arrested before a
- 6 Superior judge of the unit in which the arrest was made, who shall conduct a
- 7 hearing for the purpose of determining the lawfulness of the arrest.
- 8 (b) If the judge determines that the arrest was lawful, he or she the judge
