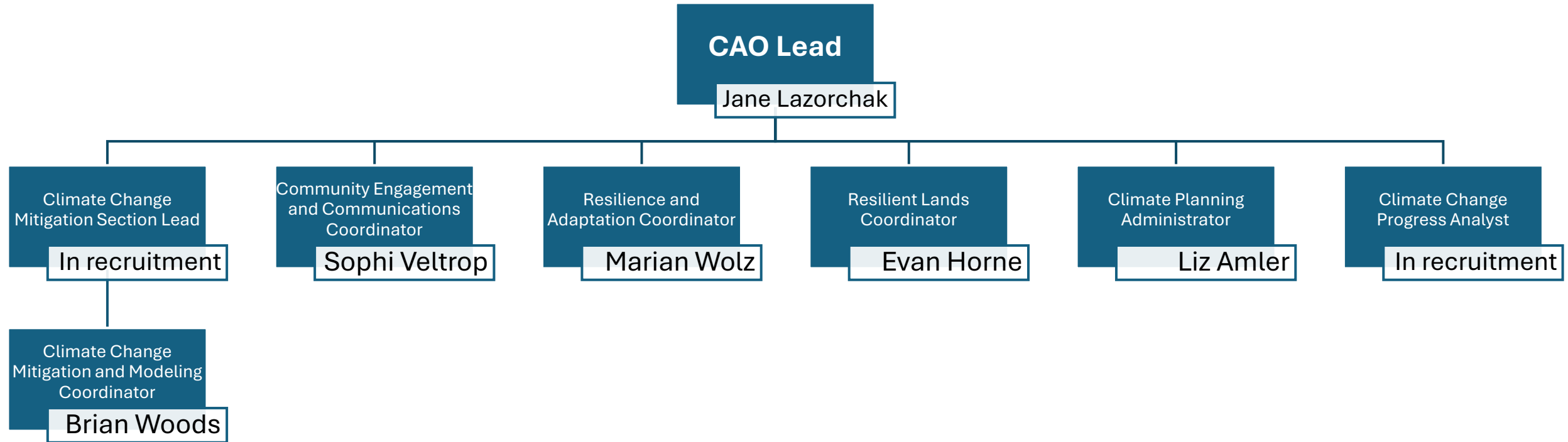

# Climate Action Office

## Background /Context

- GWSA (2020) includes funding for two (new) positions and legal services to support implementation of the GWSA, including preparation of the initial Climate Action Plan
- Governor’s FY23 budget proposed creation of the Climate Action Office to *“...coordinate and lead in the implementation of state-led climate initiatives, as well as the monitoring, assessment and tracking of climate adaptation, mitigation, and resilience activities necessary to evaluate progress over time in achieving the requirements of the GWSA.”*

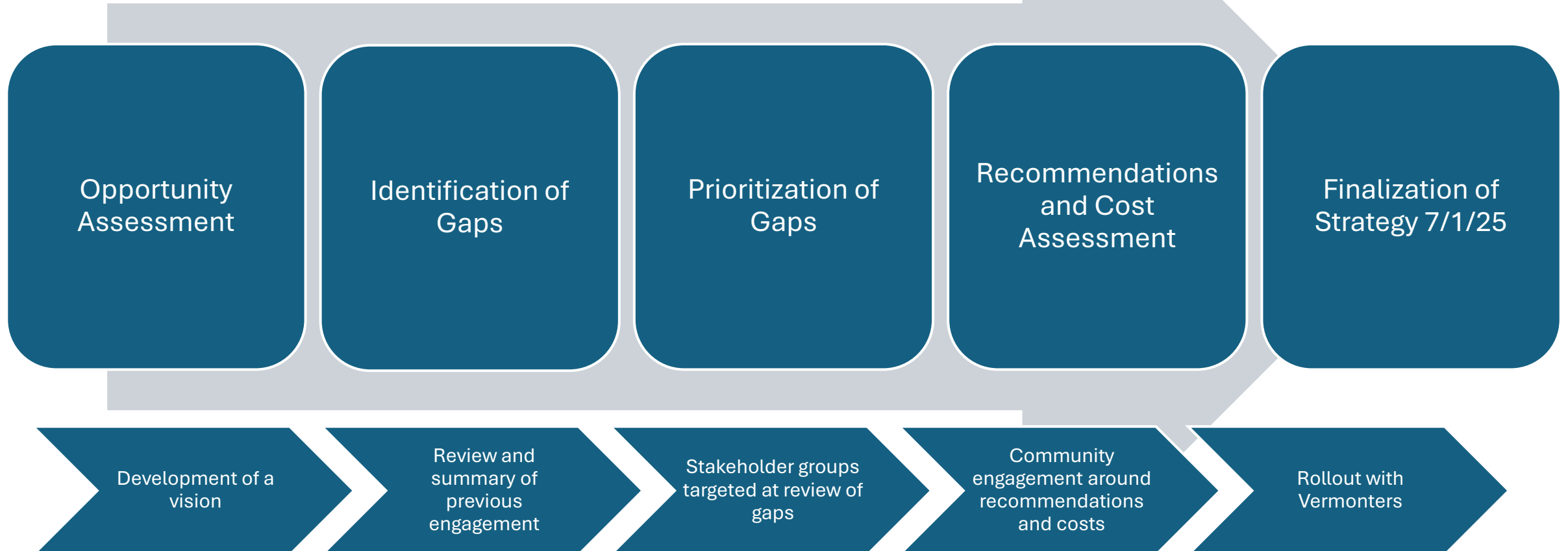

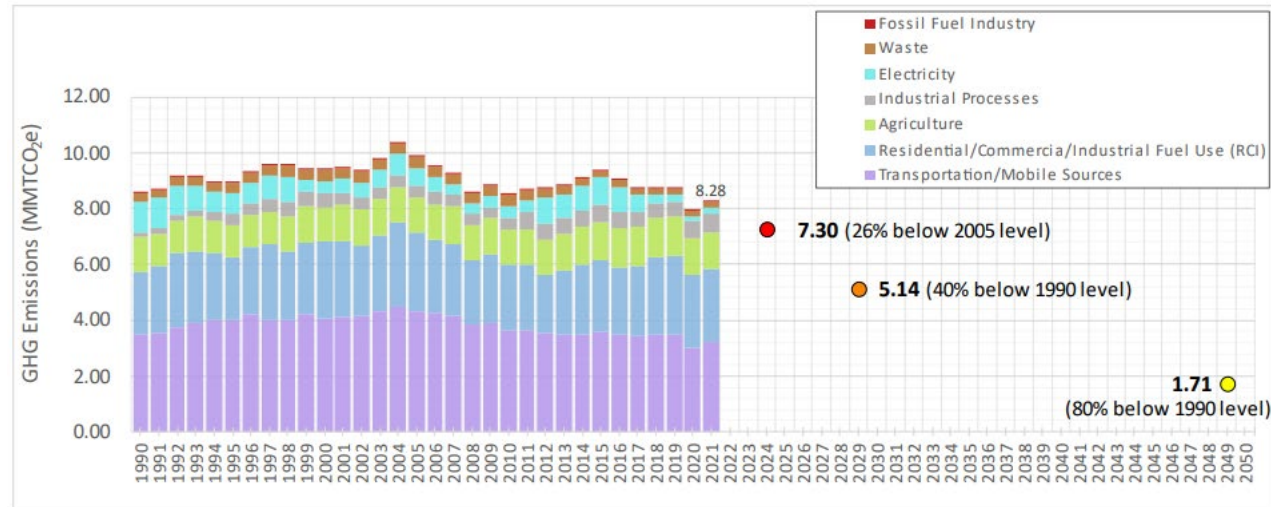

# Community Engagement

## Objectives of climate action outreach are:

- **Provide information and knowledge** that helps people prepare for climate impacts, take action, and access programs that can benefit them.
- **Lift up the voices and viewpoints of communities** into the implementation of climate-related initiatives and the ongoing work of the Climate Action Office and other key entities, including the Vermont Climate Council, so that a diverse group of Vermonters can influence this work.
- **Build relationships and communication channels** that will help Vermonters work collaboratively on future climate action with the state.

# Interagency Coordination

- Coordinates and tracks climate action across state government
  - Leads/convenes Inter-Agency Advisory Board whose charge is:
    - Aligning efforts
    - Identifying gaps and needs
    - Evaluating existing programs
    - Monitoring progress

## Climate Action Office Focus Area:

## GWSA and Climate Council

- Manages contractual services (technical and programmatic) in support of GWSA
- Provides administrative assistance to the Climate Council, consistent with the requirements of the GWSA
- Supports the Climate Action Plan Process
  - Revised plan to be adopted by July 1, 2025

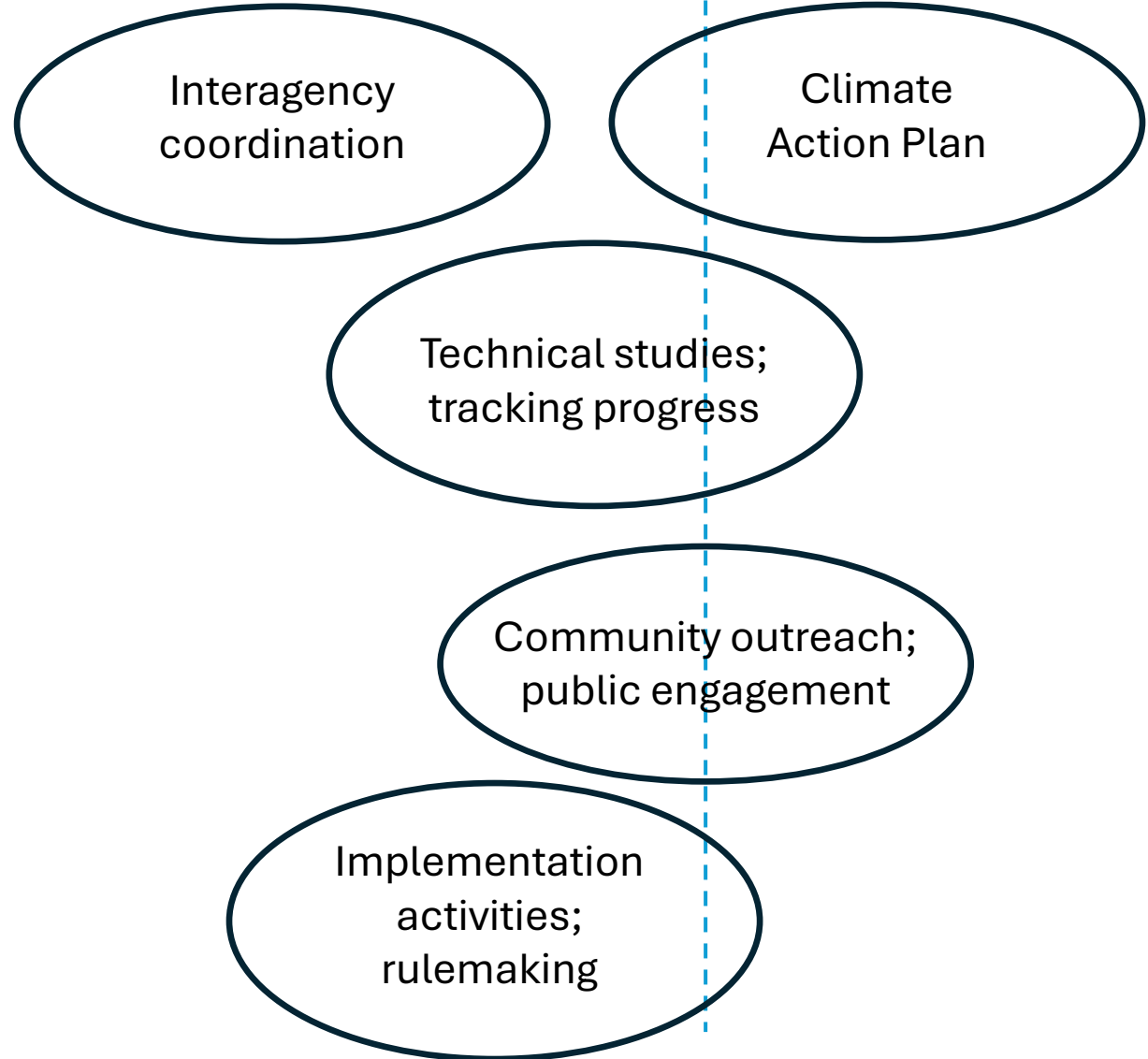
