Good afternoon Megan,

This email is to provide follow up to prior Senate Committee on Transportation testimony where Sen. White requested further information on capital improvement projects that will utilize Highway Safety Improvement Program (HSIP) funding.

The HSIP (23 U.S.C. 148) is a core-federal aid program that is intended to work towards the reduction of traffic fatalities and serious injuries on all public roads. The HSIP requires a data-driven, strategic approach to highway safety that identifies roadway features that constitute a hazard to road users and subsequently identifies highway safety improvement projects on the basis of crash experience, crash potential or other data supported means. The following are the capital improvement infrastructure projects that are intending to spend HSIP dollars in SFY26.
