2 Representative Emmons of Springfield moves that the bill be amended by
3 adding a new section to be Sec. B.1103 to read as follows:

4 Sec. B.1103 CASH FUND FOR CAPITAL AND ESSENTIAL
5 INVESTMENTS; FISCAL YEAR 2027 ONE-TIME CAPITAL
6 APPROPRIATIONS

7 (a) In fiscal year 2027, \$23,418,455 is appropriated from the Capital
8 Infrastructure Subaccount in the Cash Fund for Capital and Essential
9 Investments for the following:

10 (1) Department of Buildings and General Services:

11 (A) \$1,281,174 for statewide major maintenance;

12 (B) \$225,000 for statewide physical security enhancements;

13 (C) \$3,600,000 for Asa Bloomer roof replacement;

14 (D) \$900,000 for Rutland multimodal garage renovation;

15 (E) \$3,000,000 for Burlington, 32 Cherry St. parking garage repairs;

16 (F) \$1,050,000 for the Agency of Human Services for HVAC
17 upgrades at correctional facilities;

18 (G) \$225,000 for the Agency of Human Services for statewide
19 correctional facilities security upgrades;

20 (H) \$700,000 for the Agency of Human Services for door control
21 upgrades at correctional facilities;

1 (I) \$1,000,000 for the Agency of Human Services for the Northern
2 State Correctional Facility boiler replacement;

3 (J) \$772,557 for the Agency of Human Services for the Department
4 for Children and Families’ youth short-term stabilization facility;

5 (K) \$500,000 for the Department of Public Safety for an Urban
6 Search and Rescue (USAR) facility;

7 (L) \$1,600,000 for the Judiciary for renovations at the White River
8 Junction courthouse; and

9 (M) \$1,250,000 for the Agency of Human Services for replacement
10 women’s reentry and correctional facilities.

11 (2) Department of Environmental Conservation:

12 (A) \$2,498,000 for the State match for federal Drinking Water State
13 Revolving Fund; and

14 (B) \$150,000 for Waterbury Dam Penstock project cost overruns.

15 (3) Department of Forests, Parks and Recreation:

16 (A) \$400,000 for park infrastructure and rehabilitation, improvement,
17 and three-acre rule compliance.

18 (4) Department of Fish and Wildlife:

19 (A) \$200,000 for dam maintenance and safety planning.

20 (5) Judiciary:

21 (A) \$500,000 for the Essex County Courthouse connector project.

1 (6) Vermont Historical Society:

2 (A) \$566,724 for the replacement of a climate control unit.

3 (7) Department of Corrections:

4 (A) \$3,000,000 to work with the Agency of Digital Services to install
5 a Wi-Fi system in State correctional facilities that is appropriately designed to
6 address the safety, security, and confidentiality risks of the correctional
7 environment.
