Journal of the Senate of the STATE OF VERMONT ADJOURNED SESSION, 2012

TUESDAY, JANUARY 3, 2012

Pursuant to the provisions of the 2011 final adjournment joint resolution of the two Houses (J.R.S. 32), the Senate convened at the State House at Montpelier, on Tuesday, the third day of January, two thousand twelve.

At ten o'clock in the forenoon, Eastern Standard Time, the Senate was called to order by the President, Lieutenant Governor Philip B. Scott.

Joint Resolution Referred

J.R.S. 37.

Joint Senate resolution of the following title was offered, read the first time and is as follows:

By Senators Pollina and Baruth,

J.R.S. 37. Joint resolution expressing deep concern over the growing inequality in wealth and income in Vermont.

Whereas, societal cohesiveness and unity is dependent on a set of common economic aspirations and a belief that all Vermonters have an equal opportunity to support themselves and their families in a dignified and sustainable manner, and

Whereas, Vermont's constitution, including the first prohibition of slavery and "common benefits" clause, highlights our commitment to basic human rights and equal opportunity, and

Whereas, some inequality is inevitable, but the disparity of wealth and income must not be so great as to provoke animus or despair, and inequality of historic proportions is also the result of conscious public policy choices that can be identified and reversed, and

Whereas, both the *New York Times* and Reuters news agency report that in America income inequality is now greater than it has been since the 1920s just before the Great Depression, and

Whereas, the Congressional Budget Office reported in October 2011 that the wealthiest one percent of the population more than doubled its share of America's income over the last three decades, and federal government policy encouraged economic disparity partly by shifting away from progressive income taxes, and

Whereas, Nobel Prize-winning economist Joseph Stiglitz has written in *Vanity Fair* magazine that the wealthiest one percent of Americans now receives one-quarter of the nation's income and controls 40 percent of its wealth, while those in the middle saw their incomes fall, and economist and former U.S. Labor Secretary Robert Reich reports at Salon.com that those in the bottom 90 percent of earners, if employed, today earn on average about \$280.00 more each year than 30 years ago, adjusted for inflation; a less than one-percent gain, and

Whereas, economist Emmanuel Saez, a 2010 MacArthur Foundation genius award winner, and economics professor at the University of California, Berkeley, co-authored a 2011 article in the *Journal of Economic Literature* entitled "Top Incomes in the Long Run of History," in which the writers documented that during the years 2002–2007, 65 percent of the total income growth in the United States was captured by the top one percent of income earners, and

Whereas, in September 2011, the United States Census Bureau reported that the median household income in the United States declined to 1996 levels, and Harvard University economics professor, Lawrence Katz, stated, "We think of America as a place where every generation is doing better, but we're looking at a period when the median family is in worse shape than it was in the late 1990s," and

Whereas, the Pew Charitable Trusts has published a report entitled "Economic Mobility of Men and Women," written by Julia Isaacs of the Brookings Institution that found the median income for men ages 30–39 actually fell by 12 percent between 1974 and 2004, from \$40,000.00 a year to about \$35,000.00 a year, inflation adjusted, and

Whereas, the Organization of Economic Co-operation and Development finds in a time line comparison from the mid-1980s to the late 2000s that the United States has the second highest Gini coefficient of income inequality increase, at almost 0.40 and second only to Mexico, and

Whereas, the Pew Charitable Trusts, in a report entitled "Chasing the Same Dream, Climbing Different Ladders: Economic Mobility in the United States and Canada," states that sons of Canadian fathers in the bottom one-third of the earnings distribution are more likely to make it to the top one-half of the

distribution in adulthood than are sons of comparably low-earning American fathers, and

Whereas, the research shows that income and wealth inequality has grown faster in Vermont than in the nation as a whole, and

Whereas, a University of New Hampshire study by Ross Gittell and Jason Rudokas reported that between 1989 and 2004, Vermont was one of the top five states ranked for increased income disparity, and

Whereas, according to the United States Census Bureau (Census), Vermont's median household income dropped seven percent between 2008 and 2010, and

Whereas, on September 30, 2009, WCAX News reported that according to the Census, over the years 2007–2008, "Vermont had the biggest drop in household income" of any state in the country, and

Whereas, the Public Assets Institute found that in 2009, the median household income in Vermont was just two percent higher than it had been 20 years earlier, so after adjusting for inflation, a Vermont household in 2009 survived on nearly the same income as it did in 1989, and

Whereas, the U.S. Census Bureau's American Community Survey for 2006–2010 found that in greater Burlington, the middle class is shrinking nearly 10 times faster than nearly anywhere else in the country, and

Whereas, a 2010 analysis by the University of Massachusetts Political Economy Research Institute found increasing inequality makes low and middle income households poorer, and even if the overall economy is expanding, prosperity does not trickle down; instead, the income of low and middle income households falls as income disparity rises, and

Whereas, growing economic inequality hurts us all because it deprives people of basic needs – housing, food, heat, and health care—and steals their dignity and hopes for the future, and because when incomes drop and people are out of work, they cannot pay their bills or generate tax revenues, instead relying on social programs and putting pressure on the state budget, and

Whereas, this hurts local businesses because businesses need customers, and people cannot spend money they do not have, and because increasing inequality undermines the potential for a real economic recovery, *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly expresses its awareness of and deep concern over the growing inequality in wealth and income in Vermont and its impact on Vermont families and our Vermont economy, *and be it further*

Resolved: That the General Assembly is committed to reducing income and wealth inequality by rejecting policies that increase disparity and to supporting policies that close the wealth and income gap and increase economic opportunities for all Vermonters.

Thereupon, the President, in his discretion, treated the joint resolution as a bill and referred it to the Committee on Economic Development, Housing and General Affairs.

<u>First</u>: By adding a new Rule 24.1, to read as follows:

24.1 A committee on reapportionment shall be appointed, consisting of seven members, at least four of whom shall be of the majority party, and at least two of whom shall be of the minority party.

<u>Second</u>: By amending Rule 24, sixth paragraph, by striking out the following: "civil defense; and reapportionment" and inserting in lieu thereof the following: and civil defense.

This amendment to the Senate Rules is temporary and shall expire upon final adjournment of the biennial session of 2012.

Whereas, the Vermont Senate appreciates the critical role that organized labor has played in advancing higher living standards, better working conditions, and greater workplace democracy for all workers, and

Whereas, the decline of organized labor in the United States has significantly contributed to the vastly increased income and wealth inequality deplored by the popular Occupy Wall Street Movement, and

Whereas, it is important that this legislative body affirm that the right to collective bargaining is a fundamental human right recognized in Article 23 of the Universal Declaration of Human Rights, and

Whereas, working people in Vermont have a right to seek redress of contractual grievances free of any public condemnation by public officials, *now therefore be it*

Resolved by the Senate:

That the Senate of the State of Vermont supports recent and ongoing efforts by members of the Vermont State Employees Association to obtain a ruling from duly constituted authority and a clarification of the terms of its contract with the State of Vermont, *and be it further*

Resolved: That the Senate of the State of Vermont urges elected and appointed public officials to desist from castigation of the efforts of working

Vermonters to seek an adjudication of contractual grievances through proper and recognized means.

The Proposed Amendment to the Constitution of the State of Vermont designated as Proposal 4 was introduced, read the first time and referred:

Senators Galbraith and Benning,

PROPOSAL 4

Sec. 1. PURPOSE

This proposal would amend the Constitution of the State of Vermont to specifically provide that each person has a right to privacy, including the right to keep personal information private; to communicate with others privately; and to make decisions concerning his or her body.

Sec. 2. Article 22 of Chapter I of the Vermont Constitution is added to read:

Article 22. [RIGHT TO PRIVACY]

<u>That each person has a right to privacy, including the right to keep personal</u> information private; to communicate with others privately; and to make decisions concerning his or her body.

Sec. 3. EFFECTIVE DATE

Once ratified and adopted by the people of this state in accordance with the provisions of 17 V.S.A. chapter 32, the provisions of this amendment shall become a part of the Vermont Constitution as of the first Tuesday next after the first Monday of November 2014.

PROPOSAL 5

Sec. 1. PURPOSE

This proposal would amend the Constitution of the State of Vermont to provide for election of the Governor, Lieutenant-Governor, and Treasurer by plurality vote, provided the candidate receive at least 40 percent of the votes cast. If no candidate receives at least 40 percent of the votes, then a runoff election between the two candidates receiving the greatest number of votes cast shall be held on the first Tuesday in December to determine the winner.

Sec. 2. Section 47 of Chapter II of the Vermont Constitution is amended to read:

§ 47. [ELECTION OF GOVERNOR, LIEUTENANT-GOVERNOR AND TREASURER]

The voters of each town shall, on the day of election for choosing Representatives to attend the General Assembly, bring in their votes for Governor, with the name fairly written, to the Constable, who shall seal them up, and write on them, Votes for Governor, and deliver them to the Representatives chosen to attend the General Assembly; and at the opening of the General Assembly, there shall be a committee appointed out of the Senate and House of Representatives, who, after being duly sworn to the faithful discharge of their trust, shall proceed to receive, sort, and count the votes for Governor, and declare the person who has the major part greatest number of the votes, to be Governor for the two years ensuing, provided the person receive at least 40 percent of votes cast. The Lieutenant-Governor and the Treasurer shall be chosen in the manner above directed.

The votes for Governor, Lieutenant-Governor, and Treasurer, of the State, shall be sorted and counted, and the result declared, by a committee appointed by the Senate and House of Representatives.

If. time, there shall be no election, of Governor. at any Lieutenant-Governor, or Treasurer, of the State, the Senate and House of Representatives shall by a joint ballot, elect to fill the office, not filled as aforesaid, one of the three candidates for such office (if there be so many) for whom the greatest number of votes shall have been returned a runoff election shall be held between the two candidates receiving the greatest number of votes on the first Tuesday of December following the election. The runoff election shall be held as prescribed by the General Assembly.

Sec. 3. EFFECTIVE DATE

Once ratified and adopted by the people of this state in accordance with the provisions of 17 V.S.A. chapter 32, the provisions of this amendment shall become a part of the Constitution of the State of Vermont as of the first Tuesday next after the first Monday of November 2014.

Whereas, it is not uncommon for individuals to own scanning receivers designed to monitor the transmissions of public safety agencies, and

Whereas, via the scanners, Vermonters listen to public safety transmissions for informational and hobbyist purposes, and

Whereas, public safety officials will on occasion broadcast information on scanner frequencies relating to the death or serious injury of an individual, be it due to natural causes or violent action, and

Whereas, although 13 V.S.A. § 3014 prohibits the use of information derived from a scanner transmission for criminal purposes, Vermont law is silent on the use of this information for noncriminal purposes, and

Whereas, the federal Electronic Privacy Act, codified as 18 U.S.C. § 2511, prohibits intercepting electronic transmissions by wire or radio, but the mere repetition of information heard on a scanner for noncriminal purposes does not appear to violate the act, and

Whereas, the officials broadcasting this highly personal information are often announcing its existence for the first time prior to the notification of next of kin, and

Whereas, public safety organizations and the military, in reporting events and incidents involving serious injury or death, typically delay releasing the names of persons injured or deceased until next of kin are duly notified, and

Whereas, an unofficial release of names of injured or deceased individuals, either to family members or the public, based on information derived from a public safety scanner transmission may cause great personal distress for the next of kin who have yet to receive official notification from public safety officials, and

Whereas, the benefit the public derives from the use of police scanners depends on Vermonters upholding their responsibility to use any information so derived in a responsible and respectful way that honors the privacy of persons connected to the information, and

Whereas, a real-life example of the tragic consequences that can flow from third-party release of police scanner-transmitted information occurred on September 21, 2011, when Kendra Dowen, residing out of state, learned from an acquaintance's text message of her father's sudden and unexpected death in Middlesex, and

Whereas, the message was triggered when a local merchant, who heard the information on a police scanner, informed his part-time employee of the death, and

Whereas, Kendra's younger sister, Allyson, did learn of the death from their mother, Penny Dowen, but Ms. Dowen was forced to call her younger daughter with little time to compose herself, and immediately after the phone call, Allyson's phone became filled with text messages, and

Whereas, local dispatchers may eventually be able to encode these types of messages to rescue squads with the use of digital technology, but the date of implementation of these new radio transmission systems is estimated to be at least five years from now, and

Whereas, the next of kin are entitled to learn of tragic news in the most dignified and private manner possible, *now therefore be it*

Resolved by the Senate:

That the Senate of the State of Vermont urges all Vermonters to respect the privacy of families whose relative's injury or death has been ascertained from a public safety scanner transmission and to allow the appropriate public safety

<u>Whereas</u>, the NWHM has identified federally owned property for sale near the National Mall, and two congressional bills—the National Women's History Act of 2011, sponsored by Representative Maloney in the House of Representatives as H.R. 1269 and Senator Collins in the Senate as S.80, and the National Women's History Museum and Federal Facilities Consolidation Act of 2011, sponsored in the House of Representatives by Representative Mica as H.R. 2844 and in the Senate by Senator Boozman as S.1870—are currently pending in Congress, and

<u>Whereas</u>, there are museums dedicated to flight, postage stamps, buildings, and many other areas of interest but not to women, and yet women comprise 51 percent of the nation's population, and

<u>Whereas</u>, the NWHM will showcase the full history of women in the United States and the contributions they have made and continue to make in the marketplace, arts and sciences, government, entertainment, education, home, and community, and

<u>Whereas</u>, a coalition of 43 women's organizations representing eight million women, which includes the National Foundation for Women Legislators (NFWL), supports the efforts of the NWHM to establish a permanent residence near the National Mall, the most prominent location for museums to be situated in the nation's capital, and

<u>Whereas</u>, in 1880, 40 years before universal women's suffrage was enshrined in the United States Constitution as the 19th Amendment, the Vermont General Assembly granted tax-paying women the right to vote in and hold office in school district elections, and

<u>Whereas</u>, in 1917, Vermont became the first New England state to grant women the right to vote in municipal elections, and

<u>Whereas</u>, women have played an important role in Vermont state government, having served as governor, lieutenant governor (Vermont elected the first female lieutenant governor in the United States), secretary of state, and state treasurer, and

<u>Whereas</u>, in 2011, Vermont has one of the highest percentages of women state legislators of any state in the nation, and the tradition of women legislators dates to Edna Beard, who was elected the first female state representative in 1920 and then the first female state senator in 1922, now therefore be it

The department shall report its accounting of fund receipts and disbursements, plate inventory, and uncollected payments for plates distributed to the joint fiscal committee at its November 2012 meeting.

J.R.S. 41. Joint resolution providing for a Joint Assembly for the election of two legislative Trustees of the Vermont State Colleges Corporation.

Resolved by the Senate and House of Representatives:

That the two Houses meet in Joint Assembly on Thursday, February 16, 2012, at ten o'clock and thirty minutes in the forenoon to elect two legislative Trustees of the Vermont State Colleges Corporation to serve a four year term commencing March 1, 2012, and expiring on March 1, 2016. In case election of all such Trustees shall not be made on that day, the two Houses shall meet in Joint Assembly at ten o'clock and thirty minutes in the forenoon, on each succeeding day, Saturdays and Sundays excepted, and proceed in such election, until all such Trustees are elected. By Senator Campbell,

J.R.S. 42. Joint resolution establishing a procedure for the conduct of the election of two legislative trustees of the Vermont State Colleges Corporation by plurality vote by the General Assembly in 2012.

Whereas, in recent years it has become increasingly necessary to shorten the length of time spent by the General Assembly in joint session for the election of various officials, and

Whereas, if elections for multiple vacancies were to be decided by a plurality vote, then a great savings of time can be effectuated, *now therefore be it*

Resolved by the Senate and House of Representatives:

That, notwithstanding the current provisions of Joint Rule 10, and for this election only, the election of two legislative trustees of the Vermont State Colleges Corporation at a Joint Assembly to be held on February 16, 2012, shall be governed by the following procedure:

(1) All candidates for the office of Trustee shall be voted upon and decided on the same ballot; members may vote for any number of candidates up to and including the maximum number of vacancies to be filled, which in this case shall be two.

(2) The two candidates receiving the greater number of votes shall be declared elected to fill the two vacancies.

(3) In the event that the first balloting for the Trustee vacancies results in a tie vote for one or both of the two vacant positions, then voting shall continue on successive ballots for the unfilled position or positions until the vacancies have been filled by election declared of the two candidates receiving the greater number of votes.

Thereupon, in the discretion of the President, under Rule 51, the joint resolutions were severally placed on the Calendar for action the next legislative day.

Sec. 1. 16 V.S.A. § 1167 is added to read:

<u>§ 1167. SCHOOL RESOURCE OFFICER; MEMORANDUM OF</u> <u>UNDERSTANDING</u>

(a) Neither the state board nor the department shall regulate the use of restraint and seclusion in a school by a fully sworn school resource officer certified pursuant to 20 V.S.A. § 2358. This subsection supersedes any state board rule that purports to regulate that use.

(b) A school board or its designee may enter into a memorandum of understanding with a municipal police department or other law enforcement entity to restrict the use or possession of any weapon or device by a school resource officer on school property.

Sec. 2. EFFECTIVE DATE

This act shall take effect on passage.

And that when so amended the bill ought to pass.
