As of 3/15/2024, disability can be verified by a licensed medical professional and <u>Disability Variance Form</u> can be submitted.




Act 113 Changes to the GA Housing Program

Act 113: "The utilization of hotel and motel rooms pursuant to this subdivision shall be capped at 1,100 rooms per night between September 15, 2024, through November 30, 2024, and between April 1, 2025, through June 30, 2025. (2) The maximum number of days that an eligible household receives emergency housing in a hotel or motel under this section, per 12-month period, shall not exceed 80 days."

The number of eligible households in July has remained consistent with previous months.

Currently, it is estimated that 1/3rd of households being housed will exhaust their 80 days on September 19, 2024, which is 80 days from July 1, 2024, when the law became effective.

Based on current data, DCF is working on a prioritization policy to help with the distribution of the 1,100 rooms to the most vulnerable households.

- Those staff were able to help people in the cohort connect to needed and desired services and provider teams in the community based on individual household needs including healthcare, mental healthcare, substance use, child and family services, housing, etc.
- Moving forward we are working with the Office of Economic Opportunity (OEO) and through Field Services and Vermont Chronic Care Initiative (VCCI) to help identify people who have had a Coordinated Entry assessment who need connections to other services and a team-based care approach. The Coordinated Entry assessment assesses health and social needs in addition to housing needs. This information will be used to identify needs and referrals to services, resources, and/or Team Based Care.
- Each region has community health teams and Adult Local Interagency teams that can be resources to help people connect to team-based care.
- Each region is also engaged in a Team-Based Care Learning Collaborative led by the Blueprint Program Managers, Field Directors, and an expert technical assistance coach to improve each regions approach and workflows in relation to Team Based Care.


CE Subpopulations by Region



Housing Opportunity Grant Program (HOP) Status Update

New base funding for HOP grants was prioritized for:

- Emergency Shelter expansion
 - Preservation of shelter capacity created with one-time funding in State Fiscal Year (SFY)

 - Anticipate increased household capacity of up to approximately 99 during SFY25, some projects are still in development and this number should be finalized in early fall




Residential Capacity
